THE APPEALS CHAMBER ("Appeals Chamber") of the Special Court for Sierra Leone ("Special Court") composed of Justice George Gelaga King, Presiding Judge, Justice Emmanuel Ayoola, Justice Renate Winter, Justice Raja Fernando and Justice Jon Kamanda;

SEIZED of the "Prosecution Motion for Reclassification of Filing", filed on 3 December 2007;

CONSIDERING that the Prosecution requests the Appeals Chamber to permit the Court Management Section to reclassify as confidential the Statement and Report of Prosecutio: Witness TF1-150 (the "Report") filed publicly on 31 May 2005 in the case Prosecutor v. Brima, Kamara and Kanu;
