- Counsel for the Second Accused, Mr Moinina Fofana, (the "Defence") hereby submits its reply to the 'Prosecution Response to the Fofana Application for Right of Audience for Mr Andrew Ianuzzi' filed on 30 May 2006¹.
- 2. In light of the events which transpired in court this morning, the Defence acknowledges the suggestion advanced by the Office of the Prosecutor in its Response as a prudent one².
