I, HON. JUSTICE PIERRE BOUTET, acting as Single Judge of Trial Chamber I pursuant to the Order Designating a Judge for Contempt Proceedings of the 2<sup>nd</sup> of May, 2005;<sup>1</sup>

MINDFUL of the Decision on the Report of the Independent Counsel Pursuant to Rules 77(C)(iii) and (D) filed by Trial Chamber II on the 29<sup>th</sup> of April, 2005 and the corrigendum thereto of the 2<sup>nd</sup> of May, 2005 ("Decision");

MINDFUL, in particular, of the Order in Lieu of the Indictment ("Charge") against Margaret Fomba Brima, Neneh Binta Ba Jallow, Anifa Kamara and Ester Kamara ("Alleged Contemnors"), as contained in the aforementioned Decision;

CONSIDERING that Margaret Fomba Brima, Neneh Binta Ba Jallow and Ester Kamara have changed their plea and have now entered a guilty plea to the Charge against them on the 27<sup>th</sup> July 2005;

NOTING the Findings and Scheduling Order Pursuant to Rule 62 of the 27th of July, 2005;

**NOTING** that Anifa Kamara pleaded not guilty to the Charge against her on the 9<sup>th</sup> of May, 2005;

NOTING the joint application by Defence Counsel for the Alleged Contemnors Margaret Fomba Brima, Neneh Binta Ba Jallow and Ester Kamara for the severance of their case from that of the Alleged Contemnor Anifa Kamara pursuant to Rule 82 of the Rules of Procedure and Evidence ("Rules");

NOTING that the Independent Counsel did not oppose to the said joint application;

**CONSIDERING** that it will be in the interest of justice to proceed with the case of Anifa Kamara separately from the case of the Margaret Fomba Brima, Nenej Binta Ba Jallow and Ester Kamara;
