

I, Justice Teresa Doherty, Single Judge of the Special Court for Sierra Leone ("Special Court");

RECALLING that a "Decision on Defence Motions on Behalf of Hassan Papa Bangura, Santigie Borbor Kanu and Brima Bazzy Kamara for Judgement of Acquittal Pursuant to Rule 98" ("Decision on Motions for Judgement of Acquittal") was filed on 13 August 2012;

NOTING that the Decision on Motions for Judgement of Acquittal contained a clerical error;

ORDERS, pursuant to Rule 54 of the Rules of Procedure and Evidence of the Special Court for

Sierra Leone, that the Decision on Motions for Judgement of Acquittal be rectified and amended as
follows:

1. Paragraph 21, Line 4 should read as follows, inserting the word "not:"

Rule 77(E) clearly states that the provisions of Part IV – XIII apply "as appropriate" to contempt trials notwithstanding that contempt is not a crime provided for in Article 2 of the Statute. The Rules are to be applied "as appropriate," meaning according to the procedures appropriate to each particular rule. The Rules are not stated to be applicable "if appropriate," thereby giving a Trial Chamber discretion to determine if a Rule is applicable in any particular case. As Rule 98 is a rule specified in Part IV -VIII of the Rules it must follow that Rule 98 also applies to a trial for contempt and I do not dismiss the applications on this ground.

HEREBY ORDERS that the revised version of the Decision be treated as authoritative.
