

URGENT DEFENCE APPLICATION FOR PERMISSION TO INSTRUCT HANDWRITING EXPERT

- 1. Noting that there has been no Pre-Defence Conference pursuant to Rule 73ter.
- 2. Further noting the Accused's right to call witnesses in his defence pursuant to Rule 85(A)(ii) and (C) and the provisions contained in Rule 94bis.
- 3. Considering that the Independent Prosecutor adduced opinion evidence from Mr. Hillary Sengabo, Deputy Director of Mpanga Prison, Rwanda, that the latter recognised the handwriting of the Accused, Santigie Borbor Kanu, on the manual telephone log.
- 4. Following consideration of instructions from Mr. Kanu and the potential effect of the opinion evidence on handwriting adduced by the Independent Prosecutor, the Defence hereby requests permission from the Honourable Court to instruct and call a forensic document and handwriting expert in order to rebut the evidence of Mr. Sengabo.
- 5. In view of the stage of proceedings the Defence for Mr. Kanu has contacted a reputable Forensic Document and Handwriting specialist, Mrs. Maureen Ward-Gandy¹ of Crawley, west Sussex in the United Kingdom. Mrs. Ward-Gandy has provided her terms of engagement², specimen writing sample requests³ and requires: (a) the original disputed document (b) original specimen writing of the defendant made at different times (25+ preferred) (c) Original witnessed writing on request writing forms provided (d) Synopsis of the case history and relevant statements to clarify disputes.

¹ Mrs. Ward-Gandy, B Ed, CDE, BCFE is a forensic document expert with considerable experience. She is a fellow of the Expert Witness Institute & the American College of Forensic Examiners and was awarded the National Association of Document Examiner's, 'Document Examiner of the Year' at their conference in New Orleans in 2003.
