

Independent Counsel's Motion to Refile as "Confidential" Annex B of Independent Counsel's Urgent Motion for Clarification Regarding the Deadline for Filing Submissions in Response to Appellant's Submissions for Appeals Against Conviction and Sentence AND Replace Said Annex with a Redacted Version

- 1. On 22 February 2013, Appellant Prince Taylor ("Appellant") filed his Notice of Appeal. On 15 March 2013, counsel for Appellant sent Respondent Independent Counsel ("Respondent") an email claiming that Appellant filed his Submissions with the Appeals Chamber that afternoon and attaching an unofficial copy of his Submissions to that email. On 18 March 2013, Court Management for the Special Court for Sierra Leone sent Respondent an email advising him, among others, that Appellant's Submissions were "filed on the 18/03/2013 at 09:00" and attaching a court-stamped copy of that filing. That same day, Respondent filed his Urgent Motion for Clarification Regarding the Deadline for Filing Submissions in Response to Appellant's Submissions for Appeals Against Conviction and Sentence ("Urgent Motion") respectfully requesting that the Appeals Chamber "advise Respondent of the deadline for filings his submissions in response to Appellant's Submissions." Respondent appended two public annexes to the Urgent Motion. One of those annexes was "Annex B," which was the email from Court Management described above.
- 2. On 22 March 2013, Court Management for the Special Court for Sierra Leone advised Respondent that Annex B of the Urgent Motion contained confidential contact information. Court Management recommended that Respondent file a motion requesting that the publically-available version of Annex B of the Urgent Motion be reclassified as "confidential" and replaced with a redacted version.

3. Respondent agrees that Annex B contains confidential contact information and does not anticipate any objections from Appellant to the recommendations presented by Court Management. Accordingly, Respondent respectfully requests that: (1) the Appeals Chamber reclassify the public version of Annex B of the Urgent Motion that was filed on 18 March 2013 as "confidential" in accordance with the rules and procedures of the Special Court for Sierra Leone; and (2) replace said annex with the redacted version appended to the instant motion.<sup>3</sup>
