



I. INTRODUCTION

- This Defence Motion is filed pursuant to the Trial Chamber's order made on 5 February 2010, regarding the procedure to be adopted for the tendering of the documentary evidence marked for identification during the course of the testimony of the Accused Charles Ghankay Taylor.¹
- During the testimony of the Accused some 407 documents were marked for identification. At the close of the cross-examination of the Accused, Lead Counsel for the Prosecution outlined a suggested procedure for the tendering of those documents marked for identification. It was suggested that each party file in writing a list of those documents which it wishes to tender into evidence and that upon receipt of that list, the parties would file any objections in writing so that the Trial Chamber could resolve any outstanding issues. This suggestion rightly found favour with the Trial Chamber, and the Trial Chamber so ordered.²
- 3 The Defence attaches hereto, as Annex A, a schedule of all the items it has asked to be marked for identification and which it now seeks to be admitted into evidence.

II. APPLICABLE LEGAL STANDARD

- 4 It is submitted that the following fundamental principles govern the admission into evidence of such documents:
 - a The golden rule of admissibility is that all evidence which is relevant to the facts in issue is admissible and that which is irrelevant is inadmissible. For the purposes of a criminal trial, evidence is relevant if its effect is to make more or less probable the existence of any fact which is in issue, that is, upon which guilt or innocence depends.
 - b The facts in issue are those facts which the prosecution must establish in order to prove its case and the defendant must establish in order to raise a defence.

- c Facts such as those concerning the credibility of a witness are said to be collateral facts and evidence relevant to such an issue is admissible subject to the rule that no evidence may be called to rebut a witness' evidence in cross-examination as to credit.
- 5 Section 3 of the Rules of Procedure and Evidence ("the Rules") of this court governs the Rules of Evidence. The Defence recognises and submits that Rule 89 (C) of the Rules, as part of the Section 3, is a general rule governing the admission of evidence which provides that the Trial Chamber "may admit any relevant evidence".

III. ARGUMENT

- 6 Applying those principles, it is submitted that all of the 301 documents and photographs marked for identification during the evidence-in-chief of the Accused should be admitted into evidence.
- In relation to the documents tendered by the Prosecution during the cross-examination of the Accused, it is respectfully submitted that only those parts of each document actually used during the course of the cross-examination of the Accused can be admitted. It is submitted that the remainder of those documents cannot be admitted because the Accused had no opportunity to accept or challenge those passages. However, where the Defence have re-examined the Accused in relation to documents submitted by the Prosecution, the Defence accepts that such documents can be admitted *in toto*. Attached hereto as Annex B is a schedule of all the documents submitted by the Prosecution containing also the defence observations on their admissibility.

IV. CONCLUSION

8 In the premises the Defence respectfully submits that all the documents marked for identification and described in the attached schedule, Annex A, be admitted into evidence.
