- On 19 July 2012, the Defence filed the Notice of Appeal of Charles Ghankay
   Taylor<sup>1</sup> ("the Notice"). The Defence notes that there are two aspects to the
   Notice which require correction through this corrigendum.
- 2. Paragraph 121 of the Notice inadvertently refers to "Part V" instead of "Part VII" of the Notice. Accordingly, paragraph 121 should read: "For each of the Grounds of Appeal set out in Part VII, the precise relief sought as a result of the Trial Chamber's abuse of its discretion, is the quashing of the sentence imposed by the Trial Chamber, and the imposition of a new and appropriate sentence."
- 3. The content of Footnote 47 was also inadvertently inserted, and should be replaced in its entirety with the following: "Judgement, pp. 1255-1279, paras. 3553-3606; p. 1282, para. 3611 (xiv); p. 2464, para. 6966; p.2475 para. 6994 (b)."
