- 2 MS IRURA: Your Honour, we are in open session.
- 3 PRESIDING JUDGE: Thank you. Ms Hollis, please proceed.
- 4 MS HOLLIS:
- 09:41:42 5 Q. Mr Witness, would you tell the Court what languages you
 - 6 speak?
 - 7 A. I speak Krio, Mende and Liberian English.
 - 8 Q. Do you understand spoken English?
 - 9 A. Yes.
- 09:42:10 10 Q. How well do you understand spoken English?
 - 11 A. I understand it little by little.
 - 12 Q. Do you read English?
 - 13 A. I read it a little bit.
 - 14 Q. Now, I would like to draw your attention to May of 1991.
- 09:42:38 15 Where were you in May of 1991?
 - 16 A. I was in Pendembu Town.
 - 17 Q. And what happened in Pendembu Town in May of 1991?
 - 18 A. I was there when I heard that the rebels had entered
 - 19 Pendembu in May 1991.
- 09:43:03 20 Q. And when you say "rebels", what do you mean?
 - 21 A. Well, I saw people who entered and were speaking Liberian
 - 22 English and they had guns. They were shooting around in the
 - 23 Pendembu Town. They referred to themselves as rebels.
 - Q. When these rebels entered Pendembu Town, were there
- 09:43:32 25 government forces in the town?
 - 26 A. There was no government forces at that time.
 - 27 Q. And were the people in Pendembu armed at that time?
 - 28 A. No.
 - 29 Q. What kind of weapons were used when the rebels attacked

- 1 Pendembu?
- 2 A. I saw guns that were referred to as Beretta, guns like RPG,
- 3 guns like AK-47.
- 4 Q. What happened to the people in Pendembu when the rebels
- 09:44:19 5 attacked the town?
 - 6 A. Well, after they had attacked I was in a group where I saw
 - 7 small boys who had guns who captured us and they took us to the
 - 8 NA court barray together with some other people.
 - 9 Q. You said that you saw small boys in this group. What do
- 09:44:46 10 you mean?
 - 11 A. Small boys whom I was even older than and some of them were
 - 12 older than me.
 - 13 Q. And how was it that you knew their ages?
 - 14 A. Well, that happened at the time I was at the base. They
- 09:45:12 15 showed their ages when they called for formation. It was through
 - 16 the formation that I knew their ages.
 - 17 Q. Now we are going to talk about the base in a moment, but
 - 18 before we do that let me ask you what happened to other people in
 - 19 Pendembu during this attack?
- 09:45:35 20 A. Well, when they captured me we went to the NA court barray
 - 21 whilst the other people ran away to other villages. We were 17
 - 22 that were captured that particular day.
 - 23 MS HOLLIS: Your Honours, NA court barray, I believe barray
 - 24 is B-A-R-R-A-Y:
- 09:46:23 25 Q. What were the ages of the people who were captured?
 - 26 A. There were women amongst, there were boys and there were
 - 27 some other people. Their ages were up to 40 years.
 - 28 Q. These small boys and others who captured you, did they have
 - 29 any weapons?

- 1 A. Yes, they had guns with them.
- 2 Q. What happened once you were taken to the NA court barray?
- 3 A. When they took us to the court barray, we were there for
- 4 the whole day. They were punishing us, they were shooting around
- 09:47:13 5 us, they were shooting up. They told us to lie down on the
 - 6 ground and later they asked us to go with them to the training
 - 7 base.
 - 8 Q. Who was it who was doing this to you at the court barray?
 - 9 A. Well, those were the soldiers who had the guns who were
- 09:47:31 10 speaking the Liberian English.
 - 11 Q. Where was it you were taken after this happened?
 - 12 A. Well, they took us to the Pendembu vocational secondary
 - 13 school compound to undergo training.
 - 14 Q. Now just for clarification, do you know what district
- 09:47:59 15 Pendembu is in?
 - 16 A. Pendembu is in Kailahun District.
 - 17 Q. And what happened when you arrived at this base?
 - 18 A. When we got to the base they called for a formation and
 - 19 somebody introduced himself to us who introduced himself as
- 09:48:26 20 Charles Timber and he said he was the training commandant at the
 - 21 base. He told us that the war was a Sierra Leone war and he
 - 22 further told us that they were NPFL and that they have come to
 - 23 help fight the Sierra Leone war, and he even gave an example that
 - 24 we shouldn't fear and that they had Sierra Leoneans amongst them
- 09:48:57 25 and he made mention of two names. He called Morris Kallon and
 - 26 Kai fa Wai.
 - 27 MS HOLLIS: Your Honours, Kaifa Wai would be K-A-I-F-A
 - 28 W-A-I:
 - 29 Q. Now, what do you mean that he made an example and he showed

- 1 you Morris Kallon and Kaifa Wai?
- 2 A. That is to say he wanted to tell us that we shouldn't fear
- and that there were Sierra Leoneans amongst them.
- 4 Q. And did he tell you anything about these two people, Morris
- 09:49:38 5 Kallon and Kaifa Wai?
 - 6 A. Well, he further told us that Morris Kallon and Kaifa Wai
 - 7 were RUF vanguards who were trained by Foday Sankoh at Camp Naama
 - 8 base in Liberia.
 - 9 Q. How many did you say were brought from Pendembu to this
- 09:50:08 10 training base? How many people?
 - 11 A. We were 17.
 - 12 Q. In this formation at the base, how many people?
 - 13 A. Well, when I went there we met people who were there up to
 - 14 100. 100 of them.
- 09:50:28 15 Q. And what were the ages of these people?
 - 16 A. There were children and their ages were from 13 years
 - 17 upwards.
 - 18 Q. What was the gender of these people?
 - 19 A. There were children, there were women, there were men.
- 09:50:57 20 Q. And the children, what were the gender of the children?
 - 21 A. There were boys. There were girls.
 - 22 Q. Did you learn how these other people came to be there at
 - this training base?
 - 24 A. They were going around the surrounding villages and within
- 09:51:28 25 the Pendembu township itself and they brought them to the
 - 26 training base.
 - 27 Q. And when you say they were going around, who was going
 - 28 around?
 - 29 A. Those were the training commandants.

- 1 Q. These people that came, do you know did they come there
- 2 voluntarily?
- 3 A. They went around and forcefully captured them and brought
- 4 them to the base.
- 09:52:06 5 Q. How long were you at this Pendembu training base?
 - 6 A. I was there for two months.
 - 7 Q. What type of training did you receive there?
 - 8 A. I underwent ambush training, I underwent AK-47 training and
 - 9 I underwent barbed wire crawling and halaka training.
- 09:52:48 10 Q. Now you said that you underwent this training. Did anyone
 - 11 else receive this training?
 - 12 A. Yes, all of us who were taken to the base. All of us went
 - 13 through that training.
 - 14 Q. While you were on the base during these two months did
- 09:53:10 15 anyone refuse to accept this training?
 - 16 A. Well, when they took us to the base to be trained, if
 - 17 anybody said that you were tired, you will be beaten.
 - 18 Q. What would happen if you refused to train?
 - 19 A. They will punish you.
- 09:53:40 20 Q. In what way would they punish you?
 - 21 A. There was a place that was referred to as the halaka place.
 - 22 When you said you were tired they will put other instructions
 - 23 behind you and they will take you to the halaka and they will ask
 - 24 you to run and they will have canes, they continue beating you
- 09:54:07 25 and they will say you are falling in an ambush.
 - 26 Q. Who would be beating these people?
 - 27 A. Those who were training us there.
 - 28 Q. Now, you said this was done at the halaka place. Can you
 - 29 tell us what the halaka place was?

- 1 A. Well, the halaka was something like a circle. It was
- 2 circled using cement blocks and it was round in shape. There was
- 3 a centre and there was somewhere in the middle that they put some
- 4 sand. They will place you there and the training instructors
- 09:55:00 5 will have canes and whilst you were running through there, they
 - 6 will beat you up.
 - 7 Q. What were the ages of those that were taken to this halaka
 - 8 place and this done to them?
 - 9 A. Well, from 12 upwards.
- 09:55:24 10 Q. What was the gender of the people taken to the halaka place
 - 11 and this done to them?
 - 12 A. Men went there, women went there and children went there.
 - 13 Q. When you say children, what were the gender of these
 - 14 chi I dren?
- 09:55:48 15 A. Girls went there and boys went there.
 - 16 Q. You testified that when you came to the base there were
 - 17 approximately 100 other people at the base. During the two
 - 18 months you were there how many people were training at Pendembu
 - 19 base?
- 09:56:06 20 A. Well, after I had completed my two months, later the number
 - of people went up to 800.
 - 22 Q. What was the ages of these 800 people?
 - 23 A. From 12 upwards.
 - Q. What was the gender of these 800 people?
- 09:56:36 25 A. There were girls amongst them, there were boys amongst
 - them, there were men amongst them and there were women amongst
 - 27 them.
 - 28 Q. These 800 people, did they all receive the same training?
 - 29 A. Yes.

- 1 Q. During the time you were at this training base were the
- 2 trainees organised into any sorts of units?
- 3 A. Yes, at the time we were undergoing this training they put
- 4 us in platoons, companies, like there were the WAS unit, and that
- 09:57:30 5 was how we were arranged.
 - 6 Q. Did you say "wives unit"?
 - 7 A. WAS unit.
 - 8 Q. What was the wives unit?
 - 9 JUDGE LUSSICK: Just to be clear on that, is he saying
- 09:57:53 10 "wi ves" or "wi se"?
 - 11 THE WITNESS: WAS.
 - 12 MS HOLLIS:
 - 13 Q. Mr Witness, let me spell the word and if you understand
 - 14 tell me if this is the word you're using. Is it W-I-V-E-S?
- 09:58:10 15 A. No.
 - 16 Q. Can you pronounce it for us again, please?
 - 17 PRESIDING JUDGE: Maybe the witness could spell it if he
 - 18 knows.
 - 19 MS HOLLIS:
- 09:58:21 20 Q. Are you able to spell it, Mr Witness?
 - 21 A. W-A-S, WAS.
 - 22 Q. W-A-S?
 - 23 MR GRIFFITHS: Your Honour, it may be best if the witness
 - just explains what he means.
- 09:58:37 25 PRESIDING JUDGE: I am sure that's coming.
 - 26 MS HOLLIS:
 - 27 Q. So when you say WAS, W-A-S, unit, what do you mean?
 - 28 A. Those were the women. The girls and the women. Those were
 - 29 the ones who were referred to as the WAS.

- 1 Q. Now, you mentioned small boys receiving training. Were
- they in any particular unit?
- 3 A. Yes.
- 4 Q. What was that unit?
- 09:59:18 5 A. They were called the SBU unit.
 - 6 Q. Did you learn what SBU meant?
 - 7 A. Small Boys Unit.
 - 8 Q. You testified that Charles Timber indicated that he was in
 - 9 charge of the training base. Were there any other commanders at
- 09:59:49 10 this training base?
 - 11 A. Yes.
 - 12 Q. Who?
 - 13 A. Monica Pearson was there. She was serving as deputy to
 - 14 Charles Timber and she was the WAS commander too.
- 10:00:08 15 Q. Who was Monica Pearson?
 - 16 A. Monica Pearson was a Liberian.
 - 17 Q. Do you know where she was trained?
 - 18 A. According to what she told us, she said she trained in
 - 19 Liberia, in Camp Naama.
- 10:00:30 20 Q. Do you know what group she was with?
 - 21 A. She was in the vanguard group.
 - 22 JUDGE SEBUTINDE: Ms Hollis, is Timber T-I-M-B-A or
 - 23 T-E-M-B-A?
 - MS HOLLIS: I believe the spelling is actually T-I-M-B-E-R.
- 10:00:56 25 The "Timba" is the accent:
 - 26 Q. Mr Witness, who actually gave you the training at this
 - 27 training base? Who were the instructors?
 - 28 A. Matthew was there. He was a Liberian. We received
 - 29 training from him. Jah Glory was there. He was a training

- 1 instructor too. And some others that I cannot recall now.
- 2 MS HOLLIS: Your Honours, Jah Glory, J-A-H, second word
- 3 Glory, G-L-O-R-Y. Matthew would be the regular spelling:
- 4 Q. What was Jah Glory's nationality?
- 10:02:02 5 A. Jah Glory was a Liberian.
 - 6 Q. Do you know what group he was in?
 - 7 A. He was in the NPFL group.
 - 8 Q. You mentioned a Matthew who was a Liberian. Do you know
 - 9 what group he was in?
- 10:02:22 10 A. Well, he also told us that he was trained in Liberia, in
 - 11 the NPFL.
 - 12 Q. During this two months that you were at the Pendembu
 - 13 training base did you have any visitors to the base?
 - 14 A. Yes, people used to visit us there.
- 10:02:50 15 Q. Do you recall the names of any of these people who visited
 - 16 there?
 - 17 A. We were there when Foday Sankoh came there, Francis Mewon
 - 18 went there, Dopoe Menkarzon too went there.
 - 19 Q. Who was Francis Mewon?
- 10:03:20 20 A. Francis Mewon was a Liberian. He was Liberian Special
 - 21 Forces.
 - 22 Q. Do you know what group he was in?
 - 23 A. He told us that he was NPFL at that time.
 - 24 Q. Do you know what position he held at the time he came to
- 10:03:43 25 visit the base?
 - 26 A. No.
 - 27 Q. Now, you mentioned a Dopoe Menkarzon, who was he?
 - 28 A. Well, Dopoe Menkarzon too told us that he was called Dopoe
 - 29 Menkarzon and that he was trained in Liberia and he said he was a

- 1 Special Forces. He said he came from Liberia, from amongst the
- 2 NPFL.
- 3 Q. Do you know what position, if any, he held at that time?
- 4 A. Well, when he came at that time he came to replace somebody
- 10:04:29 5 in Pendembu.
 - 6 Q. To replace them as what?
 - 7 A. There was one NPFL commander who was called Samuel G Tuah.
 - 8 He came to replace him.
 - 9 Q. Now, you mentioned that Foday Sankoh came to the base.
- 10:04:59 10 What happened when Foday Sankoh came to the base?
 - 11 A. Well, when Foday Sankoh came to the base, after our
 - 12 graduation he told the training commander, that was Charles
 - 13 Timber, that he needed 25 manpower to go and serve as guards at
 - 14 his mansion in Pendembu.
- 10:05:30 15 Q. How did you know that this man was Foday Sankoh?
 - 16 A. Well, that was the first time I saw him, when he came to
 - 17 the base and introduced himself, that he was the leader and he
 - 18 brought the war. That was the time I knew that he was the Foday
 - 19 Sankoh.
- 10:05:52 20 Q. Now, you indicated this happened after graduation. Before
 - 21 we talk about Foday Sankoh's visit and his request I would like
 - 22 to ask you to your knowledge how long did the training base
 - 23 remain at Pendembu?
 - 24 A. The training base was there from '91 it was there in '91
- 10:06:26 25 to the end.
 - 26 Q. Do you know where the training was moved to after Pendembu?
 - 27 A. Later the training base was transferred to Kailahun Town.
 - 28 Q. Do you know how long the training base was there?
 - 29 A. It was there up to 1992.

- 1 Q. If you know, where did it move to after that?
- 2 A. When they moved it from there, it was taken to a town that
- 3 is moving from Kailahun. The place is called Bunumbu.
- 4 Q. Do you know who was the training commander at Kailahun Town
- 10:07:26 5 base?
 - 6 A. I can't recall.
 - 7 Q. Do you know who the training commander was at Bunumbu base?
 - 8 A. It was Monica Pearson that was there.
 - 9 Q. Now, you have indicated that Foday Sankoh asked for 25
- 10:07:56 10 people to serve him. What happened to these other trainees?
 - 11 Where did they go after graduation?
 - 12 A. They were sent to the various front lines.
 - 13 Q. And do you know the ages of the people sent to the various
 - 14 front lines?
- 10:08:18 15 A. The ages started from 12 years upwards.
 - 16 Q. What happened to you after you graduated from the training
 - 17 base?
 - 18 A. After Foday Sankoh had come to the base and asked for the
 - 19 25 manpower, I was also selected to serve in the 25 manpower to
- 10:08:56 20 go and serve at the Mansion Ground.
 - 21 Q. Where was this Mansion Ground?
 - 22 A. In Pendembu Town.
 - 23 Q. To your knowledge, did Foday Sankoh have any other mansion
 - 24 grounds at this time?
- 10:09:16 25 A. I knew that when I was at the Mansion Ground. I understood
 - 26 from him that he had another mansion in Kailahun.
 - 27 Q. And by Kailahun do you mean Kailahun Town?
 - 28 A. Yes.
 - 29 Q. What were your duties at the mansion?

- 1 A. Well, when they brought us there as mansion guards we were
- there guarding around the mansion with guns.
- 3 Q. How long did you serve as a mansion guard?
- 4 A. We were there as mansion guards for a long time.
- 10:10:28 5 Q. During what year or years were you there as a mansion
 - 6 guard?
 - 7 A. In '91.
 - 8 Q. During the time you were there as a mansion guard, was
 - 9 Foday Sankoh doing any travelling away from Pendembu?
- 10:10:51 10 A. Yes, during the time I was there as mansion guard Foday
 - 11 Sankoh sometimes left us there and travelled.
 - 12 Q. Did you know where he went?
 - 13 A. He told us that he was going to Gbarnga in Liberia.
 - 14 Q. Did he tell you why he was going to Gbarnga in Liberia?
- 10:11:17 15 A. He told us that he was going to see his brother,
 - 16 Charles Taylor, and he brought arms and ammunition together with
 - 17 food.
 - 18 Q. During the time you were at the mansion as a mansion guard,
 - 19 do you know what the chain of command was for the RUF in Sierra
- 10:11:50 20 Leone?
 - 21 A. Yes.
 - 22 Q. Please tell us.
 - 23 A. Well, at that time it was General Samuel G Tuah who
 - 24 controlled the movement at that time and he was an NPFL.
- 10:12:23 25 Q. And at this time, to your knowledge, who was in control of
 - the front line areas?
 - 27 A. Well, it was the NPFL commanders.
 - 28 Q. If you know, at this time how many NPFL were in Sierra
 - 29 Leone?

- 1 A. Well, there were many. I cannot tell the number.
- 2 Q. If you know, at this time how many Sierra Leonean RUF
- 3 personnel were in Sierra Leone?
- 4 A. There were also many.
- 10:13:12 5 Q. At the time that you were assigned to the mansion --
 - 6 THE INTERPRETER: Your Honours, whilst the witness is
 - 7 giving his testimony could be speak up a little at the tail end
 - 8 of his testimony because the last thing he said was not clear to
 - 9 the interpreters.
- 10:13:27 10 PRESIDING JUDGE: Mr Witness, the interpreters have to
 - 11 translate everything you say. They are having difficulty hearing
 - 12 the last part of each of your answers, so can you speak clearly
 - 13 right through the answer and, if necessary, come a little closer
 - 14 to the microphone please.
- 10:13:49 15 THE WITNESS: Okay.
 - 16 MS HOLLIS:
 - 17 Q. Mr Witness, at the time you were assigned to the mansion as
 - 18 a guard were any other people assigned to the mansion?
 - 19 A. Yes.
- 10:14:11 20 Q. Who else was assigned to the mansion?
 - 21 A. That was the Liberian securities who were with Foday
 - 22 Sankoh.
 - 23 Q. Anyone el se?
 - 24 A. Yes, the radio operator was there. They used to call him
- 10:14:37 25 CO Nya. Foday Sankoh also had a woman called Catherine.
 - 26 Q. Did you say Catherine?
 - 27 A. Yes.
 - 28 Q. And what was her position at the mansion?
 - 29 A. Well, she was Foday Sankoh told us she was his wife and

- 1 so she used to cook there.
- 2 Q. You mentioned CO Nya. Do you know him by any other name?
- 3 A. We used to call him Foday Lansana.
- 4 Q. Do you know his nationality?
- 10:15:30 5 A. Well, he was a Liberian.
 - 6 Q. Do you know what group he was with?
 - 7 A. Well, when I was at the mansion I was made to understand
 - 8 that he was part of the NPFL at the time that I joined the RUF.
 - 9 THE INTERPRETER: Your Honours, can the witness be audible
- 10:15:53 10 a little. He is still not audible enough for the interpreter.
 - 11 PRESIDING JUDGE: Mr Witness, the interpreter is still
 - 12 having trouble hearing you. Can you speak a little louder and
 - 13 I will ask Madam Court Attendant to assist us to bring the
 - 14 microphone closer to you.
- 10:16:10 15 THE INTERPRETER: Your Honours, let him kindly repeat his
 - 16 last answer.
 - 17 PRESIDING JUDGE: Mr Witness, the interpreter asks that you
 - 18 repeat your last answer. Do you need the question asked again?
 - 19 THE WITNESS: Yes.
- 10:16:27 20 PRESIDING JUDGE: Ms Hollis, if you could oblige please.
 - 21 MS HOLLIS:
 - 22 Q. Mr Witness, you were talking about CO Nya who was also
 - 23 known as Foday Lansana. You said he was a Liberian and I asked
 - 24 you if you knew what group he was with. Can you tell us the
- 10:16:43 25 answer to that, please.
 - 26 A. When I was at the Mansion Ground, CO Nya made me to
 - 27 understand that he was part of the NPFL and later he joined the
 - 28 RUF and came to Sierra Leone as a radio operator.
 - 29 Q. You mentioned that Foday Sankoh also had Liberian

- 1 securities. What was the job of these Liberian securities?
- 2 A. Well, they were bodyguards to him.
- 3 Q. And how long did he have these Liberian securities?
- 4 A. The Liberian securities were with him in '91.
- 10:17:40 5 Q. What happened after that?
 - 6 A. After that their posts were dissolved and he asked Kargbo,
 - 7 who was the battle group commander for the RUF, to look for five
 - 8 junior commandos to be his bodyguards. He sent these Liberians
 - 9 to the front lines.
- 10:18:14 10 Q. Now, you said that their posts were dissolved. Can you
 - 11 tell us why that was?
 - 12 A. Well they just left their duties unknowingly to Foday
 - 13 Sankoh, so he too became angry and sent them to the front line.
 - 14 Q. You said that "... he asked Kargbo, who was the battle
- 10:18:48 15 group commander for the RUF, to look for five junior commandos."
 - 16 Who is the "he"? Who asked Kargbo to do that?
 - 17 A. Foday Sankoh.
 - 18 Q. And who was Kargbo?
 - 19 A. Kargbo was the battle group commander for the RUF.
- 10:19:11 20 Q. What was his nationality?
 - 21 A. He was a Sierra Leonean.
 - 22 Q. So then what happened after Foday Sankoh asked Kargbo to
 - 23 find these five junior commandos?
 - 24 A. Kargbo those of us who were at the Mansion Ground, it was
- 10:19:36 25 from among us that Kargbo appointed people. He appointed me, Ben
 - Sheriff, he appointed Ansu Brima, he appointed Ansu Sillah, he
 - 27 appointed Mohamed.
 - 28 MS HOLLIS: Your Honours, Ansu Brima is A-N-S-U B-R-I-M-A,
 - 29 Ansu Sillah is A-N-S-U S-I-L-A-H and Ben Sheriff is

- 1 S-H-E-R-I-F-F:
- 2 Q. Once you became a bodyguard to Foday Sankoh, what were your
- 3 duties?
- 4 A. When Foday Sankoh took me as a bodyguard he told us that we
- 10:20:38 5 should be protecting him. He told me that I should be taking
 - 6 care of his food and to be preparing tea for him. That was -
 - 7 those were my own duties.
 - 8 Q. And do you recall what year it was that you and these
 - 9 others became a bodyguard to Foday Sankoh?
- 10:21:03 10 A. It happened in 1991.
 - 11 Q. Now if I can go back for just a moment, you said that Foday
 - 12 Sankoh told Kargbo to find junior commandos. Who are junior
 - 13 commandos?
 - 14 A. That refers to those of us who were trained in Sierra
- 10:21:28 15 Leone. They referred to us as junior commandos.
 - 16 Q. What was the name given to Foday Sankoh's bodyguards?
 - 17 A. At first after the bodyguards he changed it to Black Guard.
 - 18 Q. And when did this happen?
 - 19 A. It happened in 1992.
- 10:22:04 20 Q. How long did you remain a bodyguard to Foday Sankoh?
 - 21 A. Since when I was with him, I was with him until the time
 - 22 that he was arrested.
 - 23 Q. Until the time he was arrested where?
 - 24 A. I was with him until he was arrested in when the Court
- 10:22:45 **25** indicted him.
 - 26 Q. When you say "court", what court are you talking about?
 - 27 A. Special Court.
 - 28 Q. What were the duties of the Black Guard personnel?
 - 29 A. Well, Foday Sankoh trained us, the Black Guards, and he

- 1 told us that the revolution that he had launched was a black
- 2 revolution. We, the Black Guards, our duties were to guard the
- 3 revolution. So he trained us and sent us to the front lines.
- 4 Our duties were that we should go and sensitise the soldiers that
- 10:23:43 5 no raping should take place, no looting, no burning of houses, so
 - 6 that was the training that he gave us and told us that we should
 - 7 go to the front lines to teach the soldiers.
 - 8 Q. In addition to sensitising the soldiers did you have any
 - 9 other duties at the front lines?
- 10:24:05 10 A. To send reports to him in relation to what was going on.
 - 11 Q. What kind of reports would you send, in what form?
 - 12 A. We used to write them down on paper and send them to him.
 - 13 Q. When you were at the front lines in addition to these
 - 14 written reports did you have any other way to communicate with
- 10:24:38 15 Foday Sankoh?
 - 16 A. We communicated to him through radio communications.
 - 17 Q. Do you remember the names of any of the radio operators you
 - 18 worked with?
 - 19 A. There was Daf, who was a radio operator, and others.
- 10:25:27 20 Q. [Microphone not activated]
 - 21 A. His name is Dauda Fornie.
 - 22 Q. What was his nationality?
 - 23 A. He is a Sierra Leonean.
 - 24 Q. Now, you testified that you were sent to the front lines to
- 10:25:55 25 sensitise the soldiers that there would be no raping, no looting,
 - 26 no burning of homes. Now, when you were at the front line did
 - 27 raping occur?
 - 28 A. It used to happen.
 - 29 Q. Did looting occur?

- 1 A. Yes.
- 2 Q. Did burning of houses occur?
- 3 A. Yes.
- 4 Q. And did you report all these things?
- 10:26:22 5 A. Yes, because that was my duty. I used to do it.
 - 6 Q. If you know, what happened when you reported these things?
 - 7 A. Sometimes the leader took action and at some other times he
 - 8 di dn' t.
 - 9 Q. Could you tell us, please, what was the command structure
- 10:26:51 10 of the Black Guards?
 - 11 A. We had Black Guard commander, we had a deputy Black Guard
 - 12 commander, we had the adjutant, we had the operation Black
 - 13 Guard operation. We had those.
 - 14 Q. What was the duty of the adjutant?
- 10:27:37 15 A. The adjutants who had been with the commanders, whenever
 - 16 things happened at the front line it was the adjutants and the
 - 17 commanders who sat together and the adjutant would write them
 - 18 down.
 - 19 Q. Then you said you also had "operation", what do you mean by
- 10:28:01 **20** that?
 - 21 A. I have not got that clearly.
 - 22 Q. You said that in this command structure you had operation.
 - 23 What do you mean by "operation"?
 - 24 A. Operation commander. He was he went to the front lines
- 10:28:24 25 to the other Black Guards. If he had any report, he will take
 - 26 that to the deputy commander and the deputy commander in turn
 - 27 will send them to the Black Guard commander. That was how we
 - 28 operated.
 - 29 Q. During the time that you were a bodyguard, a Black Guard,

- 1 to Foday Sankoh did you ever see Foday Sankoh's signature on any
- 2 documents?
- 3 A. Yes.
- 4 Q. And are you able to recognise his signature?
- 10:28:59 5 A. Yes.
 - 6 MS HOLLIS: Your Honours, at this time I would ask that the
 - 7 document at tab 2 which is D-15 and the document at tab 3 which
 - 8 is P-65 be taken to the witness.
 - 9 MR GRIFFITHS: I wonder if I can just intervene to clarify
- 10:29:43 10 what it is that my learned friend proposes to do. Is it merely
 - 11 to identify the signature, or is it to introduce the document?
 - 12 I am not quite sure what the purpose of this is.
 - 13 MS HOLLIS: Firstly, your Honour, both documents are in
 - 14 evidence, so I am not introducing or offering a document, and my
- 10:30:05 15 next questions were going to be if the witness recognised the
 - 16 signatures.
 - 17 JUDGE SEBUTINDE: Ms Hollis, we just need to make sure we
 - 18 are on the same page. My document in tab 2 doesn't have a
 - 19 signature. Maybe I am looking at the wrong document.
- 10:30:27 20 MS HOLLIS: Perhaps I am in error, your Honour. The
 - 21 document I am talking about is a two page handwritten document.
 - 22 It is D-15. It is from Corporal Foday Sankoh to brother Mohamed
 - 23 Talibi, subject: "Follow-up request". Your Honour, that's in
 - the binder for week 23.
- 10:31:12 25 PRESIDING JUDGE: Madam Court Attendant, please show the
 - document to the witness.
 - MS HOLLIS:
 - 28 Q. Mr Witness, if you would take a moment and look at page 2.
 - 29 Do you see the signature on page 2?

- 1 A. Yes.
- 2 Q. Do you recognise that signature?
- 3 A. I have seen it. Yes, I can remember it. It is Foday
- 4 Sankoh's signature.
- 10:31:43 5 Q. Mr Witness, did you know someone called Mohamed Talibi?
 - 6 A. Yes, I used to know him.
 - 7 Q. How did you know him?
 - 8 A. I knew Mohamed L Talibi at the time that I was in Liberia.
 - 9 It was Foday Sankoh who introduced him to me.
- 10:32:09 10 MS HOLLIS: If the witness could be shown the document at
 - 11 tab 3, P-65. It is a one page document:
 - 12 Q. Mr Witness, do you recognise the signature on this
 - 13 document?
 - 14 A. Yes.
- 10:32:30 15 Q. Whose signature is it?
 - 16 A. This too is Foday Sankoh's signature.
 - 17 Q. Now, Mr Witness, this signature on P-65, look at that and
 - 18 then would you also look at the signature on the document D-15,
 - 19 the two page letter. Would you look at both of those signatures.
- 10:33:00 20 Now, those signatures appear to be different. Can you explain
 - 21 that to us?
 - 22 A. Yes. Foday Sankoh was a person who hadn't a single
 - 23 signature. He had up to three.
 - Q. Mr Witness, once you became the bodyguard to Foday Sankoh
- 10:33:30 25 you have described some of the duties. Did you have other duties
 - as his bodyguard?
 - 27 A. Yes.
 - 28 Q. What were those duties?
 - 29 A. I was a bodyguard to him. He used to send me to the front

- 1 lines to bring reports.
- 2 Q. Did you ever travel with him?
- 3 A. Yes.
- 4 Q. Where did you go with him?
- 10:34:08 5 A. The first trip that I made with him, Foday Sankoh and
 - 6 I travelled to Liberia.
 - 7 Q. How many trips to Liberia did you make with Foday Sankoh?
 - 8 A. In 1991 I travelled with him once. In '92 we travelled
 - 9 agai n.
- 10:34:41 10 Q. And were those the only trips you made with him to Liberia?
 - 11 A. I can't recall.
 - 12 Q. Where did you travel to in Liberia?
 - 13 A. When we left Pendembu we went we travelled to Kailahun.
 - 14 From Kailahun, Buedu to Koindu and from there we went to Foya and
- 10:35:15 15 from Foya we went to Kolahun and then Voinjama and then Zorzor,
 - 16 then we got to Gbarnga. That's how we went.
 - 17 Q. Did you take this route both times that you went with Foday
 - 18 Sankoh?
 - 19 A. Yes.
- 10:35:34 20 Q. When you travelled this route did you ever have any
 - 21 problems crossing into Liberia from Sierra Leone?
 - 22 A. No, we had no problems in crossing.
 - 23 Q. Who was in control of the border on the Liberian side?
 - 24 A. Well, when we were crossing over we met the Liberian
- 10:36:04 25 securities there and they were NPFL.
 - 26 Q. When you travelled from the border to Gbarnga did you go
 - through checkpoints?
 - 28 A. Yes.
 - 29 Q. Who controlled those checkpoints?

- 1 A. The NPFL soldiers.
- 2 Q. Did you ever have problems at those checkpoints?
- 3 A. No.
- 4 Q. Now, why did you go to Gbarnga these two times?
- 10:36:39 5 A. Foday Sankoh told us that it was one of his bases. When he
 - 6 used to go there he used to go there to meet his brother
 - 7 Charles Taylor.
 - 8 Q. And when he told you it was one of his bases what did you
 - 9 understand that to mean?
- 10:37:04 10 A. That it was a place that was there for him. Whenever he
 - 11 goes to Gbarnga, that was where he was to stay.
 - 12 Q. On this first trip to Gbarnga, did you have any
 - 13 communications during that trip?
 - 14 A. Yes.
- 10:37:33 15 Q. And what communications did you have?
 - 16 A. When we crossed the border, we got to Foya, Foday Sankoh
 - 17 told us that he was going to the signal room; that is the radio
 - 18 room. He disembarked from the vehicle and he went into the radio
 - 19 office and we kept guard. After some time he came out. Then he
- 10:38:12 20 told us that he had spoken to his brother Charles in Gbarnga and
 - 21 his brother said "No problem" and that he would be happy to
 - 22 receive him. Then we went.
 - 23 Q. Now, you said that he went into a radio room in Foya.
 - Whose radio room was this?
- 10:38:33 25 A. Well, this radio room, it was the NPFL that controlled it.
 - 26 I did not know who was operating it.
 - 27 Q. What happened when you arrived at Gbarnga on this first
 - 28 trip?
 - 29 A. When we went, we arrived at night. Later I saw someone

- 1 come and introduced himself as an SS officer. He said he had
- 2 come from Charles Taylor's mansion. I saw him enter to Foday
- 3 Sankoh. After some time he came out.
- 4 Q. Now, where were you when this happened?
- 10:39:25 5 A. Well the area where we went in Gbarnga, Foday Sankoh told
 - 6 us that that place was called the far east. That was where we
 - 7 went. That was where the house was.
 - 8 Q. When you say "the far east" and this is where the house
 - 9 was, whose house was there?
- 10:39:47 10 A. It was Foday Sankoh's place.
 - 11 Q. You said that an SS officer came. Did you learn what SS
 - 12 meant?
 - 13 A. Yes, later I was made to understand that SSS was Special
 - 14 Security Services.
- 10:40:11 15 Q. And did you learn for whom the Special Security Service
 - 16 worked?
 - 17 A. Yes.
 - 18 Q. Who was that?
 - 19 A. They were Charles Taylor's securities.
- 10:40:27 20 Q. So what happened after the SS man went into Foday Sankoh
 - 21 and then came out?
 - 22 A. Foday Sankoh went to the mansion to Charles Taylor.
 - 23 Q. Did anyone go with him?
 - 24 A. Yes, I went with him together with some other securities.
- 10:40:53 25 Q. And what happened at Charles Taylor's mansion?
 - 26 A. We went there. When we got there, Foday Sankoh entered.
 - 27 He told us that he was going to meet his brother Charles and so
 - we waited in the waiting room. We were there up to 1.30 and he
 - 29 came back and we went back home.

- 1 Q. You said you were there until 1.30. Is that in the
- 2 afternoon, or early morning?
- 3 A. Well, we went there at night, 1.30 a.m.
- 4 Q. What happened then when you arrived back at the residence?
- 10:41:38 5 A. We came back home. Foday Sankoh told us that he had spoken
 - 6 with his brother Charles. He said he was happy. He said his
 - 7 brother had told him that he will help him with materials to
 - 8 return.
 - 9 Q. And did you understand what materials meant?
- 10:41:59 10 A. Well, he said arms and ammunition.
 - 11 Q. What happened after that?
 - 12 A. After that, the following morning they came with the arms
 - 13 and ammunition in a vehicle.
 - 14 Q. And who came with the arms and ammunition?
- 10:42:24 15 A. One SS officer.
 - 16 Q. Do you remember that person's name?
 - 17 A. He called himself he said he was Cassius Jacob.
 - 18 Q. What happened when he arrived with the arms and ammunition?
 - 19 A. He handed over everything to Foday Sankoh and then he
- 10:42:55 **20** returned.
 - 21 Q. Did you learn what type of arms and ammunition he had
 - 22 handed over?
 - 23 A. He came with AK rounds, RPG bombs, grenades and other
 - 24 weapons which I can't recall now.
- 10:43:25 25 Q. Do you recall what quantity of materials you were given at
 - 26 that time?
 - 27 A. There were plenty. I can't recall now.
 - 28 Q. You said this person came with the materials in a truck.
 - 29 What happened to the truck?

- 1 A. This truck, Foday Sankoh said that the truck should take
- 2 the materials to Sierra Leone.
- 3 Q. Now this truck, was this a truck you had brought to
- 4 Gbarnga?
- 10:44:09 5 A. No, it came from there. It had come from the mansion.
 - 6 Q. Who took these arms and ammunition back to Sierra Leone?
 - 7 A. One other security who was with Foday Sankoh. His name was
 - 8 Papa. They took the ammunition to Sierra Leone.
 - 9 Q. And what was Papa's nationality?
- 10:44:42 10 A. Papa was a Liberian.
 - 11 Q. Do you know what group he was with?
 - 12 A. At first he was with the NPFL and he later joined Foday
 - 13 Sankoh.
 - 14 Q. Did Foday Sankoh give Papa any instructions as to what to
- 10:45:00 15 do with these arms and ammunition?
 - 16 A. He told Papa to take the arms and ammunition to Pendembu to
 - 17 give to Kargbo, who was the battle group.
 - 18 Q. What did Foday Sankoh and you and the others do after Papa
 - 19 | left?
- 10:45:26 20 A. Well, Foday Sankoh went back to the mansion to his brother.
 - 21 He gave him one other pick-up with arms and ammunition.
 - 22 Q. How do you know it was Charles Taylor who gave Foday Sankoh
 - 23 these materials?
 - 24 A. Whatever happened, he told us the bodyguards to him.
- 10:46:01 25 Q. Just to be clear, when you say "he told us" who are you
 - 26 talking about?
 - 27 A. Foday Sankoh used to tell us that Charles was his brother.
 - 28 Whatever arms and ammunition he gave to him, we the bodyguards -
 - 29 he will tell us, the bodyguards, that it was his brother that had

- 1 given them to him.
- 2 Q. Now, you said it was a pick-up truck that the materials
- 3 were in. Did you learn what kind of materials were in this
- 4 pick-up truck?
- 10:46:34 5 A. Yes.
 - 6 Q. What kind of materials?
 - 7 A. AK rounds were there, RPG and AK rounds, RPG and M203 gun
 - 8 and others which I cannot recall.
 - 9 Q. What happened after this pick-up truck was brought with
- 10:47:05 10 these arms and ammunition in it?
 - 11 A. Well, we travelled with Foday Sankoh to Sierra Leone.
 - 12 Q. Where did you go in Sierra Leone?
 - 13 A. We went to Pendembu.
 - 14 Q. During this first trip to Gbarnga, did you see
- 10:47:37 15 Charles Taylor?
 - 16 A. No.
 - 17 Q. During this first trip, did Foday Sankoh have any
 - 18 communications with Sierra Leone while he was in Gbarnga?
 - 19 A. Yes.
- 10:47:57 20 Q. And, if you know, what type of communications did he have?
 - 21 A. Well, at that time when he wanted to communicate to Sierra
 - 22 Leone he used to go to the Mansion Ground. The operator was
 - 23 there and he was called Butterfly. That was where he
 - 24 communicated.
- 10:48:18 25 Q. Who was Butterfly?
 - 26 A. Butterfly was an operator for Charles Taylor.
 - 27 Q. What happened once you arrived back in Pendembu?
 - 28 A. When we got to Pendembu, Foday Sankoh gave these materials
 - 29 to the battle group commander.

- 1 Q. Do you know how this material was going to be used?
- 2 A. He said they should be distributed to the front lines.
- 3 Q. Now, you said you made a second trip to Gbarnga. Can you
- 4 tell us again what year that was that you made this second trip?
- 10:49:04 5 A. It happened in 1992.
 - 6 Q. What happened on this second trip?
 - 7 A. During the second trip we used the same route through
 - 8 Koindu in Mendekoma. That was where we crossed and got to
 - 9 Gbarnga. When we got there, Foday Sankoh went to greet his
- 10:49:36 10 brother Charles again. Later he told us that he had received a
 - 11 radio message at Cape Mount area. He said his brother Charles
 - 12 had told him that the soldiers the RUF soldiers from Pujehun -
 - 13 had retreated and have come to Bomi Hills and Bopolu.
 - 14 Q. Now, you said that he had received a message. Who received
- 10:50:13 15 this message?
 - 16 A. Well, he said a signal message had come from Cape Mount
 - 17 area to the mansion. He said his brother has told him. His
 - 18 brother Charles had told him.
 - 19 Q. You said this message came from Cape Mount. What do you
- 10:50:33 20 mean by Cape Mount?
 - 21 A. Cape Mount County. That is an area where the NPFL was in
 - 22 control. That is the area, Cape Mount County.
 - 23 Q. You said that RUF soldiers had come to Bomi Hills and
 - 24 Bopolu. Did you know another name for Bomi Hills?
- 10:50:59 25 A. Yes, Bomi Hills they called there Tubmanburg.
 - 26 Q. So what happened after Foday Sankoh got this news?
 - 27 A. Well, later he told us that his brother Charles had said
 - 28 that he will help him with food to take for the soldiers. At
 - 29 that time his brother provided the food rice and other items, so

- 1 we went.
- 2 Q. So there was food and other items "and then we went". What
- 3 do you mean "we went"?
- 4 A. Well after these items had been given to Foday Sankoh, he
- 10:51:56 5 organised a trip. He said the truck would go through. He said
 - 6 it will leave Gbarnga for Kakata. From Kakata it will go to Bong
 - 7 Mine crossing point. That is where they would leave the rice.
 - 8 Other people were to come from Bomi Hills and cross the rice over
 - 9 in a canoe. We were to Foday Sankoh, together with us, the
- 10:52:27 10 securities, were to use a pick-up and go through Gbarnga to
 - 11 Zorzor and from Zorzor we go to Fassama until we get to Bomi
 - 12 Hills. That was how it happened. That was how he organised the
 - 13 trip.
 - 14 Q. Mr Witness, if we were to provide you with a map of Liberia
- 10:52:48 15 would you be able to show us these routes?
 - 16 A. Yes.
 - 17 MS HOLLIS: If the witness could be shown L1, it is in the
 - map binder as L1, and if the witness could be given a moment to
 - orientate himself to the map.
- 10:54:27 20 THE WITNESS: Yes.
 - 21 MS HOLLIS:
 - 22 Q. Mr Witness, you are orientated to the map?
 - 23 A. Yes.
 - 24 Q. If you could first show us on this map if you could be
- 10:54:40 25 perhaps provided a pen and just show us the route that the truck
 - 26 with the supplies took to Bomi Hills. You will have to move over
 - to the map, but you will have to leave those headphones on.
 - 28 Madam Court Administrator, are we going to be able to do this
 - 29 with the microphones?

- 1 A. Yes.
- 2 Q. Now, Mr Witness, if you could please show the judges by
- 3 tracing it with your pen show the judges the route that the
- 4 truck took to Bomi Hills.
- 10:55:22 5 A. This is Bong County and this is where we were, Gbarnga
 - 6 Town. So the route the truck took to go to Bong Mines, it went
 - 7 this way up to Totota. From there it came this way up to here,
 - 8 Kakata. That was where they took the intersection from Kakata
 - 9 and went to Bong Mines. This is where they crossed over. This
- 10:57:10 10 is where they crossed and went to Tubmanburg. Here, this is
 - 11 where they came.
 - 12 Q. [Overlapping speakers]
 - 13 A. This is where Bong Mines crossing point is. Here is
 - 14 Tubmanburg. So this is where they used the truck to bring the
- 10:57:34 15 rice. It was unloaded here and they crossed over to Tubmanburg.
 - 16 Q. Thank you, Mr Witness. Now, if you could, using that same
 - 17 map, could you show us the route that you and Foday Sankoh and
 - 18 the others took to go to Tubmanburg?
 - 19 JUDGE SEBUTINDE: Ms Hollis, don't you think the witness
- 10:57:57 20 should actually mark this? How is this going to go into
 - 21 evi dence?
 - 22 MS HOLLIS: He did mention that he went from Gbarnga to
 - 23 Kakata and up to Bong Mines and over. Now if it would be of more
 - 24 assistance we can certainly have him trace it.
- 10:58:14 25 JUDGE SEBUTINDE: Yes, because I am concerned about the
 - 26 record months from now. This running of the pen is not
 - 27 registering anywhere.
 - 28 MS HOLLIS: Yes, your Honour.
 - 29 Q. Mr Witness, are you able to trace that route for us that

- 1 you just described?
- 2 A. Yes.
- 3 Q. Perhaps green would be better given that the road
- 4 [overlapping speakers]?
- 10:58:47 5 A. Gbarnga is in Bong County. This is in Bong County. Here
 - 6 is Gbarnga. This was where we were. So the truck took this
 - 7 route. It came this way.
 - 8 Q. Mr Witness, would you please mark the map with the
 - 9 highlighter. Actually trace the route on the map, if you can.
- 10:59:12 10 JUDGE SEBUTINDE: Mr Witness, in other words, draw with
 - 11 your pen the route that you took.
 - 12 THE WITNESS: This route what I am trying to say, from
 - 13 what Foday Sankoh said, I did not use this route. He said this
 - 14 truck this was an instruction he gave to them, the way the
- 10:59:32 15 truck should go. I went this way, the Fassama way. But Foday
 - 16 Sankoh gave instruction that the truck was to leave Gbarnga and
 - 17 come this way, the main road up to Totota. When it got to Totota
 - 18 it was to go to Kakata. From Kakata it was to use that
 - 19 intersection to enter Bong Mine. The crossing point was at Bong
- 11:00:01 20 Mines, from what he said. From there people were to come from
 - 21 Tubmanburg to receive this rice and they will be crossed they
 - 22 were using a canoe.
 - 23 MS HOLLIS:
 - 24 Q. Mr Witness, we understand that. What we would ask you to
- 11:00:19 25 do, if you can, is to take that green marker and actually mark it
 - 26 along the route that the truck took so that you are marking the
 - 27 route with the green marker. Can you do that?
 - 28 JUDGE SEBUTINDE: Ms Hollis, if the witness has said he
 - 29 wasn't on the truck, he took a different way, he only heard the

- 1 instruction, how on earth can he mark the route?
- 2 MS HOLLIS: Well, he was told the route that they were
- 3 taki ng.
- 4 JUDGE SEBUTINDE: That they were going to take, but he
- 11:00:48 5 wasn't with them.
 - 6 MS HOLLIS: He can mark the route he understood they would
 - 7 take:
 - 8 Q. Now, Mr Witness, are you able to do that for us?
 - 9 A. Yes.
- 11:01:11 10 JUDGE LUSSICK: Ms Hollis, just on that very same point,
 - 11 your question was, "Show the judges the route that the truck took
 - 12 to Bomi Hills" but now this witness is being asked to mark a
 - 13 route that he thinks they took.
 - 14 MS HOLLIS: Let me rephrase the question to be consistent
- 11:01:30 15 with his knowledge then, your Honour:
 - 16 Q. Mr Witness, you said that Foday Sankoh instructed the
 - 17 people in this truck to take this route to Bomi Hills. Would you
 - 18 mark on the map the route Foday Sankoh instructed them to take.
 - 19 A. From Gbarnga Town this way the truck was to leave here, use
- 11:02:01 20 the main road, so --
 - 21 Q. Mr Witness, I want you to actually use the marker to mark.
 - 22 So the green that you are marking, is this along the road?
 - 23 A. Okay, they used the main road and got to Totota. They
 - 24 continued up to Kakata. Then they branched off and they went to
- 11:03:20 25 Bong Mine. When they got to Bong Mine he gave instruction that
 - 26 that was where they were to cross. He said that was the crossing
 - 27 point, at the riverside, here, this area. This was where they
 - were to cross to go to Tubmanburg.
 - 29 MS HOLLIS: Could we have the assistance of the Court

- 1 Administrator to move the map so we can see what has been marked.
- 2 Move all the way over so Tubmanburg is on the screen:
- 3 Q. Now, can you complete your marking to Tubmanburg?
- 4 A. Well, I heard Foday Sankoh giving the instruction that when
- 11:04:31 5 they got to Kakata it was from there that they would take the
 - 6 point up to Tubmanburg, but I was not with them to know the
 - 7 actual route they took to get to Tubmanburg, but I know that when
 - 8 you get to Kakata that is where you would branch off to go to
 - 9 Tubmanburg.
- 11:04:51 10 Q. Thank you for that, Mr Witness. Now, are you able on this
 - 11 map to take that marker and mark for us the route that you and
 - 12 Foday Sankoh travelled to Tubmanburg? Are you able to do that?
 - 13 A. Yes, yes. We were in Gbarnga Town. We left there, went
 - 14 this way. We got to Fassama, then we branched off and went to -
- 11:07:15 15 and got to Bopolu, then Tubmanburg. That was how we travelled.
 - 16 Q. So the route that is shown in green is the route that the
 - 17 truck took, is that right?
 - 18 A. Yes.
 - 19 Q. That is the route that the truck was instructed to take?
- 11:07:39 20 A. Yes.
 - 21 Q. And the route that is --
 - 22 MR GRIFFITHS: I hesitate to interrupt, your Honours, but
 - 23 I wonder if we could just clarify what that first mark from
 - 24 Gbarnga going east what that first mark made by the witness
- 11:07:55 **25** represents.
 - 26 PRESIDING JUDGE: Is that the one in red?
 - 27 MR GRIFFITHS: The one in red well it is actually orange,
 - 28 but it shows up on the screen as red. Initially the witness made
 - 29 a mark going east on the map and I just wondered what that

- 1 represents.
- 2 PRESIDING JUDGE: Yes, Ms Hollis, I did notice that he
- 3 seemed to start in a different way.
- 4 MS HOLLIS: Well, your Honour, if I had the ability to ask
- 11:08:24 5 the questions I would have asked that.
 - 6 PRESIDING JUDGE: Please do so.
 - 7 MS HOLLIS:
 - 8 Q. So this marking in red, you have marked in orange or red,
 - 9 is the route that you and Foday Sankoh took to Tubmanburg. Is
- 11:08:33 10 that correct?
 - 11 A. Yes.
 - 12 Q. Now if you look at what you marked from Gbarnga, you
 - initially had a line going off to the east. What is that line?
 - 14 A. Are you talking about this one?
- 11:08:56 15 Q. Back to Gbarnga --
 - 16 A. Yes, here is Gbarnga.
 - 17 Q. -- do you see where you went north on the map, or you went
 - 18 up? Now, you have another mark here going to the east instead of
 - 19 going north. Can you tell us what that mark is?
- 11:09:15 20 JUDGE SEBUTINDE: Madam Court Officer, could you move --
 - 21 THE WITNESS: This?
 - 22 JUDGE SEBUTINDE: Could you move it into view, please, the
 - 23 marking in question. It is off the map now.
 - 24 THE WITNESS: The line that I drew it is from this is
- 11:09:49 25 Gbarnga Town going this way.
 - 26 MS HOLLIS:
 - 27 Q. Yes, now look at the other line that you started to make
 - 28 from Gbarnga going to your right as you are looking at the map.
 - 29 A. Thi s?

- 1 Q. Yes, would you tell us what that is?
- 2 A. No, this is not the actual route. This is a mistake. It
- 3 is the ink. This is the actual route that we used, from Gbarnga
- 4 Town here and went this way.
- 11:10:20 5 MS HOLLIS: Your Honours, if I can ask that that map be
 - 6 marked for identification.
 - 7 PRESIDING JUDGE: Yes, that is MFI-1 no, MFI-4 I think.
 - 8 Just let me check, please.
 - 9 MS IRURA: Your Honour, it is MFI-2.
- 11:10:40 10 PRESIDING JUDGE: MFI-2. It is one map of Liberia, with
 - 11 the surrounding countries of Sierra Leone, Guinea and Cote
 - 12 d'Ivoire, as marked by the witness in green and orange.
 - 13 MS HOLLIS: Thank you, Madam President:
 - 14 Q. Now, Mr Witness, you can move back if it is better for the
- 11:11:03 15 microphones. Mr Witness, what happened? Did you actually take
 - that route to Tubmanburg with Foday Sankoh?
 - 17 A. Yes.
 - 18 Q. Now, you had mentioned earlier that the radio message said
 - 19 that RUF had come to Bopolu and to Tubmanburg. When you went to
- 11:11:40 20 Bopolu, did you find any RUF there?
 - 21 A. Yes, I saw RUFs there.
 - 22 Q. And what happened when you arrived in Tubmanburg?
 - 23 A. When we got to Tubmanburg, we went to a place where I met a
 - 24 person who was an NPFL commander called One Man One. He
- 11:12:10 25 introduced himself to us that he was the commander in that area.
 - I saw some other people who were later introduced by Foday Sankoh
 - 27 to me as the RUF soldiers.
 - 28 Q. Do you remember the names of any of these people that were
 - 29 introduced to you as RUF soldiers?

- 1 A. He introduced Philip Palmer he was an RUF person and Pa
- 2 Moriba, Smiling P and Mosquito.
- 3 Q. Philip Palmer, were you told where Philip Palmer had
- 4 trained?
- 11:13:07 5 A. They told me that Philip Palmer was trained at Camp Naama.
 - 6 He was an RUF vanguard.
 - 7 Q. What was his nationality?
 - 8 A. He is Sierra Leonean.
 - 9 Q. You mentioned a Smiling P. Who was that?
- 11:13:31 10 A. Smiling P was a woman, but she was NPFL.
 - 11 Q. And do you know why she was with these RUF fighters?
 - 12 A. She had been with the RUF. That was what she said.
 - 13 Q. And you also mentioned a Moriba. Who is that?
 - 14 A. Pa Moriba was a Liberian.
- 11:14:08 15 Q. Do you know why he was with the RUF?
 - 16 A. I can't recall now.
 - 17 Q. You mentioned Mosquito. Did you have another name for
 - 18 Mosqui to?
 - 19 A. Mosqui to Mosqui to was Sam Bockarie.
- 11:14:44 20 Q. And what was his nationality?
 - 21 A. He was a Si erra Leonean.
 - 22 Q. Did you learn where he had trained?
 - 23 A. Please repeat your question. The last bit was not clear.
 - 24 Q. Did you learn where Sam Bockarie had trained?
- 11:15:05 25 A. Well, when I was there I was made to understand that he had
 - 26 trained at Camp Naama. He was one of the vanguards.
 - 27 Q. And what happened then when you and Foday Sankoh were with
 - these RUF people?
 - 29 A. He called a meeting where Foday Sankoh arranged with One

- 1 Man One and Philip Palmer that they should try and since they
- 2 had retreated from the Pujehun area they were to organise how
- 3 they were to go to Gbarnga and to go back to Kailahun because the
- 4 RUF were still in the Kailahun area. That was what they
- 11:16:04 5 arranged.
 - 6 Q. And what happened after this arrangement was made?
 - 7 A. Well, after that arrangement had been made Foday Sankoh and
 - 8 I returned to Gbarnga.
 - 9 Q. While you were at Tubmanburg, did that supply truck arrive
- 11:16:30 10 at Tubmanburg?
 - 11 A. No, it didn't arrive.
 - 12 Q. Now, you said you and Foday Sankoh went back to Gbarnga.
 - 13 Who went with you?
 - 14 A. The group that we went with, when we were returning
- 11:16:54 15 Mosqui to added to our number because Mosqui to had a problem with
 - 16 the NPFL soldiers and so Foday Sankoh said he was not going to
 - 17 leave him behind. We were all to go together.
 - 18 Q. What was his problem he had with the NPFL?
 - 19 A. From what they said Mosquito had killed one NPFL soldier
- 11:17:25 20 whom they said had raped someone, so he killed the soldier. This
 - 21 caused the problem between himself and the NPFL soldiers.
 - 22 Q. But what was the problem itself?
 - 23 A. They wanted to kill him.
 - 24 Q. Now when you returned from Tubmanburg to Gbarnga, what
- 11:17:58 25 route did you take?
 - 26 A. That same route was the one that we used to Belle Fassama,
 - 27 from there Zorzor and back to Gbarnga.
 - 28 Q. What happened after you arrived back in Gbarnga?
 - 29 A. After we had arrived Foday Sankoh went to his brother,

- 1 Charles Taylor.
- 2 Q. And what happened after he went to his brother,
- 3 Charles Taylor?
- 4 A. Well he told him that he and his brother had arranged that
- 11:18:48 5 this was the time that they were to capture Kono, because Kono
 - 6 was a diamond mining area and that they should try and capture
 - 7 there. Later Charles Taylor gave the arms and ammunition.
 - 8 Q. And what type of arms and ammunition --
 - 9 JUDGE LUSSICK: Well I am sorry to interrupt, but it is
- 11:19:09 10 just that I don't understand that last answer. The answer was
 - 11 "Well, he told him that he and his brother ..." It looks as
 - 12 though there is a third person in there somewhere.
 - 13 MS HOLLIS: Thank you, your Honour, I will clarify that:
 - 14 Q. Mr Witness, you said that Foday Sankoh went to his brother
- 11:19:30 15 Charles Taylor and "... he told him that he and his brother had
 - 16 arranged that was the time that they were to capture Kono." Now
 - 17 when you say, "... he told him that he and his brother had
 - 18 arranged ...", who told whom?
 - 19 A. Well he was trying to talk to us that he and his brother,
- 11:19:56 20 he and Charles Taylor, have arranged that Charles Taylor was to
 - 21 help with arms and ammunition to go and capture Kono because Kono
 - 22 had di amonds.
 - 23 Q. Just to be absolutely clear, when you say, "He and
 - 24 Charles Taylor", who is the "he"?
- 11:20:14 25 A. Foday Sankoh.
 - 26 Q. These arms and ammunition that you received, could you tell
 - 27 us what types of arms and ammunition?
 - 28 A. The arms and ammunition were plenty. He gave up to 50
 - 29 boxes 50 boxes of AK rounds. That is 100 sardine tins were

- 1 contained in two boxes, that is hundred. He gave rice, he gave
- 2 RPG boxes, GPMG and others that I cannot recall.
- 3 Q. And when you talk about sardine tins, what are you talking
- 4 about?
- 11:21:07 5 A. Well in the box, the box in the box the tins that were
 - 6 in the tins in which the ammunitions were we used to call them
 - 7 sardine tins.
 - 8 Q. And what happened after you received these materials?
 - 9 A. Well after we had received these materials Foday Sankoh
- 11:21:43 10 said that we were to go back to Sierra Leone, but at that time
 - 11 some other soldiers for whom he had left an instruction at Bomi
 - 12 Hills to meet him at Gbarnga were already on the ground. So he
 - 13 put Mosquito in charge of the group to go with the truck that
 - 14 contained the arms and ammunition, so we moved.
- 11:22:12 15 Q. This truck that contained the arms and ammunition, whose
 - 16 truck was it?
 - 17 A. Well, the truck was a DAF truck. It had come from the
 - 18 mansion from Charles Taylor.
 - 19 Q. And what size truck was this?
- 11:22:31 20 A. Well, it was a six-tyred truck.
 - 21 Q. And when you say it was a DAF truck, what do you mean by
 - 22 DAF?
 - 23 A. Well the vehicle, that was the name of the vehicle. In
 - 24 front of it in front of the vehicle it was written "DAF",
- 11:22:59 **25 D-A-F**.
 - 26 Q. Now, you said that Foday Sankoh put Sam Bockarie in charge
 - of the truck and "we moved". What do you mean "we moved"?
 - 28 A. We went to Sierra Leone.
 - 29 Q. At this time when you left Gbarnga, where was Philip

- 1 Palmer?
- 2 A. Well the other group that were coming, Philip Palmer came
- 3 to Gbarnga. He stayed in charge of the other materials and to
- 4 control the other soldiers that were coming.
- 11:23:46 5 Q. And who gave him this assignment?
 - 6 A. It was Foday Sankoh who gave him the assignment.
 - 7 Q. Now, on this second trip to Gbarnga did you see
 - 8 Charles Taylor?
 - 9 A. Yes, I saw him.
- 11:24:02 10 Q. How did it happen that you saw Charles Taylor?
 - 11 A. It happened when we were returning to Sierra Leone, we
 - 12 passed through the Mansion Ground. As we were approaching
 - 13 Charles Taylor's mansion area in Gbarnga, we were approaching the
 - 14 motor pool. At that time Charles Taylor was outside and so Foday
- 11:24:31 15 Sankoh told the driver to slow down. When he slowed down, he
 - 16 told him to stop. When he stopped, Foday Sankoh alighted and
 - 17 went and met his brother Charles. It was since it was then
 - 18 that I knew him.
 - 19 Q. The residence that Foday Sankoh had in Gbarnga, what was
- 11:24:52 20 the distance between that residence and Charles Taylor's mansion?
 - 21 A. It was not far at all. You would be there and looking at
 - the mansi on.
 - 23 Q. Can you give us any idea of the distance?
 - 24 A. If you are walking on foot you could spend about
- 11:25:25 **25 15 mi nutes**.
 - 26 Q. You said that you, Foday Sankoh and the others left for
 - 27 Sierra Leone. Where did you go in Sierra Leone?
 - 28 A. We went straight we went straight to Pendembu.
 - 29 Q. And what happened once you arrived in Pendembu?

- 1 A. When we got to Pendembu, Foday Sankoh called a meeting
- 2 which they referred to as a forum.
- 3 Q. Who came to this meeting?
- 4 A. When we arrived, it took three days before he called this
- 11:26:11 5 meeting. At this meeting at this meeting Morris Kallon and
 - 6 others were there, Issa and others, Mosquito. At this meeting he
 - 7 said that we had been fighting for a long time. He said this was
 - 8 the time that we were to capture Kono. He introduced Mosquito at
 - 9 this meeting to the others who did not know Mosquito. He said
- 11:26:47 10 Mosquito he had heard that Mosquito was a strong fighter. This
 - 11 Kono mission, Mosquito was to be in charge. Mosquito was to be
 - 12 the commander of this Kono mission; the mission commander to
 - 13 capture Kono.
 - 14 Q. You said that Issa was at this meeting. Who was Issa?
- 11:27:10 15 A. Issa was one of the vanguards.
 - 16 Q. Do you know his last name?
 - 17 A. Issa Sesay.
 - 18 Q. Did Foday Sankoh explain why you should capture Kono at
 - 19 this meeting?
- 11:27:28 20 A. Yes, he said that we should capture Kono to get more
 - 21 diamonds so that we will be able to get more arms and ammunition
 - 22 to continue the war.
 - 23 Q. So what happened after this meeting?
 - 24 A. After the meeting Mosquito Foday Sankoh brought the
- 11:27:57 25 manpower together and Mosquito went to the place called Kono
 - 26 bypass at Mende Buima and that was where he was based. It was
 - 27 from there that he was to leave and go and run the mission.
 - 28 MR GRIFFITHS: I hesitate to interrupt, your Honour, but
 - 29 I wonder if it can be clarified whether the witness was actually

- 1 at this forum called by Foday Sankoh because I am not sure from
- 2 the transcript that that has been clarified.
- 3 PRESIDING JUDGE: Yes, Ms Hollis, there is that point of
- 4 clarification and I have just been alerted that we are almost up
- 11:28:35 5 to time.
 - 6 MS HOLLIS: Is there time for that clarification?
 - 7 PRESIDING JUDGE: I think so.
 - 8 MS HOLLIS:
 - 9 Q. Mr Witness, how did you know about this meeting?
- 11:28:43 10 A. I was with him. Because I was a bodyguard, wherever Foday
 - 11 Sankoh was I was with him.
 - 12 PRESIDING JUDGE: Thank you, Ms Hollis. Mr Witness, this
 - is now the time when we normally take the mid-morning adjournment
 - 14 for half an hour. We are going to have a break and we will
- 11:28:59 15 resume court at 12 o'clock. Please adjourn court until 12.
 - 16 [Break taken at 11.30 a.m.]
 - 17 [Upon resuming at 12.00 p.m.]
 - PRESIDING JUDGE: Ms Hollis, when you're ready, please
 - 19 proceed.
- 12:00:12 20 MS HOLLIS: Thank you, Madam President:
 - 21 Q. Mr Witness, before the break you were explaining about a
 - 22 meeting where Foday Sankoh talked about taking Kono for access to
 - 23 the diamonds and that Sam Bockarie was placed in charge and that
 - 24 he made his camp at Mende Buima. Now, you said that he was given
- 12:00:53 25 manpower for this operation. If you know, could you tell us the
 - ages of the manpower that went with Sam Bockarie on this
 - 27 operation?
 - 28 A. The age groups that Sam Bockarie received for that mission
 - 29 started from 14 years of age upwards.

- 1 Q. And could you tell us the gender of these people that were
- 2 sent with Sam Bockarie?
- 3 A. Men were among them, women were among.
- 4 Q. Now you yourself, where were you when Sam Bockarie took the
- 12:01:38 5 manpower for this operation?
 - 6 A. I was with Foday Sankoh in Pendembu.
 - 7 Q. And could you tell us what happened after Sam Bockarie
 - 8 established his base at Mende Buima?
 - 9 A. Sam Bockarie attacked Gandorhun. He attacked Gandorhun
- 12:02:08 10 first, but he was unsuccessful in his first attack, but later he
 - 11 succeeded and he sent a message to Foday Sankoh that he had
 - 12 captured Gandorhun and that they were now advancing to Koidu
 - 13 Town.
 - 14 Q. What kind of message did he send to Foday Sankoh?
- 12:02:32 15 A. After he had sent the message that he had captured
 - 16 Gandorhun and that he was now advancing to Koidu, that was the
 - 17 message that he sent to Foday Sankoh; that he had advanced to
 - 18 Koi du.
 - 19 Q. And what was the form of this communication?
- 12:03:01 20 A. It was through it was a message that they brought, a
 - 21 radio message. It was on the radio.
 - 22 Q. And what happened after he had given the report that he had
 - 23 captured Gandorhun and advanced to Koi du?
 - 24 A. Well, after capturing Koidu, Foday Sankoh sent a message to
- 12:03:43 25 Mosquito that he wanted to go to Koidu, but later Mosquito sent
 - another message saying that he shouldn't go to Koidu that moment,
 - 27 he said because he wanted to push the enemies far off from Koidu
 - 28 before he could send to him for him to go, but Foday Sankoh did
 - 29 not listen to Mosquito, so he went there.

- 1 Q. Foday Sankoh went where?
- 2 A. Foday Sankoh went to Koi du Town.
- 3 Q. And when Mosquito said he wanted to push the enemy far off
- 4 from Koidu Town, do you know what he meant?
- 12:04:37 5 A. He said that he wanted to push the enemies towards Sewafe
 - 6 area before allowing Foday Sankoh to come.
 - 7 Q. Now, you have named quite a few places. You've named Mende
 - 8 Buima. Can you tell us what district Mende Buima is in?
 - 9 A. Mende Buima is in Kailahun District.
- 12:05:08 10 Q. You mentioned Gandorhun. What district is that in?
 - 11 A. Well, Gandorhun, I can't recall the district in which it
 - 12 is.
 - 13 Q. And you mentioned Sewafe. Can you tell us what district
 - 14 Sewafe is in?
- 12:05:40 15 A. Sewafe is in Kono District.
 - 16 Q. When Foday Sankoh went to Koidu Town, who went with him?
 - 17 A. We, the bodyguards, went with him.
 - 18 Q. Now these enemies that Sam Bockarie was talking about at
 - 19 this time, who were the enemies that he was fighting?
- 12:06:10 20 A. Well, at that time it was in 1992, it was the NPRC soldiers
 - 21 that they were fighting against at that time.
 - 22 Q. What happened when Foday Sankoh went to Koi du Town?
 - 23 A. When Foday Sankoh got to Koidu Town, Mosquito later came to
 - 24 Foday Sankoh, but when he got there it did not take long that we
- 12:06:48 25 heard that the soldiers were advancing from the Sewafe side, so
 - 26 Mosquito moved there to go and put the situation under control.
 - 27 So he came back later to Foday Sankoh and explained to him that
 - 28 he has put the situation under control.
 - 29 Q. When you say the soldiers were advancing from Sewafe, what

- 1 soldiers are these?
- 2 A. Those were the government soldiers who were under the NPRC
- 3 government.
- 4 Q. When Mosquito came back and told Foday Sankoh that he had
- 12:07:25 5 put the situation under control, what else happened at that time?
 - 6 A. Well, when Mosquito came to Foday Sankoh he told him that,
 - 7 "Pa Sankoh, we have put the situation under control, but that we
 - 8 have not yet started mining", and I saw him give Pa Sankoh a
 - 9 parcel and they were --
- 12:07:57 10 THE INTERPRETER: Your Honours, could the witness slow down
 - and repeat the last bit of that. The cup, I don't know what cup
 - 12 he referred to.
 - 13 PRESIDING JUDGE: Please pause, Mr Witness. The
 - 14 interpreter is having trouble keeping up with you, so can you
- 12:08:09 15 speak a little slower and also clarify for the interpreter when
 - 16 you're talking about a cup, what you're referring to. The
 - 17 interpreter does not understand.
 - THE WITNESS: Those were film cups, Kodak film cups. The
 - 19 films that they use in cameras to snap with. A small cup.
- 12:08:41 20 MS HOLLIS:
 - 21 Q. Did you yourself see what was in this small cups like Kodak
 - 22 film cups?
 - 23 A. Yes, I saw Mosquito give diamonds to Pa Sankoh and when he
 - 24 displayed them on the table, Pa Sankoh checked them and he sorted
- 12:09:03 25 them out and the bigger ones that were inside were about 15 and
 - the sizable ones were five. There were small ones, but he did
 - 27 not take those ones and he told Pa Sankoh that, "We have not yet
 - 28 started mining, but we got these from the operation."
 - 29 Q. Did he explain how he got those from the operation?

- 1 A. He said, "We got these when we attacked the town and when
- 2 we searched civilians we took these diamonds from them, or when
- 3 we took their houses, we checked there and we got these diamonds
- 4 from there."
- 12:09:54 5 Q. Now, what happened after Sam Bockarie came back and gave
 - 6 these diamonds to Foday Sankoh?
 - 7 A. Later Sam Bockarie went. He came another time and he
 - 8 brought diamonds, but by then, when he brought those diamonds,
 - 9 the enemies were advancing so he advised Pa Sankoh to go back to
- 12:10:27 10 Pendembu, so Pa Sankoh went.
 - 11 Q. Now, you say that Sam Bockarie went and then later he
 - 12 brought back diamonds. Where did Sam Bockarie go?
 - 13 A. He went back to the front line.
 - 14 Q. And these diamonds that he brought back, do you know the
- 12:10:51 15 quantity of these diamonds?
 - 16 A. Well, at that particular time Pa Sankoh did not check them.
 - 17 He just handed them over to Pa Sankoh and they were plenty, but
 - 18 because the enemies were advancing he was unable to check them,
 - 19 so he returned.
- 12:11:14 20 Q. When you say "he returned", who are you referring to?
 - 21 A. Mosqui to returned.
 - 22 Q. Returned where?
 - 23 A. He returned to the front line, but before he went back he
 - 24 told Pa Sankoh to go back to Pendembu because the enemies were
- 12:11:36 25 advancing, so Pa Sankoh went.
 - 26 Q. Now, just to be clear, these diamonds that Sam Bockarie
 - 27 brought back, what did he do with the diamonds?
 - 28 A. He handed all the diamonds over to Pa Sankoh.
 - 29 Q. The materials, the arms and ammunition that Sam Bockarie

- 1 was using on this operation, where did those arms and ammunition
- 2 come from?
- 3 A. The arms and ammunition were coming from Liberia, Gbarnga.
- 4 Q. When Foday Sankoh was in Koidu, how many times did Sam
- 12:12:22 5 Bockarie give him diamonds?
 - 6 A. I saw him give diamonds to Foday Sankoh two times.
 - 7 Q. Now, you say that Sam Bockarie warned Foday Sankoh and
 - 8 Foday Sankoh went. Where did he go?
 - 9 A. Sam Bockarie advised Foday Sankoh not to come to Koidu Town
- 12:12:49 10 at that time, but Foday Sankoh did not take his advice, so he
 - 11 came.
 - 12 Q. And you said that when Foday Sankoh was in Koidu Town Sam
 - 13 Bockarie warned him that the enemy was advancing and then you
 - 14 said Foday Sankoh went. Where did he go?
- 12:13:09 15 A. He went back to Pendembu Town.
 - 16 Q. And what did you do?
 - 17 A. Before Foday Sankoh left he gave me an instruction that I
 - 18 should stay and control the other things that were given to him,
 - 19 like the rice and some other items that the soldiers gave to him,
- 12:13:46 20 and he instructed me that I should stay and later take them over
 - 21 for him. So I stayed in Koidu Town.
 - 22 Q. These items that the soldiers gave to him, do you know
 - where the soldiers got these items?
 - 24 A. Mosquito said that they got those items when they captured
- 12:14:15 25 Koidu Town. He said they got them from the shops that were in
 - 26 Koidu Town. When they broke into the shops they got them and
 - when they broke into people's houses they got them there too.
 - 28 Q. So to be clear, you're saying they broke into shops, they
 - 29 broke into people's houses. Did they pay for these items?

- 1 A. No, they did not pay for them because when they captured
- the places the shops were closed, so they broke into them and
- 3 took those items.
- 4 Q. How long did you stay in Koidu Town after Foday Sankoh
- 12:14:56 5 **left?**
 - 6 A. I was there for some time and later, when the enemies
 - 7 advanced, we all moved from there and went to Gandorhun.
 - 8 Q. Now, during the time you were in Koidu after Foday Sankoh
 - 9 left, did you receive any communications from Foday Sankoh?
- 12:15:28 10 A. Whilst we were in Gandorhun, at one time Mosquito said that
 - 11 Foday Sankoh had sent a message to him that he had received an
 - 12 urgent message from his brother Charles that he was supposed to
 - 13 go and meet him in Gbarnga.
 - 14 Q. You say this is while you were in Gandorhun. How long were
- 12:15:56 15 you in Gandorhun?
 - 16 A. We spent some time in Gandorhun.
 - 17 Q. Now, what year are we talking about?
 - 18 A. Here I am talking about 1992.
 - 19 Q. And do you have any recollection as to what part of 1992
- 12:16:30 20 this was when you were in Gandorhun?
 - 21 A. This happened at the time we were approaching the end of
 - 22 ' 92.
 - 23 Q. While you were in Gandorhun did you receive any other
 - 24 communications from Foday Sankoh?
- 12:17:04 25 A. Yes. Whilst we were there another message came. Foday
 - 26 Sankoh sent a message to Mosquito that he has arrived in Gbarnga
 - and he said his brother Charles has given him arms and
 - ammunition, but he said the ULIMO had blocked the road between
 - 29 Voinjama and Kolahun, but he said his brother told him not to be

- 1 worried, that he was going to give him manpower to come and clear
- 2 the way and that he was going to come and meet us back, so that
- 3 was the message that he sent.
- 4 Q. And did he tell you where he was going to meet you?
- 12:18:02 5 A. I did not get that one clear.
 - 6 Q. Did he tell you in what location he was going to meet you?
 - 7 A. I did not get that one clear. To go and meet whom? Me?
 - 8 Who? Where?
 - 9 Q. Let me try it again then. You said that Foday Sankoh sent
- 12:18:25 10 a communication and he said he was in Gbarnga, "He was going to
 - 11 come and meet us". So my question is where was Foday Sankoh
 - 12 going to come to meet you?
 - 13 A. He said his brother Charles has given him all the arms and
 - 14 ammunition that he needed, but that the ULIMO had blocked the
- 12:18:57 15 road, but he said they shouldn't be worried, he was going to give
 - 16 him manpower to come and clear the way for him to join us back in
 - 17 Si erra Leone.
 - 18 Q. Now, you said you were in Gandorhun for some time. Why did
 - 19 you I eave?
- 12:19:16 20 A. Well, when Foday Sankoh arrived in Kailahun he sent for
 - 21 Mosquito and whilst Mosquito was going was answering to his
 - 22 call, I joined him for us to go together.
 - 23 Q. Where was Foday Sankoh in Kailahun?
 - 24 A. He was in Kailahun Town.
- 12:19:42 25 Q. When you joined Mosquito to go meet Foday Sankoh, what did
 - 26 you do with these items that had been taken from shops and homes?
 - 27 A. I took civilians to carry the loads to Kailahun.
 - 28 Q. And how did you get these civilians to carry the loads?
 - 29 A. I got the civilians around Gandorhun Town and the

- 1 surrounding villages.
- 2 Q. And were these people volunteers to carry these loads?
- 3 A. No, they did not volunteer. We just captured them.
- 4 Q. And while we're talking about that, how did you move those
- 12:20:40 5 items from Koidu Town to Gandorhun?
 - 6 A. Whilst we were moving from Koidu to Gandorhun we used
 - 7 vehicles, but it got to a time that the roads were not good and
 - 8 so that was the reason why we decided to capture civilians to
 - 9 carry the loads for us to Kailahun to meet Foday Sankoh there.
- 12:21:09 10 Q. If you remember, how long did the RUF hold Koidu?
 - 11 A. That was just around the end of '92 that we were pushed out
 - 12 of there.
 - 13 Q. And do you remember for what period of time the RUF
 - 14 controlled Koidu?
- 12:21:45 15 A. I can't recall that again.
 - 16 Q. Now, what happened once you arrived in Kailahun Town?
 - 17 A. When we arrived in Kailahun, Foday Sankoh called a meeting.
 - 18 At this meeting there was Ajami, who was the MP commander, and
 - 19 Mosquito was there and other people were there, and during this
- 12:22:17 20 meeting he said that he went and met his brother Charles and in
 - 21 this meeting too he said the diamonds that Mosquito handed over
 - 22 to him, he said he gave him some for him to keep to keep them
 - 23 for him.
 - 24 PRESIDING JUDGE: Who is the "he", Ms Hollis?
- 12:22:46 **25** MS HOLLIS:
 - 26 Q. So who gave some diamonds to whom?
 - 27 A. Foday Sankoh gave the diamonds to Charles Taylor. That was
 - 28 what Foday Sankoh told us during the meeting.
 - 29 Q. And did Foday Sankoh explain to Charles Taylor why he was

- 1 giving him the diamonds?
- 2 A. He said he gave him for him to give a little more arms and
- ammunitions for him to bring them back.
- 4 Q. When Foday Sankoh was in Kailahun, to your knowledge did he
- 12:23:24 5 bring anything back with him from Gbarnga?
 - 6 A. Yes, he brought a good amount of ammunition, with rice,
 - 7 salt, he brought them.
 - 8 Q. And do you recall the types of ammunition that he brought
 - 9 back?
- 12:23:50 10 A. He brought RPGs, RPG boxes, AK rounds, GPMG and some others
 - 11 that I cannot recall now.
 - 12 Q. And what did he do with this ammunition that he brought
 - 13 back from Gbarnga?
 - 14 A. He gave them to the G4 and they kept them in the warehouse,
- 12:24:23 15 and he was Joseph Brown and Later they were distributed to the
 - 16 front lines.
 - 17 Q. If you know, at the time of this meeting in Kailahun Town
 - 18 with Foday Sankoh how many people were in the RUF?
 - 19 A. They were more than 10,000 people.
- 12:24:55 20 Q. Now, you've told the Court about ULIMO cutting the road for
 - 21 a period of time in Liberia. First of all, who is ULIMO?
 - 22 A. According to what we heard, ULIMO were fighting under
 - 23 Alhaji Kromah. Alhaji Kromah was the leader for the leader of
 - 24 ULIMO at that time.
- 12:25:26 25 Q. Did ULIMO ever block the route in Liberia again after that?
 - 26 A. Yes, that later happened in 1993. ULIMO blocked the road,
 - 27 they captured Kolahun, Foya, Voinjama. ULIMO captured all of
 - 28 those areas.
 - 29 Q. When they captured these areas in 1993, what access, if

- 1 any, did the RUF have to Charles Taylor?
- 2 A. Well after ULIMO had captured all of those areas, Foday
- 3 Sankoh called to Gbarnga and told his brother Charles and
- 4 Charles Taylor suggested to him that he should send some soldiers
- 12:26:33 5 from Sierra Leone to go to him so that he will be able to give
 - 6 him some arms and ammunition. So Foday Sankoh selected some
 - 7 Liberian soldiers who were with him, including Morris Kallon, for
 - 8 them to go.
 - 9 Q. And did Morris Kallon and these others go to
- 12:26:56 10 Charles Taylor?
 - 11 A. Well they went, but later we understood that they did not
 - 12 arrive there at all.
 - 13 Q. And how did you come to understand that they did not arrive
 - 14 there?
- 12:27:11 15 A. When they went after a week Foday Sankoh communicated with
 - 16 Gbarnga, but they told him that they have not been able to see
 - 17 them. That was how I came to know.
 - 18 Q. To your recollection, for what period of time did ULIMO cut
 - 19 off the access between the RUF and Charles Taylor?
- 12:27:43 20 A. It was in 1993.
 - 21 Q. Until when?
 - 22 A. Until 1998 again.
 - 23 Q. Now when the access was once again open between the RUF and
 - 24 Charles Taylor, where were you?
- 12:28:14 25 A. At that time I was in Kailahun District. I was based in a
 - 26 town called Balahun.
 - 27 Q. During this time that the access across the border was cut
 - off, was there any contact between the RUF and Charles Taylor?
 - 29 A. I did not get that clearly.

- 1 Q. During the time that the border was cut off between the RUF
- 2 and Charles Taylor, was there any contact between the RUF and
- 3 Charles Taylor?
- 4 A. Since the time ULIMO captured the road, we did not have
- 12:29:06 5 road contact. We only had contact through communication.
 - 6 Q. What type of communication?
 - 7 A. Radio communication.
 - 8 Q. Were you present for any of these communications between
 - 9 the RUF and Charles Taylor?
- 12:29:33 10 A. Yes, when the communication was taking place they did not
 - 11 talk directly to Charles Taylor. Sometimes Foday Sankoh would
 - 12 communicate with the operator that was with Charles Taylor that
 - 13 was called Butterfly. It was through him that the communication
 - 14 went on.
- 12:29:50 15 Q. And were you yourself present for any of these
 - 16 communications?
 - 17 A. Yes.
 - 18 Q. These communications that you were present for, what was
 - 19 the communication about?
- 12:30:08 20 A. At that time he was trying to tell his brother Charles the
 - 21 prevailing conditions in the RUF controlled zones.
 - 22 Q. And, if you know, what was Charles Taylor's response to
 - 23 this communication?
 - 24 A. Well, at that time Charles Taylor was not talking directly
- 12:30:39 25 to Foday Sankoh. He would tell his operator the message and the
 - operator in return would send a message to Foday Sankoh.
 - 27 THE INTERPRETER: Sorry, your Honours, the message to
 - 28 Charles Taylor. Correction.
 - 29 MR GRIFFITHS: Your Honour, I hesitate to interrupt, but I

- 1 note that to date we've been talking about a time frame from 1993
- 2 to 1998 and it's during that period that my learned friend has
- 3 obtained from the witness evidence of communications between
- 4 Charles Taylor and Foday Sankoh, but could we have some
- 12:31:25 5 clarification on that, please, given that we know that for some
 - 6 of that time Foday Sankoh was actually in prison.
 - 7 PRESIDING JUDGE: I'm sure counsel will come to it,
 - 8 Mr Griffiths. Ms Hollis, you've heard counsel.
 - 9 MS HOLLIS: Your Honour, just a point. I appreciate
- 12:31:46 10 counsel's comments. However I would like to point out that, if
 - 11 at the end of direct examination there are details counsel wants,
 - 12 that's what cross-examination is for.
 - 13 MR GRIFFITHS: I'm very much aware of that, your Honour.
 - 14 PRESIDING JUDGE: So am I, but I haven't commented on it.
- 12:32:08 15 MS HOLLIS:
 - 16 Q. Now, let's clear up what we were talking about. You said
 - 17 you were present when Foday Sankoh would send messages to Charles
 - 18 Taylor. Were you ever present when Charles Taylor sent messages
 - 19 back to Foday Sankoh?
- 12:32:24 20 A. Yes. When Foday Sankoh was giving the message to the
 - 21 operators, who in turn sent them, he explained the prevailing
 - 22 conditions in the RUF and that we were now suffering and we were
 - 23 not getting support from him and at that time whilst we were
 - 24 advancing the areas that we got that we got to, those were the
- 12:32:54 25 messages that he sent. And he said, "Okay, things happen that
 - 26 way because that is a guerilla warfare."
 - 27 Q. Who said "things happen that way because that is guerilla
 - 28 warfare"?
 - 29 A. That was the message that came from Charles Taylor.

- 1 Q. Now, you've talked about communications over a long period
- of time. Can you tell us the years in which these communications
- 3 occurred that you knew about?
- 4 A. From 1994 to '96.
- 12:33:46 5 Q. Now, what happened with the RUF after the border was cut
 - 6 off between the RUF and Charles Taylor?
 - 7 A. When they had cut us off, when Foday Sankoh asked Morris
 - 8 Kallon to go with the other commanders he said at that time now
 - 9 he was now planning the war for us to launch the operations
- 12:34:21 10 against the enemies and so he sat down again and
 - 11 arranged/organised the operations with the commanders.
 - 12 PRESIDING JUDGE: Ms Hollis, just before you proceed on, to
 - 13 revert back to a previous answer, "He said, 'Okay, things happen
 - 14 that way because of guerilla warfare.'" Who said that? This is
- 12:34:44 15 page 66, line 25 and thereafter.
 - 16 THE WITNESS: That was the message that came from
 - 17 Charles Taylor in Liberia.
 - 18 PRESIDING JUDGE: Thank you.
 - 19 MS HOLLIS:
- 12:35:03 20 Q. When Foday Sankoh sat down and organised these operations
 - 21 now, what kind of operations did he organise?
 - 22 A. He reorganised that since the enemies have come to our area
 - 23 we should forget about them there and then we should go and
 - 24 launch another operation. So he called on Mohamed Tarawalli
- 12:35:28 25 Zino, Mosquito, Superman, Issa Sesay and he tried to organise
 - 26 them and said, "You, Mosquito, I will be in your group. We will
 - 27 take the operation to the Nomo Faiama area and" --
 - 28 THE INTERPRETER: Your Honours, could the witness slow
 - 29 down. Could he slow down and repeat his last bit.

- 1 PRESIDING JUDGE: You've speeded up, Mr Witness. You're
- 2 going to a little too quick for the interpreter. Please speak
- 3 more slowly and pick up your answer from the point where you
- 4 said, "We will take the operation to the Nomo Faiama area."
- 12:36:15 5 Continue from there, please.
 - 6 THE WITNESS: Pa Sankoh said we will take the operation to
 - 7 Nomo Faiama whilst Issa Sesay will stay in Kailahun and Mohamed
 - 8 Tarawalli will go to the Kangari Hills area. So that was how he
 - 9 planned the mission.
- 12:36:37 10 MS HOLLIS:
 - 11 Q. Now, where were you in Sierra Leone when Foday Sankoh came
 - 12 up with this mission?
 - 13 A. Well, I was with Foday Sankoh. At that time we had been
 - 14 pushed to the border. We were close to the Liberian border,
- 12:36:56 15 around the Koindu area. That was where we were when he made that
 - 16 pl an.
 - 17 Q. And who was in this area near Koindu, near the border, when
 - 18 Foday Sankoh made this plan?
 - 19 A. At that time it was the NPRC soldiers and on the Liberian
- 12:37:30 20 side they had the ULI MO.
 - 21 Q. And at this time near Koindu, near the border, what RUF
 - 22 commanders were there with Foday Sankoh?
 - 23 A. Issa Sesay was there, Morris Kallon was there, Superman was
 - 24 there, Mohamed Tarawalli was there and some others that I can't
- 12:38:02 **25** recall now.
 - 26 Q. You said that Morris Kallon was there. Was this the Morris
 - 27 Kallon that had been sent to Liberia?
 - 28 A. That is not the one.
 - 29 Q. This Morris Kallon you're talking about, who is this?

- 1 A. There was another artillery boy who was called Morris
- 2 Kallon. He was also a commander.
- 3 Q. So which of these Morris Kallons was sent to Liberia?
- 4 A. It was the vanguard Morris Kallon who went to Liberia.
- 12:38:58 5 Q. And while you're in the border near Koindu and Foday Sankoh
 - 6 makes this operation, which Morris Kallon was there?
 - 7 A. This Morris Kallon was also a strong fighter. He was the
 - 8 artillery commander.
 - 9 Q. You mentioned a Mohamed Tarawalli and you said also Zino.
- 12:39:26 10 Who was that?
 - 11 A. He's the same person. Mohamed Tarawalli's nickname was
 - 12 Zi no.
 - 13 Q. And who was Mohamed Tarawalli?
 - 14 A. Foday Sankoh told us that they and Mohamed Tarawalli took
- 12:39:52 15 their training in Libya and that he was the next in charge to
 - 16 him.
 - 17 Q. You also mentioned Superman. Who was Superman?
 - 18 A. Superman was an NPFL soldier, but later he joined the RUF.
 - 19 Q. Did you know him by any other name?
- 12:40:18 20 A. They used to call him Denis Mingo.
 - 21 Q. Now this attack, this operation on Nomo Faiama. Do you
 - 22 know what district Nomo Faiama is in?
 - 23 A. It's under Kenema District.
 - 24 Q. And who went on this operation with Foday Sankoh?
- 12:40:51 25 A. Mosquito was the commander who went with the operation.
 - 26 Q. And you testified that Issa Sesay would remain in Kailahun
 - 27 District. Who was with Issa Sesay in Kailahun District?
 - 28 A. Those were the other commanders who were to stay with him.
 - 29 I can't recall their names.

- 1 Q. And what did you do when Foday Sankoh created this
- 2 operation?
- 3 A. I joined Foday Sankoh. Myself, Foday Sankoh, Mosquito, all
- 4 of us went on the Nomo Faiama mission.
- 12:41:46 5 Q. And was that Nomo Faiama mission successful?
 - 6 A. Yes, we captured there.
 - 7 Q. And what did you do after you captured Nomo Faiama?
 - 8 A. When we captured Nomo Faiama we advanced to the Blama
 - 9 Highway and that was where we were when Pa Sankoh opened the
- 12:42:16 10 place that was referred to as Zogoda.
 - 11 Q. This Blama Highway that you're talking about, in what
 - 12 district is that located?
 - 13 A. I can't just recall now, but the Blama Highway is close to
 - 14 Kenema.
- 12:42:43 15 Q. And when you say Kenema, what Kenema are you talking about?
 - 16 A. Kenema Town. It's not far from Kenema Town.
 - 17 Q. You said that Foday Sankoh established Zogoda. Where was
 - 18 Zogoda Located?
 - 19 A. Zogoda was close to a town that was called Bandawa. That
- 12:43:15 20 was where Zogoda was. It was in the bush and that was the place
 - 21 where Foday Sankoh was based. We called the place Zogoda.
 - 22 Q. Do you know what district that is in?
 - 23 A. No.
 - 24 Q. Who was at Zogoda when Foday Sankoh opened the base there?
- 12:43:46 25 A. Foday Sankoh himself was there and those of us, the Black
 - 26 Guards, who were with him and whilst the fighting was going on,
 - any wounded soldier that they had at the front was brought there.
 - We were those who were staying there.
 - 29 Q. So what was Zogoda base?

- 1 A. I did not get that one clearly.
- 2 Q. The base at Zogoda, what was located at that base?
- 3 A. Foday Sankoh was based there together with his bodyguards
- 4 and wounded soldiers.
- 12:44:37 5 Q. Now, you earlier mentioned that Foday Sankoh said that you
 - 6 would open an area in Kangari Hills. Who went to Kangari Hills?
 - 7 A. It was commander Zino, Mohamed Tarawalli. He went and
 - 8 established Kangari Hills.
 - 9 JUDGE SEBUTINDE: Ms Hollis, sorry to interrupt. It seems
- 12:45:07 10 we've now left Zogoda. I just wondered if we could have a time
 - 11 frame for the Nomo Faiama mission and the opening of Zogoda,
 - 12 pl ease.
 - 13 MS HOLLIS:
 - 14 Q. Now, you talked about Foday Sankoh coming up with this
- 12:45:24 15 operation and there was going to be an attack on Nomo Faiama. Do
 - 16 you remember when that happened?
 - 17 A. Yes. We entered Nomo Faiama in 1993, December, and we
 - 18 established Zogoda in 1994.
 - 19 Q. And do you remember when Mohamed Tarawalli went to Kangari
- 12:45:57 **20** Hills?
 - 21 A. Mohamed Tarawalli also went to the Kangari Hills in 1993.
 - 22 Q. You said you attacked Nomo Faiama in December 1993, so in
 - 23 what month did Mohamed Tarawalli go to Kangari Hills?
 - 24 A. Well, I can't recall the month, but it was in 1993 that he
- 12:46:28 **25** went.
 - 26 Q. And did he go to Kangari Hills before you attacked Nomo
 - 27 Fai ama?
 - 28 A. Yes, he first got there.
 - 29 Q. What were your duties while you were at Zogoda?

- 1 A. Well, whilst we were at Zogoda we were securities to Foday
- 2 Sankoh. He used to send us to the front lines to get information
- 3 and bring back to him.
- 4 Q. How long were you based at Zogoda?
- 12:47:16 5 A. We were there in '94 when Foday Sankoh sent a message to
 - 6 commander Zino to come and he told him that he had a mission for
 - 7 him to attack Rutile and the western jungle. So we were there
 - 8 when commander Zino came, together with Superman. So Foday
 - 9 Sankoh gave him the mission to go and open the areas that I have
- 12:47:50 10 spoken about.
 - 11 Q. So Foday Sankoh sent a message to Zino and told Zino to
 - 12 come to Zogoda. Where was Mohamed Tarawalli, Zino, when Foday
 - 13 Sankoh sent him that message?
 - 14 A. At that time Mohamed Tarawalli was at Kangari Hills. He
- 12:48:23 15 had already established the base. So he told Mohamed Tarawalli
 - 16 to move from there to come and join him at Zogoda.
 - 17 Q. And you said that Zino came to Zogoda with Superman. Where
 - 18 was Superman coming from?
 - 19 A. Superman was with them. They all came.
- 12:48:46 20 Q. So at that time Superman was based where?
 - 21 A. He and commander Zino went to Kangari Hills. So all of
 - them came.
 - 23 Q. You said that Foday Sankoh wanted them to go on a mission
 - to go and open the areas you talked about and you talked about
- 12:49:10 25 western jungle. Where was this area?
 - 26 A. Western jungle was close to Freetown, because where we were
 - 27 it was around the Rotifunk area. We were in the bush, but we
 - 28 referred to the place as the Western Area because it was close to
 - 29 Freetown.

- 1 Q. And how long were you in the Western Area?
- 2 A. Well, we were there until '97 when the NPRC took over.
- 3 Q. And who took over in 1997?
- 4 A. That was the AFRC.
- 12:50:22 5 Q. And while you were in the Western Area, what were your
 - 6 duties?
 - 7 A. Whilst we were in the western jungle, we used to attack and
 - 8 we used to set ambushes on the highway.
 - 9 Q. While you were in the Western Area, did you receive any
- 12:50:49 10 communications from Foday Sankoh?
 - 11 A. Yes.
 - 12 Q. And what communications did you receive?
 - 13 A. Whilst we were in the western jungle, communication came
 - 14 from Foday Sankoh that and that happened in 1996 and that was
- 12:51:19 15 when he was going for the Abidjan Peace Accord. He did say that
 - 16 he was going for the Abidjan Peace Accord and he said that
 - 17 Mohamed Tarawalli should go back to Zogoda and he said I should
 - 18 go. But by then I had a problem with my foot, I had a wound, so
 - 19 I did not go and so I stayed at the western jungle. So Mohamed
- 12:51:42 20 Tarawalli went and met Foday Sankoh at Zogoda, so Mohamed
 - 21 Tarawalli stayed in charge whilst Foday Sankoh went for the
 - 22 accord.
 - 23 Q. Mohamed Tarawalli was in charge of what?
 - 24 A. Foday Sankoh said Mohamed Tarawalli should go to Zogoda
- 12:52:10 25 because that was the headquarters. He should go and stay in
 - 26 command until he goes for the Abidjan Peace Accord.
 - 27 Q. And who was --
 - JUDGE SEBUTINDE: Ms Hollis, sorry to interrupt again, but
 - 29 did the witness say whilst they were in the western jungle he and

- 1 others set ambushes to loot ammunition? Is that what he said?
- 2 MS HOLLIS: That's what I understood, but I'll ask him.
- 3 JUDGE SEBUTINDE: Because that's not in the transcript.
- 4 MS HOLLIS:
- 12:52:42 5 Q. Mr Witness, just a point of clarification. You said that
 - 6 when you were in the western jungle you would set ambushes. Can
 - 7 you tell us why you set those ambushes?
 - 8 A. We used to set ambushes to get food and arms and
 - 9 ammunition. That was the reason why we used to set the ambushes.
- 12:53:04 10 Q. And from whom were you getting the food?
 - 11 A. From the ambush. The vehicles that were passing by, we
 - 12 used to set ambushes.
 - 13 Q. And what kinds of vehicles did you take food from?
 - 14 A. Civilian vehicles.
- 12:53:26 15 Q. Who were you getting the ammunition from the arms and
 - 16 ammunition? Who were you getting the arms and ammunition from?
 - 17 A. Well at that time we were setting ambushes to get arms and
 - 18 ammunition, or sometimes we will go and attack where soldiers
 - 19 were based. It was through such things that we got the arms and
- 12:53:57 **20** ammuni ti on.
 - 21 Q. So you said that Foday Sankoh left Mohamed Tarawalli in
 - 22 command, in charge. Who was he in charge of?
 - 23 A. Well, Mohamed Tarawalli was in charge of all the soldiers
 - in the RUF and he was at the headquarters at Zogoda.
- 12:54:30 25 Q. Once Mohamed Tarawalli left the western jungle to go to
 - 26 Zogoda, who was in charge of the western jungle?
 - 27 A. It was Denis Mingo Superman that stayed in charge.
 - 28 Q. When Foday Sankoh Left to go for the Abidjan peace talks,
 - 29 did you get any communications from him after he left?

- 1 A. Yes, when he went whilst he was now in Abidjan on the
- 2 accord he sent another message to the commanders saying that
- 3 before ever he will be in place to sign he will have to come and
- 4 talk to us, the soldiers, so he came.
- 12:55:30 5 Q. And he came where to talk to you in the western jungle?
 - 6 A. Well, he came. We were around the bushes around Rotifunk,
 - 7 so the helicopter that he came with landed in a town called Bauya
 - 8 close to Rotifunk. That was where it landed. So when he
 - 9 alighted we went there and he spoke to us.
- 12:56:05 10 Q. And what did he tell you when he spoke to you?
 - 11 A. He told us that he is the leader, but that we the soldiers
 - were fighting the war and so before ever he would be in place to
 - 13 sign the accord he will have to come and talk to us. So he asked
 - 14 the views of commanders and soldiers, so we too told him that he
- 12:56:36 15 should go ahead. He should go ahead and sign.
 - 16 Q. Did anyone come to Bauya with Foday Sankoh?
 - 17 A. Yes. Yes, the helicopter that he came with I saw some
 - 18 other people that he told us about. He said it was the Ivorian
 - 19 government that gave him security to come and I saw Philip Palmer
- 12:57:11 20 with him. I saw another Black Guard with him who was called
 - 21 Olangba. I saw him.
 - 22 Q. And did any of these other people talk with the soldiers?
 - 23 A. When Foday Sankoh spoke Philip Palmer and others too spoke,
 - but they were the same things that they said.
- 12:57:44 25 Q. You told the Court earlier that you remained in the western
 - 26 jungle until 1997 and you said first when the NPRC took over and
 - 27 then you said when the AFRC took over. So in 1997 who took over
 - 28 in Sierra Leone?
 - 29 A. In 1997 it was the AFRC that took over.

- 1 Q. And how did you learn about that?
- 2 A. Well I was in the western jungle and at one time I listened
- 3 to the radio, FM 99.9, where it was announced that the soldiers
- 4 had overthrown, so it was through there that I came to know and
- 12:58:44 5 that the group was called AFRC.
 - 6 Q. And what is this FM 99.9? What is that?
 - 7 A. It was a radio station that was in Freetown.
 - 8 Q. What happened after you heard that the AFRC had taken over?
 - 9 A. Later we received another instruction from Foday Sankoh
- 12:59:15 10 through the same radio FM 99.9 when Foday Sankoh was giving
 - 11 instruction to the RUF to join the brothers, that is the AFRC
 - 12 government, and that we should work together. He emphasised to
 - 13 especially the Superman's group in the Western Area.
 - 14 Q. You said, "He emphasised to especially the Superman's group
- 12:59:50 15 in the Western Area." What do you mean by that?
 - 16 A. That was because we were close to Freetown. We were to be
 - 17 the first to meet the group.
 - 18 Q. And then what happened after that?
 - 19 A. So after he had passed that instruction through the FM
- 13:00:17 20 radio, later Mosquito he was in Kailahun. Mosquito sent -
 - 21 Mosquito sent a message to Superman saying that as long as our
 - 22 leader has given the instruction to join the people, so Mosquito
 - 23 made the arrangement the communication arrangement between us
 - and the AFRC government through a radio communication.
- 13:00:50 25 Q. And how were you able to communicate with the AFRC over the
 - 26 radi o?
 - 27 A. Mosqui to gave our frequency to them. Through that they
 - 28 contacted us. So he arranged that they were to meet at the
 - 29 Rotifunk Town, the soldiers were to come there, so we too were to

- 1 come from the bush to meet them there. So that was what
- 2 happened.
- 3 Q. And when you say that is what happened, what happened?
- 4 A. We came from the bush. The AFRC, the soldiers, too came to
- 13:01:40 5 Bauya and we met there. When we met there, they took us to
 - 6 Freetown.
 - 7 Q. Now, who was it who went to Freetown?
 - 8 A. Well at first Superman organised about 75 armed men,
 - 9 including Superman. All of us went to Freetown.
- 13:02:03 10 Q. And what did you do in Freetown?
 - 11 A. Well, when we were taken to Freetown all of us were in a
 - 12 vehicle. They took us round Freetown. Later they took us to a
 - 13 radio station called the SLBS. It was there that Superman spoke.
 - 14 Superman did not talk long. From there Eldred Collins spoke to
- 13:02:34 15 the people. After that we returned to Hastings. It was at
 - 16 Hastings that we were camped.
 - 17 Q. Now, you said that Superman talked on SLBS. What did he
 - 18 say?
 - 19 A. Superman said that we were people who had been in the
- 13:02:58 20 bushes. As long as the brothers have taken over and have called
 - 21 us, nobody should be frightened. We were not going back to the
 - 22 bush. He did not talk for long. That was all he said.
 - 23 Q. You said that Eldred Collins also spoke. Who was Eldred
 - 24 Collins?
- 13:03:18 25 A. Eldred Collins was one of the RUF vanquards who took
 - training in Liberia, Camp Naama. He too was with us. He spoke.
 - 27 Q. And what was his position with you?
 - 28 A. Immediately after we had come to Freetown Superman made him
 - 29 spokesman for that group.

- 1 Q. Spokesman for what group?
- 2 A. For those of us who had come to Freetown, for Superman's
- 3 group, western jungle.
- 4 Q. And when Eldred Collins spoke on the radio, what did he
- 13:04:12 5 say?
 - 6 THE INTERPRETER: Your Honours, can he kindly repeat the
 - 7 name.
 - 8 PRESIDING JUDGE: Just a moment, Mr Witness. The
 - 9 interpreter asks that you repeat the name that you have just
- 13:04:27 10 mentioned. Maybe start your answer again, Mr Witness.
 - 11 THE WITNESS: Eldred Collins.
 - 12 MS HOLLIS:
 - 13 Q. And what did he say?
 - 14 A. He said he was trying to appeal to the civilians that those
- 13:04:53 15 of us who had been in the bush, we killed people, we killed our
 - 16 mothers and our fathers, we burnt down houses, we did all sorts
 - of bad things. He said he was asking the civilians to forgive
 - 18 us. He spoke a lot, but I can't recall everything, but he said
 - 19 that.
- 13:05:17 20 Q. And what language did he say this in?
 - 21 A. He spoke English.
 - 22 Q. You said that you were based at Hastings. How long did you
 - 23 remain based at Hastings?
 - 24 A. We were at Hastings when the ECOMOG attacked us there.
- 13:05:48 25 From there I left and went to Waterloo.
 - 26 Q. And, if you remember, how long did you stay in Hastings
 - 27 before you went to Waterloo?
 - 28 A. I cannot recall the time any more.
 - 29 Q. And what year was it that you moved to Waterloo?

- 1 A. It was in '97.
- 2 Q. And what happened while you were at Waterloo?
- 3 A. After we had withdrawn from Hastings for Waterloo, we were
- 4 there when Sam Bockarie's group came from Kailahun and they met
- 13:06:34 5 us there.
 - 6 Q. And when you say you were in Waterloo, in what area were
 - 7 you based?
 - 8 A. We were based at where they were training the soldiers.
 - 9 They called there Benguema.
- 13:07:02 10 Q. And what happened when Sam Bockarie and his group came to
 - 11 Benguema?
 - 12 A. Well, those of us who first went to Freetown and after we
 - 13 had been dislodged, that was where they met us. That was where
 - 14 they came.
- 13:07:22 15 Q. Do you recall any of the people in Sam Bockarie's group?
 - 16 A. Sam Bockarie came along with Issa Sesay and others I can't
 - 17 recall.
 - 18 Q. How long did you remain in Benguema barracks?
 - 19 A. Well, we were there after the junta when the AFRC
- 13:08:03 20 government invited Mosquito that after they would have formed the
 - 21 government they would want Mosquito to serve in the government,
 - 22 but Mosqui to said that he was not going to work with the
 - 23 government. So from there Mosqui to returned to Kenema.
 - 24 Q. And what did you do when Mosquito returned to Kenema?
- 13:08:33 25 A. I went along with him. We went together.
 - 26 Q. And what were your duties when you were with Sam Bockarie
 - 27 in Kenema?
 - 28 A. Well, at that time Mosquito knew that I was a Black Guard,
 - 29 so I was with him to keep security and to report whatever that

- 1 was taking place to him.
- 2 Q. And what happened after you went to Kenema?
- 3 A. When we got to Kenema he said that we should attack Tongo,
- 4 Tongo Field, because the Kamajors were there. So we went and
- 13:09:18 5 attacked Tongo. All of us went, together with Mosquito. We
 - 6 captured Tongo and later he returned to Kenema.
 - 7 Q. And did he tell you why he wanted to capture Tongo Field?
 - 8 A. Yes, he said because it was a diamond area. We should not
 - 9 go we should not just go and stay there, we should capture it.
- 13:09:45 10 Q. You said that Mosquito returned to Kenema. What did you
 - 11 do?
 - 12 A. I stayed in Tongo.
 - 13 Q. And what were your duties in Tongo?
 - 14 A. I was there to just so that if I got any information, I
- 13:10:12 15 was to send that information to Mosquito as security.
 - 16 Q. While you were in Tongo, what activities were going on in
 - 17 Tongo?
 - 18 A. Before Mosquito returned he appointed one person, whom they
 - 19 called Chairman, to head the diamond mining in Tongo.
- 13:10:42 20 Q. Who was this person Chairman?
 - 21 A. This Chairman was a civilian, but that was what they used
 - 22 to call him, Chairman. So after Mosquito after Mosquito and
 - 23 Eddie Kanneh had organised this mining, he was made head, that
 - any diamond that they got were to be kept by Chairman and when
- 13:11:13 25 Mosquito came they were to give them to him. But when Mosquito
 - 26 and others returned and when the mining was going on, after they
 - 27 had got some diamonds the Chairman hid. After he had escaped,
 - 28 Later Mosquito and others came back to Tongo. When they came
 - 29 back, after Chairman had escaped, Mosquito appointed another

- 1 person whom they called Mohamed Kanneh who and Eddie Kanneh
- 2 appointed one Junior Sheriff. Whatever mining that was going on,
- 3 these people were to keep the diamonds. Mohamed Kanneh was to
- 4 give the diamonds to Sam Bockarie and Junior Sheriff was to give
- 13:12:08 5 the diamonds to Eddie Kanneh. That was what used to happen.
 - 6 Q. How long were you in Tongo?
 - 7 A. I was in Tongo until I was in Tongo up to I was in
 - 8 Tongo up to the time that the junta was dislodged from Freetown.
 - 9 So they attacked us there too.
- 13:12:57 10 PRESIDING JUDGE: Ms Hollis, Mohamed Kanneh and Eddie
 - 11 Kanneh, are they different or the same person?
 - MS HOLLIS:
 - 13 Q. Mr Witness, you talked about Mohamed Kanneh and who was he?
 - 14 A. Mohamed Kanneh was a security to Sam Bockarie, so he
- 13:13:19 15 appointed him to become someone who was to receive the diamonds
 - 16 from the miners. So whenever Sam Bockarie came, he was to be the
 - 17 one who would hand over the diamonds to Sam Bockarie. Eddie
 - 18 Kanneh was a big man in the AFRC government. He was assigned to
 - 19 Kenema.
- 13:13:43 20 Q. Do you know what Eddie Kanneh's job was in Kenema?
 - 21 A. Eddie Kanneh, I understood, was secretary east in Kenema.
 - 22 So that was where he was.
 - 23 Q. Now, during the time you were in Tongo Field was mining
 - 24 going on that entire time?
- 13:14:19 25 A. Yes, mining was going on.
 - 26 Q. Who was actually doing the mining?
 - 27 A. The mining soldiers were mining and civilians as well
 - were mining.
 - 29 Q. And these civilians that were mining, how is it that they

- 1 were mining?
- 2 A. Well, the civilians, they were mining for soldiers. For
- 3 instance, they were saying a government mining, so they would
- 4 take the civilians to do this mining.
- 13:15:08 5 Q. And tell us what was this government mining?
 - 6 A. This government mining, the diamonds that they called the
 - 7 government mining, whatever diamonds they got from there went
 - 8 straight to Sam Bockarie because he was the head. That was why
 - 9 they called it the government mining.
- 13:15:33 10 Q. Now, you mentioned that Eddie Kanneh was there as well.
 - 11 Did any diamonds go to Eddie Kanneh, to your knowledge?
 - 12 A. Well, Mohamed Kanneh too got diamonds to be given to Eddie
 - 13 Kanneh, but I was never present when he gave diamonds to Eddie
 - 14 Kanneh. It was only Mohamed Kanneh that I saw giving diamonds to
- 13:16:03 15 Mosqui to.
 - 16 Q. During the time that you were there do you remember the
 - 17 quantity of diamonds that Mohamed gave to Mosquito?
 - 18 A. It happened many times. I can't recall the number.
 - 19 Q. You said that civilians did the government mining. Where
- 13:16:28 20 did they get these civilians to do the government mining?
 - 21 A. Well, when they were preparing for the mining they would
 - 22 send soldiers around to collect the civilians around Tongo Field,
 - 23 or in the town.
 - 24 Q. And when you say collect the civilians, what do you mean?
- 13:16:54 25 A. That is they were capturing them forcefully to bring them.
 - 26 Q. What was the treatment of these civilian miners that you
 - observed while you were in Tongo?
 - 28 A. When this mining was going on, guns the soldiers will be
 - 29 there who manned the civilians. If a soldier who was manning the

- 1 civilian mining, if he suspected that the civilian had stolen a
- 2 diamond, if they asked him to present the diamond and he refused,
- 3 they will kill him. Those were some of the things that took
- 4 place.
- 13:17:43 5 Q. And what happened if the civilians refused to work?
 - 6 A. They will force you. They will beat you up. They will
 - 7 force you. You must work.
 - 8 Q. You said that they had soldiers manning the civilians.
 - 9 What do you mean?
- 13:18:05 10 A. That is when the mining was going on these soldiers were
 - 11 there to watch if the civilian will steal the diamond. So the
 - 12 civilians, the soldiers were there to watch them.
 - 13 Q. And the soldiers that were watching the civilians, were
 - 14 they armed?
- 13:18:31 15 A. Yes.
 - 16 Q. What were the ages of these soldiers watching the
 - 17 ci vi l i ans?
 - 18 A. There would be small boys among them. Even adults would be
 - 19 there.
- 13:18:53 20 Q. When you say small boys, can you give us an age range for
 - 21 these small boys?
 - 22 A. From 14 years upwards.
 - 23 Q. And these small boys, were they also armed?
 - 24 A. Yes.
- 13:19:12 25 Q. Was there any kind of record keeping for the diamonds that
 - were being mined in Tongo?
 - 27 A. Yes.
 - 28 Q. And who kept these records?
 - 29 A. Well, Mohamed Kanneh used to keep record. He used to keep

- 1 record of the mining that was going on. Whatever amount of
- 2 diamond they got, he would document.
- 3 Q. And did anyone else keep records of the mining?
- 4 A. Well, yes. Like for the Black Guard unit, wherever the
- 13:20:13 5 mining was going on, if there was any Black Guard there you too
 - 6 would be taking record of the diamonds that were got.
 - 7 Q. While you were in Tongo and the mining was going on there,
 - 8 to your knowledge was there mining going on in any other areas?
 - 9 A. Yes, mining was going on in Kono.
- 13:20:41 10 Q. And how did you know that?
 - 11 A. Well I knew because among us, the Black Guards, Mosquito
 - 12 assigned one Black Guard called Moriba Koroma to be assigned
 - 13 there so that he will be his representative there.
 - 14 Q. Who was in charge of the mining that was going on in Kono?
- 13:21:18 15 A. Well the mining that was taking place in Kono I did not
 - 16 know who the commander was there, but they were mining for Johnny
 - 17 Paul Koroma.
 - 18 Q. And do you know what areas in Kono the mining was going on?
 - 19 A. No, because I was not there.
- 13:21:44 20 Q. Now, at Tongo Field do you know what areas in Tongo Field
 - 21 were being mined?
 - 22 A. We were mining at a place call Sand Sand. That is the NDMC
 - 23 mining, Sand Sand area. The other place we called Cyborg Ground.
 - 24 Those are the areas we got diamonds from.
- 13:22:15 25 Q. And this first area, what did you say the name of the first
 - 26 area was?
 - 27 A. Sand Sand area. That is the place where at first NDMC was
 - 28 mining and the sand that came as a residue, because they said
 - 29 during that time when they were washing the gravel diamonds used

- 1 to escape and so when we went that was the place we were mining.
- 2 Q. So this place you're talking about is Sand Sand? Is that
- 3 the place?
- 4 A. Yes.
- 13:23:03 5 Q. Now, you testified that you were in Tongo Field until the
 - 6 junta was used out. Now, while you were in Tongo Field did you
 - 7 ever travel to any other location?
 - 8 A. Yes.
 - 9 Q. Where did you go?
- 13:23:17 10 A. I used to travel to come to Kenema.
 - 11 Q. And why did you come to Kenema?
 - 12 A. When I was in Tongo I too used to mine on my own, so
 - 13 whenever I got diamonds I would come to Kenema to sell, or
 - 14 sometimes I would come to visit Sam Bockarie. That was what I
- 13:23:42 15 was doing.
 - 16 Q. And when you visited Sam Bockarie, were there other people
 - 17 with Sam Bockarie?
 - 18 A. Yes, I can remember at one time when I went to visit him I
 - 19 met someone with him who they called Jungle, that is Daniel
- 13:24:08 20 Tamba. I knew him since 1992. So I asked him what had happened
 - and so he told me that the Pa had sent him; that is
 - 22 Charles Taylor. He said that he had sent him to Mosquito and had
 - 23 told him not to be involved that much in the AFRC government. So
 - 24 when he said that Mosquito looked at him in a way, so from then
- 13:24:46 25 on he did not speak any more.
 - 26 Q. You said you knew this Jungle, Daniel Tamba, since 1992.
 - 27 How did you meet him in 1992?
 - 28 A. Well, it happened during the time when Foday Sankoh and I
 - 29 were going to Gbarnga, I knew him. He was at Charles Taylor's

- 1 Mansion Ground. He was in a group called SBU. That was the time
- 2 I knew him. That was the time I knew him.
- 3 Q. While you were in Tongo Field, what communications
- 4 capability did you have in Tongo Field?
- 13:25:43 5 A. We had a radio set, long range radio.
 - 6 Q. What do you mean when you say "long range radio"?
 - 7 A. That is long range communication radio.
 - 8 Q. And with whom did you communicate?
 - 9 A. In the RUF where the junta were, we used to communicate
- 13:26:17 10 with them there.
 - 11 Q. Do you remember the names of any of the radio operators
 - with whom you communicated?
 - 13 A. I can recall at that time Mosquito was in Kenema his
 - 14 operator was with him, Ebony Prince was with him. He had another
- 13:26:50 15 operator, Waco-Waco, and others that I cannot recall were there.
 - 16 Q. This visit of Jungle to Sam Bockarie in Kenema, do you
 - 17 remember when that visit occurred?
 - 18 A. It happened in at the end of 1997.
 - 19 Q. Now, you testified that you stayed in Tongo Field until the
- 13:27:33 20 junta was pushed out. Where did you go when the junta was pushed
 - 21 out?
 - 22 A. We pushed they pushed the junta from out of Freetown. At
 - 23 that time we too the Kamajors had dislodged us from Tongo and
 - 24 we had gone to Kenema. In Kenema it was not long when Mosquito
- 13:28:06 25 said he spoke to the soldiers that he has named an operation
 - 26 called Operation Pay Yourself.
 - 27 Q. Now, what was this Operation Pay Yourself?
 - 28 A. It meant in RUF we were not being paid and as long as the
 - 29 junta continued to push us into the bush he told the soldiers

- 1 whatever anybody had, that person should take along. That was
- 2 how he passed the order and we implemented the order.
- 3 Q. Now, you said as long as the junta is pushing us into the
- 4 bush you should do this. What do you mean when you say the junta
- 13:29:01 5 pushing you into the bush?
 - 6 A. The ECOMOG and the SLAs who were under Tejan Kabbah at that
 - 7 time, they were the ones who were pushing us, and the Kamajors.
 - 8 JUDGE SEBUTINDE: Sorry, Ms Hollis, I'm sorry to interrupt
 - 9 again. The witness said that when he met Jungle, Jungle said to
- 13:29:34 10 him and I'm reading at page 87 where he said that Jungle told
 - 11 him that he was not supposed to be involved that much in the AFRC
 - 12 government. It's not clear was it Jungle who was not supposed to
 - 13 be involved, or was it Mosquito was not supposed to be involved?
 - 14 MS HOLLIS: Thank you, Justice Sebutinde. Let me clear
- 13:30:04 15 that up:
 - 16 Q. When you were talking about Jungle meeting with Mosquito,
 - 17 you said that Jungle told you that the Pa, Charles Taylor, had
 - 18 sent him. He said that he had sent him to Mosquito and had told
 - 19 him not to be involved that much in the AFRC government. So who
- 13:30:28 20 was not to be involved so much in the AFRC government?
 - 21 A. He said Mosquito was not to be involved that much in the
 - 22 AFRC government.
 - 23 Q. And who was it who said that Mosquito should not be
 - 24 involved that much in the AFRC government? Who said that?
- 13:30:49 25 A. Jungle said that.
 - 26 Q. And did Jungle explain why he was saying that?
 - 27 A. Well, he did not go further than that. As he was saying
 - that, Mosquito looked at him in a way and so he stopped talking.
 - 29 PRESIDING JUDGE: Ms Hollis, if you've finished that

- 1 clarification I note the time. If it's appropriate, we will take
- the lunchtime adjournment now.
- 3 MS HOLLIS: This is appropriate, thank you.
- 4 PRESIDING JUDGE: Mr Witness, this is the time now when we
- 13:31:20 5 adjourn for Lunchtime. We take one hour's break. We will be
 - 6 resuming court again at 2.30. Please adjourn court until 2.30.
 - 7 THE WITNESS: Thank you.
 - 8 [Lunch break taken at 1.30 p.m.]
 - 9 [Upon resuming at 2.32 p.m.]
- 14:26:10 10 PRESIDING JUDGE: Mr Griffiths, I note a change of
 - 11 appearance on your Bar.
 - 12 MR GRIFFITHS: I am grateful to your Honours, yes. Madam
 - 13 President, your Honours, yes, we are now joined by Elizabeth
 - 14 Nahamya, the Principal Defender.
- 14:32:23 15 PRESIDING JUDGE: Thank you, Mr Griffiths. We welcome
 - 16 Ms Nahamya to the Court. It is, I think, your first time here.
 - 17 When you are ready Ms Hollis, please proceed.
 - 18 MS HOLLIS: Thank you, Madam President:
 - 19 Q. Mr Witness, before we go back to discussing how you
- 14:32:44 20 implemented this Operation Pay Yourself, I want to go back to
 - Jungle's visit to Sam Bockarie in Kenema. Now, you testified
 - 22 that Jungle told you that he had been sent by Pa, who was Charles
 - 23 Taylor. Did Jungle tell you why Charles Taylor had sent him to
 - 24 Kenema to Sam Bockarie?
- 14:33:16 25 A. He was trying to talk to me, saying that Charles Taylor
 - 26 sent him from Liberia to tell Sam Bockarie that he shouldn't
 - involve himself too much in the AFRC governance. But he wanted
 - 28 to continue talking, but the way Sam Bockarie watched at him, he
 - 29 stopped talking.

- 1 Q. Now, Mr Witness, you had said that Sam Bockarie ordered an
- 2 Operation Pay Yourself and that you implemented that operation.
- 3 What did you do when you implemented that operation?
- 4 A. Well, those of us, the soldiers who were under
- 14:34:09 5 Sam Bockarie, we looted vehicles. We took we opened shops and
 - 6 collected properties from there, we took civilians and we went to
 - 7 Segbwema and we went to Daru, Pendembu, Kailahun, up to Buedu.
 - 8 That was what we did.
 - 9 Q. And when you say that you took civilians, what do you mean?
- 14:34:46 10 A. Well, when Sam Bockarie passed the order whilst we were
 - 11 retreating, the civilians who were in Kenema township, we took
 - 12 some of them and we went with them.
 - 13 Q. And did these people go with you voluntarily?
 - 14 A. Some of them went with us willingly, but some of them were
- 14:35:16 15 forced.
 - 16 Q. And when you went on this route from Kenema to Buedu, what,
 - 17 if anything, did these civilians do?
 - 18 A. The civilians did not do anything. They joined us and we
 - 19 went.
- 14:35:41 20 Q. These civilians that were with you and went to Buedu, can
 - 21 you tell us the ages of these civilians?
 - 22 A. Well, amongst the civilians there were children, there were
 - women, there were boys, girls, men and women.
 - 24 Q. Can you tell us about how many civilians were taken from
- 14:36:13 25 Kenema to Buedu?
 - 26 A. They were many. I can't recall the number of civilians
 - that went with us.
 - 28 Q. As you went along this route that you have described to
 - 29 Buedu, did you continue to implement Operation Pay Yourself?

- 1 A. After we had left Kenema, whilst we were going we did not
- 2 loot in the other towns because all of those areas were already
- 3 RUF controlled zones and so there were no properties there.
- 4 Q. Why were there no properties there?
- 14:37:11 5 A. Because RUF had been there for a long period of time and
 - 6 they had already taken all the properties from the people, so
 - 7 there was nothing left to be taken.
 - 8 Q. What happened when you arrived in Buedu?
 - 9 A. When we arrived in Buedu I told Sam Bockarie that I wanted
- 14:37:46 10 to go and settle in Balahun, so that I will serve as security for
 - 11 him at that place, because I was not happy in mind to stay with
 - 12 him there because of some of the bad things that he did
 - 13 sometimes.
 - 14 Q. Now, when you say you weren't happy to stay with him
- 14:38:10 15 because of some of the bad things he did sometimes, what are you
 - 16 talking about? What bad things?
 - 17 A. Well, I knew, and other soldiers were saying it,
 - 18 Sam Bockarie was somebody that was quick to go to anger and he
 - 19 used to kill other soldiers. That is what I mean.
- 14:38:35 20 Q. And what were you to do in Balahun?
 - 21 A. I was in Balahun as security. When soldiers came from the
 - 22 front line, I would be there to arrest the soldiers and inform
 - 23 Sam Bockarie so he will give me the order to send them back to
 - the front line.
- 14:39:06 25 Q. And why would you arrest these soldiers who came from the
 - 26 front line?
 - 27 A. Because they would come from the front line without
 - informing their commanders.
 - 29 Q. How long did you remain in Buedu before you went to

- 1 Bal ahun?
- 2 A. I spent four days before going to Balahun.
- 3 Q. And can you tell the Court where Balahun is located?
- 4 A. Balahun is between Kailahun and Buedu.
- 14:39:59 5 Q. How long did you remain based at Balahun?
 - 6 A. I was in Balahun up to September 1998.
 - 7 Q. Now, in addition to the Balahun area, to your knowledge to
 - 8 what other areas did Sam Bockarie deploy manpower?
 - 9 A. Sam Bockarie assigned people in Segbwema. He assigned
- 14:40:44 10 people in Jojoima and the Mobai area, Daru. Those were the areas
 - 11 he assigned people.
 - 12 MS HOLLIS: Your Honours, I believe the spelling of Jojoima
 - is J-0-J-0-I-M-A and Mobai is M-0-B-A-I:
 - 14 Q. Now, while you were at Balahun did you have any
- 14:41:23 15 communications capability there?
 - 16 A. I did not have anything in Balahun for communication.
 - 17 Q. And how did you get information or pass information while
 - 18 you were in Balahun?
 - 19 A. If I wanted to get information, I will walk to Buedu to get
- 14:41:49 20 information.
 - 21 Q. And how often would you go to Buedu to get information?
 - 22 A. It happened many times. At any time whilst I was in
 - 23 Balahun when I needed information I will walk to go there.
 - 24 Q. When you went to Buedu, what groups were in Buedu?
- 14:42:23 25 A. When I went to Buedu, after we had arrived in Buedu, myself
 - 26 and Mosquito and others. And after I returned to Balahun I met
 - 27 Johnny Paul Koroma, Leather Boot, Mosquito and other people whose
 - 28 names I can't recall now.
 - 29 Q. And who was Johnny Paul Koroma?

- 1 A. Johnny Paul Koroma was the Leader of the AFRC government.
- 2 Q. And who was Leather Boot?
- 3 A. Leather Boot also was a member of the AFRC government.
- 4 Q. Did you know him by any other name?
- 14:43:36 5 A. Yes, his name is Idrissa Kamara.
 - 6 Q. And are you saying Idriss or Idrissa Kamara?
 - 7 A. Idrissa Kamara.
 - 8 Q. How did it happen that you went to Buedu and met JPK,
 - 9 Johnny Paul Koroma, there?
- 14:44:07 10 A. Well, it was Mosquito who called for a meeting and so
 - 11 during the meeting he said as long as we had gone and joined our
 - 12 brothers, the AFRC, and we had worked with them, since we have
 - 13 now come back to the bush now we had formed our we have been
 - 14 together with the AFRC, he said we should work with them. That
- 14:44:37 15 was what he said.
 - 16 Q. Now, who was at this meeting when Sam Bockarie was saying
 - 17 thi s?
 - 18 A. Mike Lamin was present in the meeting. Mike Lamin was
 - 19 there, Rashid Sandy was there, Leather Boot was there, SYB Rogers
- 14:45:12 20 was there, Johnny Paul Koroma was there, together with some other
 - 21 people whose names I can't recall now.
 - 22 Q. And who was Mike Lamin?
 - 23 A. Mike Lamin was one of the Special Forces who trained
 - 24 together with Pa Sankoh in Libya.
- 14:45:43 25 Q. And who was Rashi d Sandy?
 - 26 A. Rashid Sandy was the general adjutant in Buedu.
 - 27 Q. Do you know where Rashid Sandy trained?
 - 28 A. Rashid Sandy was trained in the Pujehun area.
 - 29 Q. What were Rashid Sandy's duties as the general adjutant?

- 1 A. Well, he was with General Sam Bockarie and he was
- 2 responsible for taking record of everything that happened
- according to the orders given to him by Sam Bockarie.
- 4 Q. In addition to Rashid Sandy were there other adjutants in
- 14:46:50 5 the RUF?
 - 6 A. Yes, there were other adjutants in the RUF.
 - 7 Q. And what were the duties of these other adjutants?
 - 8 A. Other adjutants who were under commanders, the adjutant was
 - 9 to take a record of any activity that was to take place under a
- 14:47:37 10 command structure.
 - 11 Q. And when these adjutants took records of these activities,
 - 12 what did they do with those records, if you know?
 - 13 A. Well, the commanders reported the commanders will take
 - 14 these documents to Sam Bockarie, because he was in charge at that
- 14:48:07 15 time.
 - 16 Q. What did you do after this meeting?
 - 17 A. I returned to Balahun.
 - 18 Q. While you were in Balahun did you receive information about
 - 19 what was happening in other areas under RUF and AFRC control?
- 14:48:44 20 A. Yes, whilst I was in Balahun I understood from some
 - 21 soldiers who were coming from the Kono area and who will pass
 - 22 through us, they told us that SLAs had burned down Kono. That
 - 23 was the information I had.
 - 24 Q. And when you say they had burned down Kono, what location
- 14:49:10 25 are you talking about?
 - 26 A. That was in Koidu Town.
 - 27 Q. And do you know why they burned down Koidu Town?
 - 28 A. They said it was because the soldiers will not be able to
 - 29 be based there, so that any time we attack the place we will be

- 1 able to capture the place easily.
- 2 PRESIDING JUDGE: Ms Hollis, the witness has said SLA which
- 3 is, as I understand it, Sierra Leone Army and there are two
- 4 factions, there is the loyals and there is the AFRC, and I am not
- 14:49:54 5 clear which one he is referring to.
 - 6 MS HOLLIS: Thank you, Madam President:
 - 7 Q. Mr Witness, you have said that the SLA burned down Koidu
 - 8 Town. Now when you say SLA, who do you mean?
 - 9 A. Those were the SLAs who were part of the AFRC government.
- 14:50:26 10 Those were the ones I was trying to refer to.
 - 11 Q. Can you tell us when was your next trip to Buedu?
 - 12 A. The other trip I made to Buedu, other soldiers were passing
 - 13 by who gave me information that Jungle had come to Buedu and so I
 - 14 went there. When I went to Buedu I saw Jungle. What Jungle told
- 14:51:01 15 me was that Charles Taylor sent him to Mosquito and that Charles
 - 16 Taylor had known that the juntas had retreated from Freetown, so
 - 17 that was the reason why he sent him to come and call Mosquito for
 - 18 him to go and meet him in Monrovia. That was what he told me.
 - 19 Q. What happened after you had this conversation with Jungle?
- 14:51:37 20 A. Later I returned to Balahun.
 - 21 Q. Now while you were in Buedu this time, did you attend any
 - 22 meetings in Buedu?
 - 23 A. Yes, whilst I was there I attended a meeting in which
 - 24 Sam Bockarie, Issa Sesay and other people were present. During
- 14:52:01 25 this meeting Sam Bockarie did say that the Papay, that is Charles
 - 26 Taylor, sent Jungle to meet him and he said he had known that we
 - 27 have retreated to this area and he said he should go and see him.
 - 28 So he, Mosquito, left Issa as the commander for him to be able to
 - 29 go. After that I returned to Balahun.

- 1 Q. Did you learn whether Sam Bockarie actually went to see
- 2 Charles Taylor?
- 3 A. Yes, later I got information that Mosquito and Jungle have
- 4 gone to see Charles Taylor.
- 14:52:54 5 Q. While Mosquito had gone to see Charles Taylor and Issa
 - 6 Sesay was in charge, what happened?
 - 7 A. Later after two weeks I went back to Buedu and when I went
 - 8 there I was based with a radio operator called Daf. Later
 - 9 Sam Bockarie returned together with Junior Vandi and Jungle.
- 14:53:30 10 When they came, I saw Mosquito, Jungle and Issa Sesay entering
 - 11 into Mosquito's room. They were there for a while, but when they
 - 12 came outside later I saw Mosquito was angry and he said that Issa
 - 13 Sesay was not supposed to have taken such an action in his
 - 14 absence. He said he was supposed to have waited for him.
- 14:54:07 15 THE INTERPRETER: Your Honours, could the witness slow down
 - 16 and repeat the last bit from where I stopped.
 - 17 PRESIDING JUDGE: Mr Witness, you are going a bit too
 - 18 quickly for the interpreter who has to interpret as you talk.
 - 19 Can you go back to where you were saying, "He said he was
- 14:54:23 20 supposed to have waited for him" and continue your answer from
 - 21 there and pause at the end of each sentence for a moment. Is
 - 22 that clear?
 - THE WITNESS: He, Mosquito, when he was coming out of the
 - 24 room, he was saying that Issa Sesay was supposed to have waited
- 14:54:48 25 for him. He said he was not supposed to have taken such an
 - 26 action. He said he was not supposed to have taken Johnny Paul
 - 27 Koroma's wife from him, and the diamonds.
 - 28 MS HOLLIS:
 - 29 Q. Now, when you say that Mosquito said Issa Sesay was

- 1 supposed to have waited for him, who is the "him" you are talking
- 2 about?
- 3 A. Mosquito said that Issa Sesay should wait for him before
- 4 taking such an action.
- 14:55:25 5 Q. Wait for who?
 - 6 A. To wait for Mosquito.
 - 7 Q. Did you learn what this action was that Sam Bockarie was
 - 8 talking about?
 - 9 A. That was the taking of the diamonds and the taking of
- 14:55:54 10 Johnny Paul Koroma's wife from him. That was what he was talking
 - 11 about.
 - 12 Q. How did you learn this?
 - 13 A. That happened after Mosquito had returned and when that
 - 14 happened it was when he was blasting at him and whilst he was
- 14:56:26 15 talking in his sitting room. That was the moment I heard it.
 - 16 Q. And when you say that he shouldn't have taken the action
 - 17 regarding the diamonds, what are you talking about?
 - 18 A. That he shouldn't have undertaken such an operation in his
 - 19 absence. He, Mosquito, was supposed to be around before he could
- 14:56:56 20 take those diamonds and the other thing he did was that he took
 - 21 Johnny Paul Koroma's wife from him for some time and so Mosquito
 - 22 was not happy with that.
 - 23 Q. And what diamonds are you talking about that were taken?
 - 24 A. Well, after Mosquito had said that, Issa Sesay said that he
- 14:57:24 25 got information that Johnny Paul Koroma and the other people,
 - 26 like Gullit and Rambo, were trying to escape to go to Liberia
 - 27 with the diamonds, so he said that was the reason why he took the
 - 28 diamonds from them.
 - 29 Q. Now, on this occasion while you were in Buedu, did you

- 1 attend any meeting?
- 2 A. Yes, that was a meeting that was convened by Issa Sesay and
- 3 that included SYB Rogers, Mike Lamin, Rashid Sandy, together with
- 4 some other people that I cannot recall, and during that meeting
- 14:58:19 5 he did say he went to see he said Charles Taylor called him for
 - 6 him to go and meet with him, but he said before he could arrive
 - 7 there he said Benjamin Yeaten, who was 50, 50, was the person he
 - 8 met and he was the one who took him to Charles Taylor. He said
 - 9 when they got to Charles Taylor, Charles Taylor did say that he
- 14:59:08 10 was his brother revolutionary. He said Foday Sankoh was his
 - 11 revolutionary brother and so he said he was happy for the action
 - 12 taken by Sam Bockarie in the absence of Foday Sankoh, that he was
 - in control of the RUF up to that moment and so he said he was
 - 14 happy.
- 14:59:36 15 MR GRIFFITHS: I hesitate to interrupt, your Honour, but I
 - 16 see a passage which reads on my screen, "Mike Lamin, Rashid
 - 17 Sandy, together with some other people that I cannot recall, and
 - 18 during that meeting he did say he went to see he said Charles
 - 19 Taylor ... " I may have missed something, but I cannot identify
- 14:59:58 20 who that "he" is.
 - 21 PRESIDING JUDGE: Ms Hollis, we do have a few "he"s in
 - there and "him"s.
 - 23 MS HOLLIS: We do indeed:
 - 24 Q. Now, when you said that at this meeting he said he went to
- 15:00:13 25 see Charles Taylor, who said he went to see Charles Taylor?
 - 26 A. It was Mosquito who was addressing the meeting. He said
 - 27 he, Mosquito, went to Monrovia to see Charles Taylor.
 - 28 Q. And then you said, "He said that when they got to Charles
 - 29 Taylor, Charles Taylor did say that he was his revolutionary

- 1 brother." Now, who is the "they" who got to Charles Taylor?
- 2 A. Mosquito went to Charles Taylor. He said it was Charles
- 3 Taylor who told him that Foday Sankoh was his revolutionary
- 4 brother.
- 15:01:09 5 Q. Now, you have mentioned a person SYB Rogers. Who is that?
 - 6 A. SYB Rogers, he was one senior person that Foday Sankoh
 - 7 respected. He was a civilian and he was a War Council chairman.
 - 8 Q. At this meeting what, if anything, did Issa Sesay do with
 - 9 the diamonds?
- 15:01:53 10 A. Issa Sesay gave those diamonds the diamonds, they were
 - 11 nine there were nine plastic diamonds that he took from Johnny
 - 12 Paul. They were nine plastics that he gave to Mosquito,
 - 13 Sam Bockarie.
 - 14 JUDGE SEBUTINDE: Mr Interpreter, what are plastic
- 15:02:22 15 di amonds?
 - THE WITNESS: Well, there is a plastic that they normally
 - 17 put tablets in. That is what I am referring to.
 - 18 MS HOLLIS:
 - 19 Q. So when you say "nine plastic diamonds", what are you
- 15:02:43 20 telling us?
 - 21 A. The diamonds were in the plastic, up to nine plastics.
 - 22 Q. Now, you said that Issa Sesay gave Sam Bockarie the
 - 23 diamonds he had taken from Johnny Paul Koroma and I think you
 - 24 mentioned two other people. Who were these other people?
- 15:03:17 25 A. Those other people were also soldiers under Johnny Paul
 - 26 Koroma. They were called Gullit and Rambo. He was a security to
 - 27 Johnny Paul Koroma.
 - 28 Q. Who was a security to Johnny Paul Koroma?
 - 29 A. It was Rambo.

- 1 Q. Do you know him by any other name?
- 2 A. No.
- 3 Q. After Issa Sesay gave these diamonds to Sam Bockarie, what
- 4 did Sam Bockarie do?
- 15:04:01 5 A. Sam Bockarie said that he was going to take those diamonds
 - 6 to Charles Taylor for safekeeping until the return of Foday
 - 7 Sankoh from pri son.
 - 8 Q. Now, what did you do after this meeting?
 - 9 A. I went back to Balahun.
- 15:04:30 10 Q. And when did you next go to Buedu?
 - 11 A. I was there for some time and later I went back to Buedu,
 - 12 but this time round I met Jungle again and I met Mosquito who had
 - 13 returned with Jungle, his bodyguard Foday, JR, together with some
 - 14 other Liberian securities like Zigzag Marzah and JR and others.
- 15:05:16 15 Q. Now, you said that you met Foday there who was his
 - 16 security. Whose security was Foday?
 - 17 A. Foday was a security to Mosquito.
 - 18 Q. Do you know Foday's last name?
 - 19 A. I can't remember that.
- 15:05:42 20 Q. And you mentioned a person you called JR. Who was this?
 - 21 A. That is Junior Vandi. He was one of the Black Guards.
 - 22 Q. And you mentioned Zigzag Marzah. Who was that?
 - 23 A. Well he, Sam Bockarie, introduced the Liberian brothers,
 - 24 that is Zigzag Marzah and others, and he said, "These are the
- 15:06:23 25 Liberian brothers sent by Charles Taylor."
 - 26 Q. What happened after Sam Bockarie introduced these people as
 - 27 his Liberian brothers sent by Charles Taylor?
 - 28 A. So I heard Mosquito say that they should unload the vehicle
 - 29 in which they brought the ammunition and Mosquito said they

- 1 should unload the ammunitions and I saw that it was Zigzag Marzah
- 2 who was driving the vehicle, and later Mosquito advised them to
- 3 return that particular night for security reasons.
- 4 Q. You said that you heard Mosquito say that they should
- 15:07:21 5 unload the vehicle in which they had brought the ammunition. Who
 - 6 is the "they" you are referring to?
 - 7 A. Mosquito said that the vehicle brought by Jungle and others
 - 8 should be unloaded.
 - 9 Q. And who unloaded the vehicle, if you know?
- 15:07:51 10 A. Soldiers who were under Sam Bockarie.
 - 11 Q. Do you recall the types of ammunition that were in the
 - 12 truck?
 - 13 A. I saw RPG boxes and AK rounds.
 - 14 Q. And you also said that Mosquito advised them to return that
- 15:08:16 15 particular night for security reasons. Who was he telling to
 - 16 return that night for security reasons?
 - 17 A. He was trying to tell Jungle and Zigzag Marzah that they
 - 18 should go back. He said he did not want them to be there until
 - 19 day break, so that that would prevent other civilians from
- 15:08:45 20 knowing about the mission they were running.
 - 21 Q. What happened then after Mosquito told these people to go
 - 22 back that night for security reasons?
 - 23 A. After that I returned to Balahun. I was there.
 - 24 Q. These Liberians that were there, Zigzag and others, do you
- 15:09:18 25 recall what they were wearing?
 - 26 A. Well, I saw them in overall, blue/black, and it was written
 - 27 by the side of the pocket "SOD police".
 - 28 Q. Did you learn what that meant, SOD?
 - 29 A. Well, later I understood that SOD was a police branch that

- 1 was serving directly under Charles Taylor and they were called
- 2 Special Operations Division.
- 3 Q. And how did you learn this?
- 4 A. It was Jungle who told me.
- 15:10:14 5 Q. You said that you went back to Balahun. Did you go back
 - 6 that night, or later?
 - 7 A. It was later that I returned.
 - 8 JUDGE SEBUTINDE: Ms Hollis, it would be helpful if we had
 - 9 some indication of when this second visit to Buedu happened when
- 15:10:33 10 he saw Zigzag Marzah and others.
 - 11 MS HOLLIS: Thank you, your Honour:
 - 12 Q. Mr Witness, can you tell us when it was that you saw Zigzag
 - 13 Marzah and the others in Buedu?
 - 14 A. I did not get that clearly. Do you mean the time I
- 15:10:57 15 returned to Buedu? Is that what you are trying to talk about?
 - 16 Q. The time that you were in Buedu and you saw Zigzag Marzah
 - 17 and the other Liberians in these SOD uniforms, can you tell us
 - 18 when that was?
 - 19 A. Yes, that happened at the time that Issa Sesay had handed
- 15:11:29 20 over the diamonds to Mosquito, when he went to Monrovia and when
 - 21 he returned, and it was that time that I saw Zigzag Marzah and
 - the others.
 - 23 Q. Do you have any recollection of what month this occurred?
 - 24 A. I can't recall the month.
- 15:11:54 25 Q. Before you returned back to Balahun, did you attend any
 - 26 meetings in Buedu?
 - 27 A. I can't recall that.
 - 28 Q. After this time did you ever see these Liberians in Buedu
 - 29 agai n?

- 1 A. Yes, I used to see them there again.
- 2 Q. And how often did you see them there?
- 3 A. Well, at that time I was no longer based in Buedu. I was
- 4 in Balahun. I will go there and return. Sampson, Jungle and
- 15:12:54 5 others used to come and the time they used to come, according to
 - 6 what they told me, they used to come with a truck that contained
 - 7 arms and ammunition, food and other things that were in there.
 - 8 They said they will normally stop the truck at Voinjama and then
 - 9 they will use small vans to transport the arms and ammunition
- 15:13:16 10 together with the other items to Buedu, or sometimes if the road
 - 11 condition was better the truck will come as far as Buedu.
 - 12 Q. Did they tell you who they received these arms and
 - 13 ammunition from?
 - 14 A. Well, Jungle and others were saying that it was the Papay,
- 15:13:45 15 Charles Taylor, who used to give the arms and ammunition.
 - 16 Q. Did you ever see the trucks that were used to bring the
 - 17 arms and ammunition to Buedu?
 - 18 A. At one time I saw a military truck come to Buedu.
 - 19 Q. And how big was this truck?
- 15:14:21 20 A. It was it was a ten-tyred truck. It had two in front,
 - 21 two in the middle and then two in front, four in the middle and
 - 22 then two at the back.
 - 23 Q. While you were based in Balahun, to your knowledge how many
 - 24 times did Sam Bockarie go to Liberia?
- 15:15:20 25 A. I understood that he came there times.
 - Q. And who did he go with to Liberia these three times?
 - 27 A. He went with Jungle. And the other time, according to he,
 - 28 Mosquito, because I was not there, what he told me was that
 - 29 Varmuyan Sherif at a point in time came to him, so the two of

- 1 them went. That was what he told me.
- 2 Q. Did he tell you what Varmuya Sherif was?
- 3 A. Well, he told me that Varmuyan Sherif was sent by the Papay
- 4 to come and see him so that the two of them will go.
- 15:16:21 5 Q. Did you ever meet Varmuya Sherif?
 - 6 A. No, I did not meet him in Buedu. It was Mosquito who told
 - 7 me that.
 - 8 Q. Did you ever meet him in any other location?
 - 9 A. Yes, I met him in Monrovia.
- 15:16:49 10 Q. You have testified that soldiers passing through Balahun
 - 11 told you about the SLA burning Koidu Town. Now while you were
 - 12 stationed in Balahun, did you get information about any other
 - 13 attempt to retake Koidu Town?
 - 14 A. Well, yes.
- 15:17:25 15 Q. And what information did you receive?
 - 16 A. I got information that Superman had organised troops who
 - 17 called themselves Fitti-Fatta and that he had tried to re-attack
 - 18 Koidu Town, but that during that attack they did not succeed so
 - 19 people died and people got wounded.
- 15:17:59 20 Q. Did you learn where Superman got the materials for this
 - 21 attack on Koidu Town?
 - 22 A. Mosquito gave him the arms and ammunition.
 - 23 Q. At the time of this Fitti-Fatta attack, to your knowledge
 - where was Superman based?
- 15:18:26 25 A. Superman was based in the Koidu area, which was called
 - 26 Superman Ground, close to Koidu Town.
 - 27 Q. At this time to your knowledge were there AFRC or RUF in
 - any other areas in Kono District?
 - 29 A. Yes, Akim Turay also was a commander who was also based

- 1 around that same Kono area, but he was around the Woama area.
- 2 Q. And who is Akim Turay?
- 3 A. Akim Turay was in the AFRC government.
- 4 Q. What happened after this failed Fitti-Fatta attack on Koidu
- 15:19:46 5 Town?
 - 6 A. After the failure of Fitti-Fatta, Mosquito told Superman -
 - 7 he gave instruction to Superman for him to go to another area.
 - 8 Q. And what other area was he to go to?
 - 9 A. He told him to go to the northern area. I can't recall the
- 15:20:27 10 name of the town now.
 - 11 Q. Do you recall the district?
 - 12 A. He told him to go to Koinadugu area.
 - 13 MS HOLLIS: Your Honours, the town that the witness
 - 14 mentioned, Woama, is W-O-A-M-A:
- 15:20:53 15 Q. Now you have testified that you were based in Balahun until
 - 16 September of 1998. Where did you go after that?
 - 17 A. After that time Mosquito appointed me to serve as the
 - 18 [Redacted]
 - 19 Superman Ground.
- 15:21:24 20 MS HOLLIS: Your Honour, I would ask that that be redacted,
 - 21 [Redacted]
 - 22 from the public record.
 - 23 PRESIDING JUDGE: Any comment from the Defence counsel on
 - 24 that application?
- 15:21:37 25 MR GRIFFITHS: I have no problem with that, your Honour.
 - 26 PRESIDING JUDGE: Very well. The line on page 111, line
 - 27 10, where the witness describes his appointment should be
 - 28 redacted from the record. That's line I don't want to repeat
 - 29 it out loud, but I notice my learned brother says he has got a

- 1 different line. I have it ends "and he sent me to Superman
- 2 Ground". Is that the portion you are referring to?
- 3 MS HOLLIS: Is that referring to the position?
- 4 PRESIDING JUDGE: Yes. It is the same sentence then.
- 15:22:23 5 MS HOLLIS: And it is just before "and he sent me". I
 - 6 would give the line, but I don't think our lines are the same for
 - 7 some reason.
 - 8 PRESIDING JUDGE: Madam Court Attendant has it in hand.
 - 9 MS HOLLIS: Thank you, Madam President:
- 15:22:45 10 Q. Mr Witness, when you went to Superman Ground, why did you
 - 11 go there?
 - 12 A. It was an order given to me by Sam Bockarie for me to go
 - 13 there and join Issa Sesay.
 - 14 Q. What were your duties at Superman Ground?
- 15:23:11 15 PRESIDING JUDGE: Mr Witness, when you answer the question
 - 16 be careful not to say what the title of your job was. Just
 - 17 describe the work.
 - 18 THE WITNESS: Yes.
 - 19 MS HOLLIS:
- 15:23:28 20 Q. Could you tell us what your duties were when you went to
 - 21 Superman Ground?
 - 22 A. Well, whilst I was there I was doing the Black Guard job.
 - 23 When I was there I was taking records of things that were
 - 24 happeni ng.
- 15:23:56 25 Q. And when you say you were taking records of things that
 - 26 were happening, what kinds of things were you taking record of?
 - 27 A. I was taking records of missions that went on. If
 - 28 materials were captured I would talk to the soldiers about the
 - 29 things that I had told you earlier that Foday Sankoh had taught

- 1 us. That was what I was doing.
- 2 Q. And what would you do with these records?
- 3 A. I will send them to the person who was above me.
- 4 Q. You said that you went to Superman Ground to work with Issa
- 15:24:57 5 Sesay. What was Issa Sesay's position at this time?
 - 6 A. At that time Issa Sesay, we used to call him BFI.
 - 7 Q. What did BFI mean?
 - 8 A. BFI means that he was appointed by Mosquito to serve as the
 - 9 commander in the field.
- 15:25:58 10 Q. At the time that you went to Superman Ground, can you tell
 - 11 us what the command structure was in Kono District?
 - 12 A. Yes, when I went to Superman Ground Issa Sesay was there as
 - 13 the overall Boston Flomo, Rambo, was there; Morris Kallon was
 - 14 there; Banya was there; and Peter Vandi too was there as advisor
- 15:26:42 15 in the area. Those are some of the people who were there.
 - 16 Q. Now, you said --
 - 17 PRESIDING JUDGE: Sorry to interrupt, Ms Hollis, but we are
 - 18 just signing that redaction order and I would like to do what I
 - 19 normally do and address the monitors and any persons that are in
- 15:27:00 20 the public gallery. The name of a position held by the witness
 - 21 has been mentioned in the course of his evidence and it is not to
 - 22 be repeated outside the precincts of the court, or published in
 - 23 any other way. Sorry to interrupt, but I wanted to do it when it
 - 24 was still --
- 15:27:20 25 MS HOLLIS: Thank you, Madam President:
 - 26 Q. Now, you mentioned Boston Flomo. Who was that?
 - 27 A. Boston Flomo was a Liberian.
 - 28 Q. And do you know where he trained?
 - 29 A. Well, we understood that he was trained in the NPFL, but

- 1 later he joined the RUF.
- 2 Q. You mentioned Rambo. Who was that?
- 3 A. He is the Boston Flomo.
- 4 Q. You also mentioned someone you called Banya. Who was that?
- 15:28:07 5 A. Banya was an AFRC SLA.
 - 6 Q. You mentioned Peter Vandi, who was an advisor. Who was
 - 7 Peter Vandi?
 - 8 A. Peter Vandi was an RUF vanguard.
 - 9 Q. You also mentioned Morris Kallon. Now, you have told us
- 15:28:34 10 earlier there were two Morris Kallons, so which Morris Kallon are
 - 11 you referring to here?
 - 12 A. Well, at that time the Morris Kallon who had gone to
 - 13 Liberia had returned and he was the RUF Morris Kallon.
 - 14 Q. And where had he trained, this Morris Kallon?
- 15:29:02 15 A. He was trained at Camp Naama in Liberia.
 - 16 Q. Now, you have given us the names of people in Kono at that
 - 17 time. You said that Issa Sesay was the overall commander. Who
 - 18 was next below him?
 - 19 A. In Kono it was Morris Kallon who was next to Issa.
- 15:29:35 20 Q. And what was Boston Flomo's position in Kono?
 - 21 A. Boston Flomo was the brigade commander there.
 - 22 Q. So under Morris Kallon, who came next?
 - 23 A. It was Boston Flomo who was next to Morris Kallon and Banya
 - 24 was next to Boston Flomo. That was how the promotions were.
- 15:30:20 25 Q. You said that Peter Vandi was an adviser. An advisor to
 - 26 whom?
 - 27 A. He was advisor in that brigade.
 - 28 Q. In which brigade is that?
 - 29 A. They call the brigade the second brigade.

- 1 Q. What happened after you went to Superman Ground?
- 2 A. When I had been at Superman's ground, later Sam Bockarie
- 3 called Issa to go to Buedu, so I joined Issa Sesay and the two of
- 4 us went to Buedu. He said we should try to recapture Koidu Town,
- 15:31:18 5 so he was trying to go to Monrovia to meet the Pa, that is
 - 6 Charles Taylor, and that Issa Sesay was to stay in charge when he
 - 7 went. So we waited there until Mosquito went to Monrovia.
 - 8 Q. Can you tell us when this was that Mosquito went to
 - 9 Monrovi a?
- 15:32:00 10 A. This happened in October.
 - 11 Q. Can you tell us what year this is?
 - 12 A. It happened in 1998.
 - 13 Q. You said that you went to Buedu with Issa Sesay. How long
 - 14 were you in Buedu?
- 15:32:29 15 A. We spent up to two months.
 - 16 Q. And what happened then?
 - 17 A. Later Mosquito came with a lot of ammunition.
 - 18 Q. And what happened after he came with a lot of ammunition?
 - 19 A. After he had come with these ammunition he said that the
- 15:32:57 20 Pa, that is Charles Taylor, had told him that we should try and
 - 21 capture Kono. He said we should try and capture Kono and other
 - 22 mining areas, so that we will be able to get diamonds and hence
 - 23 get more arms and ammunition. So he handed over these materials
 - 24 to Issa Sesay. Since then we moved to Koidu Town. Sorry, to
- 15:33:31 25 Superman's ground.
 - 26 Q. You said he came back with a lot of ammunition. What kinds
 - of ammunitions did he come back with?
 - 28 A. He came with RPG bombs, he came with AK rounds, he came
 - 29 with GPMG rounds, he came with camouflage, he came with guns and

- 1 others that I cannot recall.
- 2 Q. When you say he came with camouflage, what do you mean?
- 3 A. That is the clothes that a soldier puts on. That is
- 4 combat.
- 15:34:34 5 Q. How was this ammunition and the camouflage and the other
 - 6 things, how was it brought to Buedu?
 - 7 A. It was a vehicle that brought them.
 - 8 Q. And can you tell us the size of this vehicle?
 - 9 A. At that time they were brought in a pick-up.
- 15:35:08 10 Q. You said that Mosquito gave Issa Sesay these materials.
 - 11 Why did he give Issa Sesay these materials?
 - 12 A. He said we should try and capture Koidu Town and the other
 - 13 areas which were mining areas, because the Pa, Charles Taylor,
 - 14 had said we should try and get these areas in order to get more
- 15:35:44 15 di amonds.
 - 16 Q. And what was Issa Sesay's role in this operation?
 - 17 A. Issa Sesay was to go and organise commanders. He was to
 - 18 become the commander to organise to organise so that they can
 - 19 fight and capture these areas.
- 15:36:15 20 Q. And you said you took these materials to Superman Ground.
 - 21 How did you transport the materials to Superman Ground?
 - 22 A. Well, Sam Bockarie ordered captured some civilians around
 - 23 Buedu and the surrounding villages to carry these arms and
 - 24 ammunition, so that was what they did before we departed.
- 15:36:53 25 Q. What happened when you arrived back in Superman Ground?
 - 26 A. When we got to Superman's ground, Issa Sesay called a
 - 27 meeting. At this meeting he called, Morris Kallon was at this
 - 28 meeting, Akim Turay was at this meeting, Banya was at this
 - 29 meeting, Gassama Mansaray was at this meeting, and other people

- 1 whose names I can't recall now. During this meeting he, Issa
- 2 Sesay, said that master had come, that is Mosquito. He said so
- 3 he had gone and met with the Pa, that is Charles Taylor. He said
- 4 he had given a lot of arms and ammunition for us to capture Koidu
- 15:38:06 5 Town and for us to capture the other areas; those areas that were
 - 6 mining areas. He said that Charles Taylor had said that he
 - 7 said Mosquito said Charles Taylor had said that if we did not
 - 8 capture these mining areas he said he will not supply us arms and
 - 9 ammunition any more. He said so we should try very hard to
- 15:38:37 10 capture these areas. So at this meeting he organised the
 - 11 commanders as to how they were to carry out the mission. He
 - 12 appointed Rambo, that is Boston Flomo, that he should be the head
 - 13 for the mission and Morris Kallon, he was to go he was to go
 - 14 and mount an ambush in the Goltown area. So Akim Turay was to go
- 15:39:25 15 to the other area to attack, while Rambo was to go to the
 - 16 Five-Five Spot that is in Koidu Town. He said after we had
 - 17 captured Koidu Town, the mission Akim Turay was to take troops
 - 18 to go towards Tongo Field, while Boston Flomo was to go towards
 - 19 Makeni.
- 15:39:55 20 Q. Can I stop you there for a moment. This meeting, when you
 - 21 held this meeting where was Boston Flomo?
 - 22 A. We were all in the meeting with Boston Flomo.
 - 23 MS HOLLIS: Your Honours, the witness mentioned Gassama
 - 24 Mansaray:
- 15:40:17 25 Q. Is that correct, Mr Witness?
 - 26 A. Yes.
 - 27 MS HOLLIS: G-A-S-S-A-M-A. Mansaray would be the regular
 - 28 spelling, M-A-N-S-A-R-A-Y:
 - 29 Q. Mr Witness, you mentioned a town that Morris Kallon was

- 1 to go toward a town and lay an ambush or mount an ambush. What
- town was that that you mentioned?
- 3 A. That town is behind the Sewafe bridge. When you go across
- 4 the bridge they called it Goltown.
- 15:41:00 5 Q. Now can you spell that for us, this town?
 - 6 A. G-O-L-T-O-W-N, Goltown.
 - 7 JUDGE SEBUTINDE: Ms Hollis, whilst we are on this
 - 8 particular area, the witness mentioned a consignment of arms and
 - 9 ammunition that arrived I believe in Buedu whilst the witness was
- 15:41:34 10 with Issa Sesay. Now he has stated that he was in Buedu at this
 - 11 period for two more months and that appears to take us to sort of
 - 12 the end of 1998. Could we have a little more clarity exactly
 - when these arms and ammunition were brought?
 - 14 MS HOLLIS: I will try that, your Honour:
- 15:41:55 15 Q. Mr Witness, you said that you went to Buedu, you and Issa
 - 16 Sesay, in about October and that Sam Bockarie left and was gone
 - 17 for about two months and he came back with a lot of ammunition.
 - 18 Can you tell us when it was that he came back to Buedu?
 - 19 A. It was in December 1998 that he returned.
- 15:42:21 20 Q. Now when you were telling us about the plan to attack Koidu
 - 21 and then go to other areas, you said that Akim Turay was to go to
 - 22 the other area. What area do you mean?
 - 23 A. It was the way Issa Sesay etched out the plan, these groups
 - that he had spoken about were all to come together to attack
- 15:42:52 25 Koidu Town from other areas. That after we had taken this town
 - 26 it was from there that Akim Turay was to go to Tongo Field while
 - 27 Boston Flomo would use another route to go to Makeni, but Koidu
 - 28 Town was to be attacked by the whole group. That was how the
 - 29 plan was etched out.

- 1 Q. And you indicated that the group you were in was to attack
- 2 the Five-Five area. Where was the Five-Five area?
- 3 A. The Five-Five area is in Koidu Town. It was an area where
- 4 the ECOMOG base was. They had heavy weapons there. So Boston
- 15:43:46 5 Flomo's group was to attack that particular place. That was the
 - 6 group I was in.
 - 7 Q. At the time of this meeting in Superman Ground, where was
 - 8 Superman?
 - 9 A. Superman was still in the Koinadugu area. Well, Superman
- 15:44:06 10 too when when he too Mosquito instructed him when we had -
 - 11 when we would have captured Koidu and advancing on Makeni, he too
 - 12 was to come from Koinadugu so that we can all come together in
 - 13 Makeni.
 - 14 Q. So what happened after this meeting?
- 15:44:41 15 A. After the meeting, we took we undertook the mission, but
 - 16 the very day that we launched the attack we did not succeed. It
 - 17 was the following day that we captured Koidu Town. After we had
 - 18 captured Koidu Town, Akim Turay took along his own group in order
 - 19 to attack Tongo Field whilst Rambo went towards Makeni.
- 15:45:17 20 Q. Now when you captured Koidu Town, did you capture anything
 - 21 in Koidu Town?
 - 22 A. We captured materials, that is arms and ammunition. We
 - 23 also captured the Nigerian soldiers that were there. We captured
 - 24 them.
- 15:45:47 25 Q. And who were these Nigerian soldiers?
 - 26 A. That was the ECOMOG that were deployed there.
 - 27 Q. Now tell us again, you have said that ECOMOG was in Koidu
 - 28 Town when you attacked. Were there any other forces in Koidu
 - 29 Town when you attacked?

- 1 A. Well, the SLA troops who were under Tejan Kabbah's
- 2 government were there together with some Kamajors.
- 3 Q. Can you tell us how many of these Nigerian troops you
- 4 captured?
- 15:46:38 5 A. I can't recall their number. They were many.
 - 6 Q. And what did you do with them after you captured them?
 - 7 A. Issa Sesay sent all of them to Buedu to Mosquito.
 - 8 Q. What happened to the civilians in Koidu after the attack?
 - 9 A. After we had attacked I used to see some of the corpses of
- 15:47:10 10 civilians.
 - 11 Q. And did you see how the RUF and AFRC forces treated the
 - 12 civilians after the attack?
 - 13 A. That used to happen. Some soldiers took civilians
 - 14 forcefully, they took women and forced them. That used to
- 15:47:43 15 happen.
 - 16 Q. Now you said after the attack --
 - 17 JUDGE SEBUTINDE: Ms Hollis, forced the women to do what?
 - 18 MS HOLLIS:
 - 19 Q. When you say "forced the women", what do you mean?
- 15:48:03 20 A. Well, they will force them to have sex with them.
 - 21 Q. Now you have said that after this attack Akim Turay went
 - 22 towards Tongo and that Boston Flomo went toward Makeni. Now what
 - 23 did you do after this attack?
 - 24 A. After that attack, we went to Makeni. When we got there
- 15:48:35 25 Superman too came from his end and all of us captured Makeni. So
 - 26 we were in Makeni when we were made to understand on the radio
 - 27 that the other brothers had entered that is the other SLA
 - 28 brothers had entered Freetown.
 - 29 Q. Now, let me ask you before you left Koidu Town, going

- 1 toward Makeni, are you aware of any communications that occurred
- 2 after the capture of Koidu Town?
- 3 A. Yes, communication took place at Buedu and another
- 4 communication took place in Monrovia where the operator who was
- 15:49:36 5 in Monrovia who was with Benjamin Yeaten called Sunlight -
 - 6 communication took place there when the operator was trying to
 - 7 tell the other operators how we had captured Koidu, how we had
 - 8 captured arms and ammunition, how we had captured all the
 - 9 Nigerian soldiers. That communication took place.
- 15:50:11 10 Q. And tell us again who was Sunlight?
 - 11 A. Sunlight was a radio operator who was with Benjamin Yeaten.
 - 12 Q. How do you know about these communications?
 - 13 A. I was in the radio room when the communication was going
 - 14 on.
- 15:50:40 15 Q. Now once you had captured Makeni, what forces were in
 - 16 Makeni?
 - 17 A. In Makeni too the ECOMOG troops were there together with
 - 18 the SLAs. We attacked them.
 - 19 Q. And once you captured them and had the town, what forces
- 15:51:03 20 were in Makeni?
 - 21 A. That was we, the RUFs, and the AFRC troops, we were there.
 - 22 Q. Can you tell us when it was that you captured Makeni?
 - 23 A. That happened in 1999.
 - 24 Q. And do you recall the month?
- 15:51:39 25 A. It happened in January. January 1999.
 - 26 Q. How long did you stay in Makeni?
 - 27 A. After we had received that information that our brothers
 - 28 had entered Freetown, Mosquito sent a message to Issa Sesay that
 - 29 he should try and connect with his brothers in Freetown whereby

- 1 Gullit was the commander. So Issa Sesay instructed Boston Flomo
- 2 to go and meet the brothers. At that time we were still in
- 3 Makeni.
- 4 Q. And do you recall when it was that you got the message that
- 15:52:48 5 the brothers had captured Freetown?
 - 6 A. Yes, it was in January 1999. I can't recall the date.
 - 7 Q. And when Boston Flomo was ordered to move toward Freetown,
 - 8 where was Superman?
 - 9 A. Superman was in Makeni.
- 15:53:18 10 Q. And what happened with Superman?
 - 11 A. Superman was still in Makeni when Boston Flomo went on the
 - 12 mission.
 - 13 Q. And how long did Superman remain in Makeni?
 - 14 A. Well, later, after Boston Flomo had gone to the Waterloo
- 15:53:49 15 area, Superman went and based in Lunsar.
 - 16 Q. Now, how long did you remain in Makeni?
 - 17 A. I was in Makeni with I stayed long there a little with
 - 18 Issa Sesay.
 - 19 Q. And what were your duties there in Makeni with Issa Sesay?
- 15:54:36 20 A. I was there. Wherever Issa was going, I used to go with
 - 21 him where the order I was with him there as security, so
 - 22 whatever information that was around, I was to be informed as
 - 23 well.
 - 24 Q. When Boston Flomo went toward Freetown, did you receive any
- 15:55:09 25 communications from him?
 - 26 A. Boston Flomo said that he had gone up to Waterloo, he had
 - 27 gone up to Jui bridge and had encountered a resistance there from
 - 28 the enemy. That was the message he sent to Issa Sesay.
 - 29 Q. And did he tell Issa Sesay where he was basing?

- 1 A. He told him that he was based in Waterloo.
- 2 Q. Now, you said that you based in Makeni for some time.
- 3 Where did you go after Makeni?
- 4 A. After I had left Makeni I went back to Kono.
- 15:56:22 5 Q. And where did Issa go?
 - 6 A. Issa was in Makeni.
 - 7 Q. And did you get any additional reports about what was
 - 8 happening in Freetown?
 - 9 A. Yes.
- 15:56:49 10 Q. And what reports did you get?
 - 11 A. On the day that I came back on the day that I went back
 - 12 to Kono, I heard from the radio I heard from the communication
 - 13 radio people that Superman and Issa Sesay, that there was an
 - 14 infighting between them. That was the message I got.
- 15:57:22 15 Q. Now, do you recall when this was?
 - 16 A. This was this happened in '99.
 - 17 Q. And when this happened, do you recall were Gullit's troops
 - 18 still in Freetown?
 - 19 A. No, at that time Gullit's troops had left Freetown and they
- 15:57:53 20 were now in Waterloo.
 - 21 Q. And what happened when Gullit's troops were in Waterloo?
 - 22 A. Well, when they were in Waterloo, at that time I was now
 - 23 again with Issa. I and Issa went to Waterloo. When we went to
 - 24 Waterloo we met Gullit's group had withdrawn all of them had
- 15:58:27 25 withdraw back to Waterloo, so when Issa met Gullit, Gullit was
 - 26 trying to be was getting angry. He was trying to say that,
 - 27 "Issa Sesay, I was in Freetown asking for manpower and you
 - 28 refused to send the manpower hastily. That was why I refused" --
 - 29 THE INTERPRETER: Your Honours, can he kindly repeat this

- 1 whole bit.
- 2 PRESIDING JUDGE: Please pause, Mr Witness. The
- 3 interpreter is having trouble keeping up with you. Can you go
- 4 back to your answer and start again from the point where you
- 15:59:09 5 said, "I was in Freetown asking for manpower," this is Gullit
 - 6 speaking, "and you refused to send the manpower hastily. That
 - 7 was why I refused", and continue from there, please.
 - 8 THE WITNESS: Gullit was trying to blame Issa Sesay that,
 - 9 "Issa Sesay, the reason I withdrew was that you failed to send
- 15:59:38 10 manpower immediately. That was why I retreated." So Issa Sesay
 - 11 too responded to Gullit, saying that it was not his fault, he had
 - 12 sent the manpower, but that it was due to the enemy forces at the
 - 13 bridge. So later they said that they should forget about the
 - 14 argument and try to organise in order to attack the area, so that
- 16:00:08 15 they can get back into Freetown. So that was what was organised.
 - 16 MS HOLLIS:
 - 17 Q. Could I just ask you a question here? You said that,
 - 18 "Later they said that they should forget about the argument. Who
 - 19 is the "they" that you are referring to?
- 16:00:31 20 A. Issa Sesay told Gullit that they should forget about that
 - 21 argument and that they should sit together and organise and plan
 - 22 how they were to attack and get back into Freetown.
 - 23 Q. Now, to your knowledge did they try to carry out this
 - 24 attack to get back into Freetown?
- 16:00:59 25 A. Yes, they tried, but they were they did not capture the
 - 26 pl ace.
 - 27 Q. And who was it who was trying to get back into Freetown?
 - 28 What groups?
 - 29 A. It was the RUF and the AFRC.

- 1 Q. How long did you stay in Waterloo?
- 2 A. We spent some time there. I can't remember the time now,
- 3 but we withdrew later.
- 4 Q. While you were in Waterloo, what were your duties there?
- 16:02:02 5 A. I was with Issa. Any report that came from the other
 - 6 securities with whom we were working, I will be there to see that
 - 7 report.
 - 8 Q. And did you receive reports from other securities with whom
 - 9 you were working?
- 16:02:32 10 A. Yes, since the time I was there I saw a report which the
 - 11 commander had sent to Issa Sesay. That is the IO commander who
 - 12 was there.
 - 13 Q. And who was the IO commander at that time?
 - 14 A. It was Christ A Manneh. He was the adjutant who was under
- 16:03:07 **15 him** --
 - 16 THE INTERPRETER: Your Honours, can he repeat the name
 - 17 slowly, the adjutant who was under him.
 - 18 PRESIDING JUDGE: Mr Witness, please repeat the name that
 - 19 you have just given us for the adjutant that was under you. The
- 16:03:24 20 interpreter did not hear it clearly.
 - 21 THE WITNESS: Raymond Katewo.
 - MS HOLLIS:
 - 23 Q. And who was this adjutant? He was an adjutant for whom?
 - 24 A. He was a Black Guard, but IO Black Guard. All of them we
- 16:04:08 25 all used to work together.
 - 26 Q. Now I am going to ask you for some assistance, if you can
 - 27 give it. Can you tell us how to spell this Black Guard
 - 28 adjutant's name?
 - 29 A. No.

- 1 PRESIDING JUDGE: Ms Hollis, we have had IO explained by
- 2 other witnesses, but I am not sure if this witness is using the
- 3 same terminology.
- 4 MS HOLLIS: Thank you, Madam President:
- 16:04:41 5 Q. Now, you said that you got a report from the IO commander.
 - 6 Can you tell us what you mean by 10?
 - 7 A. The IO from Foday Sankoh told us that the IO is an
 - 8 intelligence officer who was also to be on the field working
 - 9 together with the Black Guards to send reports to him.
- 16:05:17 10 JUDGE SEBUTINDE: Ms Hollis, this IO commander was Chris A
 - 11 Manneh? Is that the name?
 - 12 THE WITNESS: Yes.
 - MS HOLLIS: Your Honours, that would be C-H-R-I-S-T, middle
 - 14 initial "A", last name M-A-N-N-E-H.
- 16:05:44 15 JUDGE SEBUTINDE: And this adjutant was Raymond Katewo, or
 - 16 something like that.
 - 17 MS HOLLIS:
 - 18 Q. Can you tell us that name again, Mr Witness?
 - 19 A. Raymond Katewo.
- 16:05:59 20 MS HOLLIS: Your Honours, I would take a chance at
 - 21 phonetics at K-A-T-E-W-0:
 - 22 Q. Now, in addition to this report from the IO commander and
 - 23 the Black Guard adjutant, did you receive any other information
 - 24 while you were there with Issa?
- 16:06:32 25 A. That was the only report I saw.
 - 26 Q. While you were there in Waterloo, did you receive any
 - 27 communications from Buedu, or other areas in Sierra Leone?
 - 28 A. Yes, when we were in Waterloo, when Issa Sesay was there,
 - 29 after Gullit's group had come, Issa Sesay saw one other commander

- 1 who they called Gibril Massaquoi. He told Mosquito that Gullit's
- 2 group had come, but that he saw Gibril Massaquoi among them and
- 3 so Mosquito returned a message to Issa Sesay saying that he
- 4 should try and arrest Gibril Massaquoi in order for him to send
- 16:07:30 5 him to him in Buedu. That was the message that came.
 - 6 Q. And who was Gibril Massaquoi?
 - 7 A. Gibril Massaquoi was one of the commanders in the RUF.
 - 8 Q. And do you know where he trained?
 - 9 A. He was trained in Pujehun.
- 16:08:03 10 Q. Did Sam Bockarie say why Issa Sesay should try to arrest
 - 11 Gibril Massaquoi?
 - 12 A. Well, he said that he, Gibril Massaquoi, had disobeyed him.
 - 13 That was what he said.
 - 14 Q. What happened after you got this communication?
- 16:08:43 15 A. After that Issa Sesay wanted to arrest Gibril Massaquoi,
 - 16 but at that time Superman too was in Waterloo. When Issa when
 - 17 Gibril Massaquoi refused Issa to arrest him, Superman too
 - 18 intervened saying they should not arrest Gibril Massaquoi. So
 - 19 some SLAs who were loyal to Superman and Gibril Massaquoi, all of
- 16:09:16 20 them supported him.
 - 21 Q. Now, can you tell us what month this was happening in?
 - 22 A. I can't recall the month, but it was in 1999 that it
 - happened.
 - 24 Q. And was Issa able to arrest Gibril Massaquoi?
- 16:09:44 25 A. No.
 - 26 Q. Can you tell us how long you and Issa Sesay remained in
 - 27 Waterloo?
 - 28 A. When we were in Waterloo, Issa Sesay planned another attack
 - 29 on to attack Tombo. So we were there when that attack was

- 1 launched, but we were unable to capture the area, so we returned
- 2 to Waterloo.
- 3 Q. And Tombo, where was that?
- 4 A. Tombo was an area was a route from Waterloo when you use
- 16:10:49 5 the peninsula going to Freetown.
 - 6 Q. Why did you plan to attack Tombo?
 - 7 A. Issa wanted us to try to get back to Freetown.
 - 8 Q. Who took part in this attack on Tombo?
 - 9 A. Gullit's group and Issa Sesay's group. They took part.
- 16:11:37 10 Q. And again how long did you remain in Waterloo after this
 - 11 attack on Tombo?
 - 12 A. From that I had to return to Makeni in that same 1999, but
 - 13 I can't recall the month.
 - 14 Q. And, if you know, when did Issa Sesay Leave Waterloo?
- 16:12:21 15 A. All of us returned to Makeni. I can't recall the month.
 - 16 Q. When you say, "All of us returned to Makeni", who do you
 - 17 mean?
 - 18 A. I, Issa Sesay and others.
 - 19 Q. How long did you remain in Makeni after you returned back
- 16:12:44 20 to Makeni?
 - 21 A. I took one month in Makeni. Later I went to Kono.
 - 22 Q. During this one month that you were in Makeni, what were
 - 23 your duties?
 - 24 A. I was with Issa Sesay. I was a security.
- 16:13:21 25 Q. You said that you then went to Kono. Where did you go in
 - 26 Kono?
 - 27 A. I went to Koidu Town.
 - 28 Q. To your knowledge, after RUF and AFRC had recaptured Koidu
 - 29 Town, were there mining operations going on?

- 1 A. Yes, mining was going on.
- 2 Q. And do you know where this mining was going on?
- 3 A. Mining was going on in the Tombodu area.
- 4 Q. And where is Tombodu in relation to Koidu?
- 16:14:17 5 A. Tombodu is not far away from Koidu Town.
 - 6 Q. How did you know about this mining that was taking place in
 - 7 Tombodu?
 - 8 A. I knew. When I came came to Koidu Town, when I was there
 - 9 the mining commander who was there called CO Lion, I used to see
- 16:14:50 10 him organising the civilians to do the mining. I used to see how
 - 11 they were going around the township and the surrounding villages,
 - 12 how they brought those civilians to carry out the mining.
 - 13 Q. And how did they get these civilians to do the mining?
 - 14 A. They captured them around. It was not that they were
- 16:15:19 15 willing to come. They used to capture them around. They were
 - 16 capturing them forcefully.
 - 17 Q. To your knowledge was mining going on in any other areas
 - 18 other than Tombodu at this time?
 - 19 A. Yes, at that time mining was going on in Tongo as well.
- 16:15:44 20 Q. And who was there in Tongo?
 - 21 A. Akim Turay was there and other RUF members were also there.
 - 22 Q. How did you know about this mining going on in Tongo?
 - 23 A. Well, I knew when Issa Sesay came from Makeni and when he
 - 24 came to Kono Town I used to see him sending mining materials
- 16:16:23 25 there. I used to see that.
 - Q. When you say "mining materials", what was he sending there?
 - 27 A. He used to buy shakers, petrol for the machines and food to
 - 28 send them there.
 - 29 Q. And these shakers that he would buy, what were these

- 1 shakers?
- 2 A. That's where the gravel is washed.
- 3 Q. What kind of machines was he buying the petrol for?
- 4 A. Bailing machine to pump water.
- 16:17:12 5 Q. To your knowledge in Tongo who was actually doing the
 - 6 mining?
 - 7 A. Issa Sesay used to replace the commanders. At first, at
 - 8 the time that Akim Turay was there, he sent one person whom they
 - 9 called Peleto to the mine.
- 16:17:59 10 Q. Who was Peleto?
 - 11 A. He was called Amara Peleto. He was in control of the
 - 12 mi ni ng.
 - 13 Q. What was his nationality?
 - 14 A. He is a Sierra Leonean.
- 16:18:13 15 Q. And to what group did he belong?
 - 16 A. He underwent his training in Sierra Leone. He was a junior
 - 17 commando.
 - 18 Q. Of what group?
 - 19 A. The RUF group.
- 16:18:32 20 Q. You said that Peleto controlled the mining. Who actually
 - 21 did the mining of the and what were they mining in Tongo?
 - 22 PRESIDING JUDGE: You have got two questions there,
 - 23 Ms Hollis. Take them one at a time, please.
 - 24 MS HOLLIS:
- 16:18:50 25 Q. What were they mining in Tongo?
 - 26 A. They were mining for diamonds in Tongo.
 - 27 Q. And who was actually doing the mining itself?
 - 28 A. Civilians were captured soldiers were just there to
 - 29 control the civilians, but it was the civilians who were doing

- 1 the mining.
- 2 Q. And how did they get these civilians to do the mining?
- 3 A. Just like they used to do in Kono; they went around to
- 4 capture the civilians.
- 16:19:34 5 Q. Now, you said that it was the soldiers who were there to
 - 6 control the civilians. What do you mean by that?
 - 7 A. That is they just sat by to watch over them as they did
 - 8 what they were doing. They did not partake in the mining, for
 - 9 instance to take up a shovel or a pickaxe to do the mining. They
- 16:20:03 10 just sat by to watch them over.
 - 11 Q. And when you say "watch over them", why were they watching
 - 12 over them?
 - 13 A. So that they will not escape or steal the diamonds.
 - 14 Q. To your knowledge were there any records being kept of the
- 16:20:23 15 diamond mining going on?
 - 16 A. Yes, wherever mining was taking place there was someone who
 - 17 took record.
 - 18 Q. And who would be taking these records in Tombodu?
 - 19 A. In Tombodu it was CO Lion who was taking record records.
- 16:21:05 20 Q. Was there anyone else taking records in Tombodu?
 - 21 A. In Tombodu there was another Black Guard whom they called
 - 22 Gassama Mansaray, he too took record. And Joseph Bakundu. He
 - 23 too was a Black Guard. He used to take records.
 - 24 Q. Can you tell us Joseph's last name again, please?
- 16:21:33 **25** A. Bakundu.
 - 26 MS HOLLIS: Your Honours, I believe that is B-A-K-U-N-D-U:
 - 27 Q. Now, tell us again who was CO Lion?
 - 28 A. CO Lion, he was a Liberian RUF vanguard.
 - 29 Q. And who was Joseph Bakundu?

- 1 A. He was an RUF junior commando.
- 2 Q. How long did you stay in Koidu Town?
- 3 A. I was there for a long time.
- 4 Q. And what were you doing there in Koidu Town?
- 16:22:55 5 A. I was just there. I was not doing anything.
 - 6 Q. And did there come a time when you left Koidu Town?
 - 7 A. Yes, it came to a time when I went to the radio room. At
 - 8 one time the radio operator the radio man told me that the
 - 9 Leader, Foday Sankoh, was going to talk to the commanders.
- 16:23:34 10 Q. And what did you do after you were told this?
 - 11 A. Later I too he told me the time, he said 11 o'clock, so I
 - 12 ensured that at that time I was at the radio office. So I met, I
 - 13 heard Pa Sankoh talking to the RUF commanders. He was talking to
 - 14 Sam Bockarie. He told Sam Bockarie that he should try and
- 16:24:08 15 organise 15 to 17 people who were to meet him in Lome for the
 - 16 peace talks. So through these talks that were taking place I
 - 17 intercepted Foday Sankoh.
 - 18 Q. And please don't use your name, please.
 - 19 JUDGE SEBUTINDE: Ms Hollis, I am not sure where this is
- 16:24:32 20 taking place because you asked the witness did there come a time
 - 21 when he left Koidu Town and he said yes. And then where did he
 - 22 go? He said to the radio room. Where is this radio room?
 - 23 MS HOLLIS: Thank you, Justice Sebutinde:
 - Q. Can you tell us, please, this radio room that you went to,
- 16:24:52 25 where was it?
 - 26 A. It's in Koidu Town. That was where the radio room was.
 - 27 Q. Now, you were telling us that Foday Sankoh was speaking to
 - 28 Sam Bockarie and that at some point you intercepted. What do you
 - 29 mean?

- 1 A. After Foday Sankoh had spoken to Sam Bockarie, I
- 2 intercepted. I told Foday Sankoh that I was the one talking, so
- 3 later he told Sam Bockarie that he wanted me to join that same
- 4 group that was to meet him in Lome. He said he would like me to
- 16:25:41 5 be among them. So later I met Sam Bockarie in Buedu to go.
 - 6 Q. Now, how long did you stay in Buedu before you left for the
 - 7 peace talks?
 - 8 A. I was there for a long time.
 - 9 Q. And why were you waiting there for a long time?
- 16:26:14 10 A. When we got to Buedu we had meetings. Mosquito called a
 - 11 meeting where he told the people who were at that meeting, he
 - 12 said that the leader, who was Foday Sankoh, had told him that he
 - should organise 15 to 20 people to go and meet him in Lome for
 - the peace talks, so he said he was to appoint these people to go
- 16:26:46 15 and meet him. So at this meeting Mosquito appointed the people
 - 16 who were to go and meet Foday Sankoh in Lome. He appointed SYB
 - 17 Rogers, who was to head this delegation. Mike Lamin was to be
 - 18 among. Leather Boot too was to be among. He was to go there to
 - 19 represent the SLAs. Lawrence Womandia was among them. There was
- 16:27:30 20 a woman, Agnes, Mosquito said she was to go to become a secretary
 - 21 to Pa Sankoh. Juni or Vandi, a Black Guard, was there. Daf was
 - 22 there, Dauda Fornie, who was the radio operator who was to take
 - the radio along. Jalloh, an SLA, and Rashid Sandy who was the
 - 24 adjutant general and some other people whose names I cannot
- 16:28:03 **25** recall.
 - 26 Q. And who was Lawrence Womandia?
 - 27 A. Lawrence Womandia was one of the vanguards who trained in
 - 28 Camp Naama in Liberia.
 - 29 PRESIDING JUDGE: Ms Hollis, I am afraid we have been

	1	alerted to the time. The tape is about to run out and so I hope
	2	this is a convenient point to adjourn the witness's evidence.
	3	MS HOLLIS: We will make it a convenient point.
	4	PRESIDING JUDGE: Mr Witness, we are now going to adjourn
16:28:41	5	for the day. We finish at this time. However, I wish to remind
	6	the parties that tomorrow the judges will be attending the
	7	International Criminal Court conference, so there will be no
	8	sitting tomorrow. Mr Witness, we are adjourning now until Friday
	9	morning at 9.30. I must tell you that now that you have taken
16:29:04	10	the oath you are not to discuss your evidence with any other
	11	person until all your evidence is finished. Do you understand
	12	this?
