I notice a change of 09:15:51 5 appearances. 6 7 MS ALAGENDRA: Good morning, your Honours. For the Prosecution is Brenda J Hollis, Julia Baly, myself, Shyamala 8 9 Alagendra, Christopher Santora and Maja Dimitrova. Thank you, 09:31:12 10 your Honours. MR ANYAH: Good morning, your Honours. Good morning, Madam 11 12 President. 13 PRESIDING JUDGE: Good morning, Mr Anyah. 14 MR ANYAH: For the Defence is Mr Terry Munyard and myself, 09:31:23 15 Morris Anyah. PRESI DI NG JUDGE: Thank you. If there are no other matters 16 17 I will remind the witness of her oath? No. Good morning, Madam 18 Witness. 19 THE WITNESS: How is the morning? 09:31:43 20 PRESIDING JUDGE: Very good, thank you. I would like to 21 remind you that yesterday you took the oath to tell the truth, 22 the oath is still binding on you and you must answer questions 23 truthfully. Do you understand? THE WITNESS: Yes, sir. 24 09:32:00 25 PRESIDING JUDGE: Please proceed. 26 WITNESS: TF1-028 [On former oath] 27 EXAMINATION-IN-CHIEF BY MS ALAGENDRA [Cont.]: 28 Q. Good morning, Madam Witness. 29 Yes, how is the morning? Α.

1 Q. Madam Witness, we are going to continue from where we left 2 off yesterday, but before we do so there are a few issues I want 3 to clarify from your answers yesterday. Do you understand? 4 Α. Yes, sir. You told the Court yesterday that in 1998, at the time of 09:32:28 5 0. the intervention, you were living in Karina. Can you tell the 6 7 Court where Karina is? Yes, but before I say anything I have something to 8 Α. Yes. 9 Yesterday, when I came in yesterday I was seriously upset say. because when I came the woman, who is the boss, since I came I 09:32:57 10 was sick for about three days and by rights I was supposed to 11 12 report to the ones who brought me here when I was sick, but when 13 I reported to this woman the woman did not do anything about it, 14 but later when we went to hospital the doctor said I will die at 09:33:22 15 any time because he said I am suffering from a heart disease, but when I explained to the woman, the woman did not go there. 16 Si nce 17 I came the woman has not been there. But it was only yesterday that when I came I explained that it was only in five minutes 18 19 time that she came in. 09:33:45 20 THE INTERPRETER: Your Honours, the witness is running too 21 fast. 22 PRESIDING JUDGE: Madam Witness, could you speak more slowly so that the interpreter can hear and interpret what you 23 24 are saying. 09:33:58 25 THE WITNESS: Okay, sir. So should I repeat? PRESIDING JUDGE: Please continue from when you were saying 26 27 "it was only in five minutes that she came in". 28 THE WITNESS: Okay. When she came in yesterday she was 29 then trying to encourage me and then I told her not to encourage

1 me because she merely came to provoke me. So it was as a result 2 of that yesterday that I was upset yesterday. So, please, I am 3 appealing to all of you so that we will start afresh from where 4 we started yesterday, because actually yesterday I was upset 09:34:41 5 seriously. JUDGE LUSSICK: Well, Ms Alagendra, do you feel comfortable 6 7 calling this witness to give evidence, putting her through this ordeal, when she says that she has got heart disease and could 8 9 die at any time? MS ALAGENDRA: Your Honours, these are matters we discussed 09:35:03 10 with the witness and she indicated she was willing to testify. 11 12 THE WITNESS: Yes. 13 PRESIDING JUDGE: Madam Witness, what are you saying yes 14 to? 09:35:27 15 THE WITNESS: I am ready to testify because I know that is 16 the reason that brought me here. 17 JUDGE SEBUTINDE: Madam Witness, we as the judges have noted your concerns and we did notice you were upset yesterday. 18 19 However, we hope that you are feeling better today. Are you 09:35:51 20 feeling better today? 21 THE WITNESS: Yes, sir. 22 JUDGE SEBUTINDE: Okay then. 23 THE WITNESS: I am feeling better. 24 JUDGE SEBUTINDE: These concerns that you have raised are 09:36:04 25 to be handled by a different department, the witness and victims 26 support unit, and the head of office I am sure will handle these, 27 your concerns. So thank you for letting us know and I think we 28 are ready to proceed. 29 THE WITNESS: Yes, sir.

1 MS ALAGENDRA: Your Honours, the witness had indicated that 2 she wanted us to start afresh from yesterday, so I am not sure 3 whether the Court is going to entertain that request, or we --4 PRESIDING JUDGE: Madam Witness, we appreciate what you are saying and I am obviously glad that you are feeling a lot better. 09:36:36 5 We understood well what you said yesterday and only if you feel 6 7 there was something you did not make clear, there won't be any 8 real reason to repeat it, but if there is something you feel you 9 want to make clear, please do so. Proceed on, Ms Alagendra. MS ALAGENDRA: Thank you, your Honours. 09:36:59 10 THE WITNESS: But how would I understand if she does not 11 12 repeat the questions that she asked yesterday? 13 PRESIDING JUDGE: In the circumstances, Ms Alagendra, you 14 proceed as you consider appropriate. 09:37:21 15 MS ALAGENDRA: Your Honours, if I may suggest I was going to clarify a few issues from her testimony yesterday and remind 16 17 her about what she said. PRESIDING JUDGE: Indeed, please do so. 18 19 MS ALAGENDRA: Thank you, your Honours: 09:37:34 20 0. Madam Witness, what I am going to do is I am going to 21 clarify a few issues that arose from your testimony yesterday and 22 then we will proceed from there. Do you understand? 23 Yes, sir. Α. 24 Q. You told the Court yesterday that in 1998, at the time of 09:37:55 25 the intervention, you were living in Karina. Can you tell the 26 Court where Karina is? 27 Α. Yes, sir. 28 Q. Please do so, witness? 29 It is in Bombali District. Α.

1 Q. You also testified that around the time of the intervention 2 the junta came into Karina and you described the junta as 3 soldiers, out of which some wore combat and some wore civilian 4 clothes, and you told the Court that at the time you did not know who the leader of the group that came to your town was. Do you 09:38:37 5 recall that? 6 7 Α. Yes, sir. Witness, you told the Court yesterday - and these were your 8 Q. 9 words - you said, "The junta went to the town in the morning hours. In the evening at night they came to the town at about 9 09:38:55 10 at night." Could you clarify for the Court what time did these 11 12 junta come to your town? 13 Α. Yes, sir. Please do so, witness? 14 Q. 09:39:14 15 Α. The junta came to Karina in the morning and then in the evening around 9 o'clock they came in again. 16 17 Q. When these junta came to Karina Town in the morning, did 18 anything happen? 19 Yes, sir. Α. 09:39:38 20 Q. What happened? 21 They went on capturing people, beating up people. Α. They 22 even captured my elder brother and he was beaten up. 23 You told the Court yesterday that your elder brother was 0. 24 beaten and they sprinkled plastic on his body. What did you mean 09:40:02 25 by that, witness? 26 When they captured him they were beating him up and then Α. 27 they set fire on the plastic and they were dropping it on all 28 over his body. 29 You also told the Court that his 12 year old child was Q.

When you rushed and saw these two girls, what did you see? 8 Q. 9 Α. I saw blood and they were naked. Did you know what exactly had happened to them? 09:46:01 10 Q. Yes, raped them. 11 Α. 12 Q. Did they describe to you what happened to them? 13 Α. At that time the girls did not talk anything, but because 14 they were all nervous, but looking at them at that time I knew 09:46:27 15 that they were raped. Did you know who had raped those two girls? 16 Q. 17 I was not present when they were raped, but the girls said Α. it was juntas who raped them and they were the only people who 18 19 were in the town. They were the only people capable of doing 09:46:50 20 that. 21 0. Do you recall on that day how many girls were raped by the 22 junta? 23 In our own area that day I knew about three people. In Α. 24 other areas they said something like that, but I did not see them 09:47:07 25 myself. 26 Q. And when you say the other areas, what areas are you 27 referring to? 28 Α. Karina Town. It's because of the distance that I said "the area". 29

1 Q. Did anything else happen that day in Karina? After they had raped them then they returned. 2 Α. 3 Q. After this day, witness, do you recall if anything else 4 happened in Karina Town? Yes, around 9 o'clock at night. 09:47:48 5 Α. Q. Was it the same day? 6 7 Α. Yes, sir. What happened around 9 o'clock at night that day? 8 Q. 9 Α. At that time we had all entered and we were going to sleep, because at that time people didn't actually get good sleep, sound 09:48:12 10 They all came again and then they broke into houses and 11 sleep. 12 they took all our properties. They even put me at gunpoint and 13 from there they went to other people's houses and then they broke 14 into their houses and took their properties, because they brought vehicles and they took the properties on board the vehicles and 09:48:41 15 16 went. 17 Q. Witness, when you say they put you under gunpoint and they 18 were taking properties from people's houses, who are you talking 19 about? 09:48:53 20 Α. Juntas. 21 At this time, witness, how many houses were there in Karina 0. 22 Town, do you recall? 23 Α. Yes, sir. 24 Q. How many? 09:49:08 25 Α. 170 houses. 26 MS ALAGENDRA: Your Honours, just to be clear I heard the 27 witness saying 117 houses. 28 THE WITNESS: Yes, 117. MS ALAGENDRA: 29

1 Q. Witness, do you recall from how many houses the junta took 2 property from that day? 3 Yes, it did not happen - I cannot recall what happened all Α. 4 over the town, but in our own area I can recall the name of the people. Like my brother's house, my other brother's house and 09:49:54 5 the surrounding area, they looted about eight houses. They took 6 7 property and put them on board a vehicle. What did they put on board the vehicle? 8 0. 9 Α. My box, I had some of my clothes inside, and there was a 09:50:24 10 woman whose box they tabled --THE INTERPRETER: Your Honours, could the witness slow down 11 12 a little. 13 PRESIDING JUDGE: Madam Witness, because what you are 14 saying is being interpreted we need you to speak a little more 09:50:40 15 slowly so the interpreter can keep up. So I would like you to go back to the answer you were giving and start again from the point 16 17 where you said, "And there was a woman whose box they" and then continue from there, please. 18 19 THE WITNESS: Yes. A woman had her petty business in the 09:51:06 20 box, her wares in the box, and they took it away. 21 MS ALAGENDRA: 22 Witness, when the junta came to your house, put you under 0. 23 gunpoint and were taking your property, do you recall if they 24 said anything to you? 09:51:24 25 Α. Yes. 26 Q. What did they say? 27 Α. They said Operation Pay Yourself. 28 Q. Did they say anything else about this Operation Pay 29 Yoursel f?

During the two weeks do you recall if anything happened? Q. 6 7 Α. Yes, sir. What happened? 8 Q. 9 Α. Well, when they came to the town they said the town chief should lodge them. Then the town chief told them that he did not 09:54:28 10 have any place to lodge them and then they said they would lodge 11 12 themselves. 13 0. What did they do after they said they will lodge 14 themsel ves? We had an upstairs building there where Dr Sherrif had his 09:54:50 15 Α. clinic. They broke into the place and entered there. They based 16 17 there. 18 Q. Where exactly is this building, witness? 19 It is an upstairs building, a storey building. It's in Α. 09:55:16 20 Karina Town. Q. 21 After the RUF and the soldiers based in this building, did 22 anything else happen in Karina Town? 23 Yes, sir. Α. 24 Q. What happened? 09:55:32 25 Α. They went and took people's properties, they cleared 26 people's properties in Karina and then they went to the other 27 villages and took people's properties from there and they brought 28 them. 29 Q. The people's property who was being taken, who was taking

Yes, it was the RUF and the junta, because they were mixed 09:59:01 10 living in the house there. How do you know these two girls were raped? 11 Q. 12 PRESIDING JUDGE: Madam Witness, would you like to take 13 some water? Perhaps the WVS can help the witness. Would you 14 like to take a break, Madam Witness? Would you like to take a 09:59:53 15 break now? I think in the circumstances the witness seems very overwrought and so we will take a brief break and allow her to 16 17 compose herself and perhaps someone can report to us how she is. 18 We will take a break until the witness feels better. 1 we would like to put on record that we had checked with WVS and 2 what we were told was that the witness was not only willing to 3 testify but she wants to testify, your Honour. 4 THE WI TNESS: Okay. MS ALAGENDRA: 10:22:25 5 Madam Witness, we are going to continue from where you were Q. 6 7 talking about the two girls that were raped, your daughter and your sister's daughter, okay? 8 9 Α. Yes, sir. When you say those two girls were raped, can you explain 10:22:42 10 Q. what you mean, witness? 11 12 Α. Yes, sir. 13 0. Please explain. 14 Α. When the girls were captured, when they wanted to rape them 10:23:00 15 they placed them under gunpoint and they raped them. The raping that I am talking about is that they were damaged in the vagina 16 17 and they were bleeding. I myself checked them and I saw the 18 infection. 19 Did anything else happen in Karina during these two weeks? Q. 10:23:29 20 Α. Yes, sir. 21 0. What happened? 22 The people, the juntas, went back, but as they were going -Α. 23 they said as they were going they would come back to Karina. Did anything happen after they left? 24 Q. 10:24:03 25 Α. Yes. 26 Q. What happened? 27 Well, I and my elder brother were outside late that day in Α. 28 Karina and at daybreak I came out and I saw fire - a big fire in 29 the other village.

	28	water, do you recall what time it was?

1 Q. What time was it? 2 Α. Around 5 o'clock. 3 Q. Was that in the morning, or in the evening? 4 Α. Morning. How is it you were able to know the time? 10:27:12 5 0. Α. Because I had prayed. 6 7 0. When you entered the house, what happened? My girl - my daughter had opened the window and she said, 8 Α. 9 Mama, come and see the population that is passing by. Look at my aunt, she has oozing and his jaw and she was naked - on her jaw, 10:27:38 10 sorry, and she was naked. 11 12 Q. Did you know who she was referring to? 13 PRESIDING JUDGE: Mr Anyah? MR ANYAH: Yes, Madam President, I hesitate to intervene 14 10:28:02 15 and interrupt the flow, but I do so with respect. I had made an objection previously about evidence not alleged in the indictment 16 17 and I made that a continuing objection. This was perhaps two 18 weeks ago. 19 In this case Karina is in Bombali District, which is 10:28:27 20 charged in the indictment, but it's only charged in paragraph 30 with respect to looting. So I just reiterate my objection 21 22 respectfully, knowing that the Court has ruled on the objection, but given the extensive nature of evidence being presented today 23 24 about this particular locale and concerning acts not alleged in 10:28:50 25 the indictment I thought it appropriate to renew my objection. 26 PRESIDING JUDGE: Your reply? 27 MS HOLLIS: Madam President, with leave if I may respond? 28 PRESIDING JUDGE: Yes, please do. Madam President, your Honours, this evidence MS HOLLIS: 29

and evidence of its kind that will in the future be offered to
 this Court is relevant to this case and admissible for a variety
 of reasons. First of all, although the Court has judicially
 noticed that there was an armed conflict, it has not judicially
 noticed crimes against humanity. It has not judicially noticed
 widespread or systematic attack. It is relevant for that.

7 Secondly, it is relevant within the contextual elements of 8 crimes against humanity for the purpose of showing that this was 9 a part of crimes against humanity, that the charged crimes were part of crimes against humanity. They were part of this attack. 10:29:47 10 It is also relevant to prove that there was a campaign of terror 11 12 and that there were not isolated acts by rogue commanders, or 13 rogue persons, but rather that this type of conduct was carried 14 out throughout Sierra Leone over a period of time, showing both a campaign of terror within the time period alleged. So it is 10:30:15 15 relevant for that as well. 16

17 It is also relevant to prove various forms of liability; in
18 particular joint criminal enterprise. It shows, over a period of

	26	A. They wrote on their guns "RUF" and the boys who were with
	27	them they wrote on their chests "RUF".
	28	Q. When you say they wrote on the chests of boys who were with
	29	them, do you mean they wrote on the chests of civilians who were

The

1 with them "RUF"? 2 Yes, the boys who - the boys whom they captured. Α. civilian boys. 3 4 Q. Thank you, Madam Witness. So Med Bajehjeh was RUF and you've testified today that the rest of his group were also RUF, 16:19:34 5 yes? 6 7 Α. Yes, sir. When this group of 70 fighters joined you at Colonel Eddie 8 0. 9 Town, would it be fair to say that at that time you had on the one hand the SLAs with a few number of RUF that brought you all 16:19:54 10 the way from Karina to Colonel Eddie Town and then you had these 11 12 new arrivals made up of about 70 RUF fighters? 13 Well the RUF from Karina, there was only one among them. Α. 14 That is the junta boy with whom I was. 16:20:20 15 0. That's fair enough. What you are saying is that of the entire group that brought you from Karina all the way to Colonel 16 17 Eddie Town there was only one RUF person and that was your junta man, right? 18 19 Α. Yes, sir. He was the one I saw, sir. 16:20:40 20 0. Madam Witness, do you understand what I'm asking you? I am

21 trying to find out whether there was only one RUF member among 22 the entire group of fighters who took you and other civilians 23 from Karina all the way to Colonel Eddie Town. Was it just this 24 one junta person that was the RUF member of this group? 16:21:04 25 Α. He was the only one whom they showed to me that he was an RUF. 26 27 Q. Thank you, Madam Witness. It would then be fair to say 28 that the rest of them as you've described previously were SLAs, 29 or former members of the Sierra Leone Army, yes?

1 MS ALAGENDRA: I would object to this, your Honours. The 2 witness has said that was the only one that was shown to her to 3 be an RUF. That does not lead to the assumption that all the 4 others were SLA. PRESIDING JUDGE: I agree with that observation, Mr Anyah. 16:21:34 5 To me it does not naturally follow, but you can put the question 6 7 in some other way to elicit a clarification of the point. I understand the objection and I will rephrase 8 MR ANYAH: 9 it. I will just observe that prior to this it had been 16:21:51 10 established by questions to the witness that the group was made up of former SLA members, but I will rephrase the question. 11 MS ALAGENDRA: Your Honours, just on that point the 12 13 evidence about the attack in Karina included the RUF, your 14 Honour, and given time I can get that out of the transcript if 16:22:06 15 necessary. PRESIDING JUDGE: Ms Alagendra, we're dealing with this 16 17 part at the moment. I do recall what you're saying. 18 MR ANYAH: 19 0. Madam Witness, are you tired? Do you wish to take a break, 16:22:23 20 Madam Witness, because I have a number of questions left for you? 21 PRESIDING JUDGE: We can continue, Mr Anyah. The witness 22 has indicated she is able to continue. THE WITNESS: Yes, sir. 23 24 MR ANYAH: 16:22:34 25 Q. When you say, "Yes", Madam Witness --26 Α. I should take a break. 27 I'm in the Court's hands, Madam President. MR ANYAH: 28 PRESIDING JUDGE: Mr Anyah, you said you have a few -29 what's your words? "I have a number of questions left". When

1 you say "a number" do you mean a lot, or a few? 2 MR ANYAH: I'm just starting my examination, Madam 3 President. That's what I meant. 4 PRESIDING JUDGE: We had in mind to make up some time by staying on if the witness felt capable of doing it. 16:23:37 5 MR ANYAH: Whatever pleases the Court. I am here. 6 7 PRESIDING JUDGE: Madam Witness, would you be able to answer any more questions this afternoon? 8 9 THE WITNESS: Yes, sir. PRESIDING JUDGE: We can continue for a while, Mr Anyah. 16:23:53 10 THE WITNESS: If the questions are not much, I'll try. 11 12 PRESIDING JUDGE: That's very good. We are able to sit on 13 until 5, as you know, but we will keep our eye on Madam Witness 14 and make sure she's all right. 16:24:12 15 MR ANYAH: Thank you, Madam President: Madam Witness, I am trying to ascertain - and I recall 16 Q. 17 you've said this, but correct me if I'm wrong - how many RUF 18 members were part of the group that brought you from Karina all 19 the way to Colonel Eddie Town. Was it just one RUF member? 16:24:38 20 Α. Well I can't say he was the only one among the junta, but 21 he was the only one whom I saw. That's the person I called. 22 0. Was he the only one you knew about as being an RUF member 23 amongst this group? 24 Α. Yes, sir, from Karina to Rosos. 16:25:00 25 Q. What did you know the rest of the group to be made up of? 26 Α. They were junta. 27 Q. When you say the rest of the group were junta do you mean 28 they were SLAs, Madam Witness? 29 Yes, sir. Α.

1 Q. Thank you, Madam Witness. We're back to Colonel Eddie Town 2 and the arrival of these 70 Red Lion group members. You said 3 some of them were Liberians, yes? 4 Α. Yes, sir. And you determined that, you said, because of the way they 16:25:48 5 0. spoke, true? 6 7 Yes, sir, and I had lived with Liberians. Α. 8 0. You also knew a little bit about this group from, you said, 9 two women who were cooking or working for them, yes? Yes, sir, and the day they came, the signs that they 16:26:15 10 Α. showed, I knew that they were the RUF because they showed me all 11 12 the signs. 13 Q. Did you believe these men to be Foday Sankoh's men? MS ALAGENDRA: Your Honour, it hasn't been established 14 16:26:42 15 whether this witness knows who Foday Sankoh is. THE WITNESS: No, sir, I know that they were Superman's men 16 17 because when they came they said they were Superman's group. 18 MR ANYAH: 19 0. Have you told the Office of the Prosecution before that 16:27:03 20 they were Foday Sankoh's men? 21 I did not tell them that. I had spoke about Superman. Α. 22 MR ANYAH: Your Honours, I will with leave of the Court pass out a few documents to the Bench, as well as to counsels 23 opposite and to the witness, and I will just request that none of 24 16:28:25 25 these documents be placed on the overhead projector. Nothing 26 should be published: 27 Q. Madam Witness, I recall you telling us about how far you 28 went in school when you started testifying. Would it be fair to 29 say that if I wanted to show you a document you would prefer for

me to read it to you?

1

Read it out to me, sir. 2 Α. 3 Madam Witness, you've just told us that the Red Lion group Q. 4 was Superman's group, yes? Yes, sir. 16:29:26 5 Α. Your Honours, I would first refer the Chamber MR ANYAH: 6 7 and counsels opposite to tab number 8 of the bundle of documents: Madam Witness, I will just read to you what you told the 8 Q. 9 Prosecution before in respect of the Red Lion group and these are interview notes from 23 November 2007. Madam Witness, this is 16:29:58 10 about six months ago and indeed you did tell them - you said in 11 12 respect of the Red Lion group it says, "Witness explained ...", 13 or rather let me set the foundation, if it please the Chamber. 14 Madam Witness, of the two women who worked with the Red Lion group you were closer with one of them than the other, yes? 16:30:38 15 16 Α. Yes, sir. Yes, sir. 17 Q. And that one was a wife or girlfriend of Med Bajehjeh, the commander of the group, yes? 18 19 Α. Yes, the woman he captured to rape. 16:31:03 20 Q. And that woman told you about the make-up of the group and 21 you then told the Prosecution --22 Yes, sir. Α. 23 And you then told the Prosecution what that lady had told 0. 24 you about the constitutive make-up of this group, yes? 16:31:24 25 Α. Yes, sir. 26 Q. And what you told the Prosecution six months ago in 27 November is you said that lady told you that the group was sent 28 by Superman, yes? 29 Yes, sir. Α.

1 MR ANYAH: Your Honours, I'm at paragraph 2 of page 1 of 2 tab 8, ERN number 00045227" 3 Q. Now, that is what that woman told you. She said Superman 4 sent these fighters, yes? Yes, sir, and I got it from the other juntas. 16:32:03 5 Α. Now, Madam Witness, you met with the Prosecution less than Q. 6 7 a month ago in April. 8 Your Honours, I'll be referring to tab number 10 and that 9 would be page 3. The ERN number is not too clear, but I believe 16:32:36 10 it is 00100499. The document in its totality are interview notes from proofing sessions with the witness on 14 and 15 April 2008. 11 12 Madam Witness, the Prosecution took some notes when you met with them last month and on page 3 of the ones for 14 and 15 13 14 April it says that you told them this and I'm reading from 16:33:19 15 paragraph 18, your Honours: "Rebels were dressed in civilian clothes and tied their 16 17 heads with red bands. Witness knew that Foday Sankoh was the overall leader of the group. The Red Lion Battalion was the 18 19 group of Foday Sankoh. RUF were separate from SLA soldiers and 16:33:34 20 were distinguished by red bandages around the head." 21 Madam Witness, the Prosecution has you saying last month 22 that the Red Lion Battalion was the group of Foday Sankoh, yes? 23 No, Red Lion Battalion was sent by Superman. Α. 24 Q. They have you saying that you knew that Foday Sankoh was 16:34:12 25 the overall leader of the group. Can you explain why they would 26 have that as you telling - why they would say you told them that 27 last month? 28 MS ALAGENDRA: Your Honour, the witness has just spoken 29 about a group sent by Superman, which is different from who the

1 overall leader was. 2 PRESIDING JUDGE: I think counsel is entitled to put that 3 question. 4 MR ANYAH: Madam Witness, we have been speaking about the Red Lion 16:34:42 5 0. group. 6 7 Α. Yes, sir. And we have agreed that you have said previously that you 8 0. 9 were told by a lady that they were sent by Superman? 16:35:03 10 Α. No, I explained to them that the way they were suffering in terms of food, the Red Lion Battalion, it was the juntas that 11 12 explained to me. 13 Q. You just said - a few minutes ago you confirmed that one of 14 the two ladies who were working for the junta - for the Red Lion 16:35:28 15 group - told you that Superman sent that group, yes, Madam Witness? 16 17 I first knew that it was Superman who sent that group Α. 18 before the lady told me. 19 Well regardless of how you knew it, do you agree that 0. 16:35:46 20 you've said previously that Superman sent that group? 21 Yes. Α. 22 And now - I'm sorry, go ahead, Madam Witness. 0. 23 I just wanted to say that it was Superman who sent the Α. 24 group. If there was an overall commander who was this man Foday 16:36:13 25 Sankoh, no. The one who sent the group, that is the Red Lion, it 26 is Superman that I know. 27 Q. We know that now and you said it before. I'm just 28 wondering if you could help us why does the Prosecution say that 29 last month you told them that the Red Lion Battalion was the

1 group of Foday Sankoh? MS ALAGENDRA: Your Honour, I raise the same objection, 2 3 which is still different from who sent the group. 4 MR ANYAH: Madam President, with respect I understand the distinction counsel is trying to make. I'm entitled to ask my 16:36:49 5 questions on cross-examination. 6 7 PRESIDING JUDGE: Ms Alagendra, the question relates to what was said in a record of interview, not whether the witness 8 9 knew one person or another person, and I am going to ask the 16:37:09 10 witness if she understands the question and if she understands the question then it should be answered. 11 12 MS ALAGENDRA: Your Honours, if I just may address you on 13 one issue? The point I was trying to make was that it's being 14 put to the witness as a contradiction, when in fact it's not a 16:37:25 15 contradiction. PRESI DI NG JUDGE: 16 Please explain. 17 JUDGE LUSSICK: I see what you mean, Ms Alagendra, and perhaps, Mr Anyah, that could be cleared up if it's ascertained 18 19 that the witness is saying that it was Superman who sent the 16:37:48 20 group, but that it was Foday Sankoh's group. 21 I understand the distinction and I'd be happy to MR ANYAH: 22 clarify it with questions: 23 Madam Witness, we know who sent the group and I'm not 0. 24 asking you now who sent the group. What I want to know is whose 16:38:12 25 group was it? The Prosecution says you told them the group was 26 Foday Sankoh's group. Did you tell them that last month? 27 I did not - I know that it was Foday Sankoh that was the Α. 28 overall commander for the RUF, but the main person who sent that 29 group was Superman.

1 Q. I understand, Madam Witness. We know Superman sent the 2 group and that Foday Sankoh is the overall RUF commander. Woul d 3 you say, as you sit there now, that because Foday Sankoh was 4 overall RUF commander the Red Lion group was Foday Sankoh's 16:38:53 5 group? Α. Yes, because I know that they are all in the same group. 6 7 Thank you, Madam Witness. Madam Witness, these 70 men that 0. came, you said they were well armed, yes? 8 9 Α. Yes, sir. You did not know where they got their arms from, correct? Q. 16:39:26 10 Yes, sir. I did not know where from, sir. 11 Α. 12 Q. You said you had heard previously from other RUF fighters 13 that Superman was their commander, yes? 14 Α. Yes, sir. Even those who came, that was the introduction 16:40:02 15 that they did to the other rebels, the juntas. Did you know that Superman was Liberian? 16 Q. 17 Α. Yes, sir. 18 How did you know that, Madam Witness? Q. 19 Well, the juntas whom I - the junta man with whom I was Α. 16:40:29 20 told me that Superman was a Liberian and the force that he sent 21 were speaking Liberian language. 22 Q. You said that group came from Kurubonla, yes? 23 Α. Yes, sir. 24 Q. Have you ever heard the name Komba Gbundema, Madam Witness? 16:41:02 25 Α. Yes, sir. 26 Q. When have you heard that name before? 27 Well, I heard about Komba Gbundema in Makeni. Α. 28 Q. In what context did you hear the name Komba Gbundema in 29 Makeni?

1 Α. It was at the time that the capture of the UNAMSIL. 2 Q. Do you know whether any of the 70 men that you say were 3 sent by Superman were Komba Gbundema's men? 4 Α. No. Besides these two groups --16:42:02 5 0. JUDGE SEBUTINDE: I don't understand that answer. 6 7 JUDGE LUSSICK: That needs be cleared up. MR ANYAH: I will do so: 8 9 0. Madam Witness, when you say you do not know - when you gave the answer "No" to the question I just posed, which is, "Were any 16:42:16 10 of those 70 men Komba Gbundema's men?", what did you mean, Madam 11 Wi tness? 12 13 They did not tell me that Komba Gbundema was the leader who Α. 14 sent them there. I even knew - I came to know Komba Gbundema in Makeni. That's where I knew his name. 16:42:38 15 I understand that nobody told you Komba Gbundema may have 16 Q. 17 sent any of these men. What we wish to know is whether these two ladies who told you about the Red Lion group mentioned Komba 18 19 Gbundema's name in connection with that group? 16:43:10 20 Α. No. Madam Witness, you have heard of something called the STF 21 0. 22 before, yes? 23 Α. Yes, sir. 24 Q. STF stands for Special Task Force, yes? 16:43:32 25 Α. Yes, sir. 26 Q. Have you heard the name Bropleh - David Bropleh - before, 27 Madam Witness? 28 Α. No, sir. 29 Have you heard the name General Bropleh before? Q.

1 A. No, sir.

2 Q. The STF were present at Colonel Eddie Town when you were3 there, yes?

4 A. No, sir. The only place I heard STF when they attacked 16:44:19 5 Karina when they said "STF advance".

6 Q. Do you know who the leader of the STF, or the commander of7 the STF, was?

8 A. No.

9 Q. Madam Witness, the prior case that you testified in in
16:44:41 10 March of 2006, do you remember telling the Court that this Red
11 Lion group was made up mostly of STF members?

12 A. No, I did not say that.

13 MR ANYAH: Your Honours, if it please the Court I would direct the Chamber to tab number 6, which is a transcript from a 14 16:45:20 15 prior proceeding in the Special Court, and the page in question is page 53. I believe although the witness testified in open 16 17 session, as I see at the top of the page, she was entitled to the same protective measures and so I think I can put the date of the 18 19 transcript on the record. I don't see that that would pose any 16:46:09 20 concerns.

MS ALAGENDRA: There are no concerns on that, your Honour.
PRESI DI NG JUDGE: PI ease proceed, Mr Anyah.

23 MR ANYAH: Yes, thank you, Madam President. These
24 transcripts are from the session of Monday, 20 March 2006 in the
16:46:27 25 Sesay, Kallon and Gbao case. The RUF case:

Q. Madam Witness, when you testified on 20 March you were
asked certain questions before the other court and you gave
certain answers. This is Wayne Jordash, counsel for Issa Sesay,
asking you questions. On page 53 you were asked this question

1 and I will start from line number 3: "0. 2 Because I suggest to you that CO Med was an STF and not an RUF? 3 Well, I don't know the name of STF. It is about RUF I 4 Α. 16:47:10 5 knew. Well, you have agreed that the majority of the people Q. 6 7 in the Red Lion Battalion were STF? Yes, according to what the woman told me." 8 Α 9 Madam Witness, last year you told - well, two years ago you 16:47:30 **10** told another session of the Special Court that the majority of the people in the Red Lion Battalion were STF according to what a 11 12 woman told you. Have you heard what I read, Madam Witness? 13 I did not tell him that. I told him that the Red Battalion Α. 14 was RUF. 16:47:55 15 0. Are you saying what I have just read to you is an error, Madam Witness? 16 17 Well he made a mistake, but what I told him is I told him Α. that the Red Battalion was RUF. 18 19 Do you maintain that there were no STF at Colonel Eddie 0. 16:48:20 20 Town when you were there and these Red Lion supposedly arrived? The only place that I talked about STF, it was at that time 21 Α. 22 that they attacked Karina when they were saying "STF advance". That was when I touched on that. 23 24 Q. Can we go to page 51 of the same transcript, two pages 16:48:48 25 before. Madam Witness, this is also from the same transcript, 26 still Mr Jordash asking you questions about the Red Lion group and I will start from line 3 - rather line 4, the question there. 27 28 Madam Witness, you were asked this question: "Q. 29 The Red Lion group, is that correct?

	1	A. Yes, sir. That was the second group, sir.
	2	Q. Is it right that this was also called the Red Lion
	3	Battalion?
	4	A. Yes, sir.
16:49:18	5	Q. Did you come to learn of a distinction between men
	6	who'd been previously Sierra Leonean Army Officers and men
	7	who were part of what was called the Special Task Force?
	8	Did you learn about that difference?
	9	A. Yes, sir.
16:49:38	10	Q. Am I right that the Red Lion Battalion consisted mainly
	11	of Special Task Force personnel?
	12	A. Yes, sir."
	13	Madam Witness, they have you twice on the same day saying
	14	that the Red Lion Battalion was made up mostly of Special Task
16:49:58	15	Force personnel. Do you agree, Madam Witness?
	16	A. No.
	17	Q. You do not agree that that is what this transcript says, or
	18	you do not agree that that was in fact the case?
	19	A. It's not true. The Red Lion Battalion, when they say the
16:50:21	20	Red Lion Battalion, it's the RUF. All their guns that they had,
	21	they wrote "RUF" on it. All the boys had "RUF".
	22	PRESIDING JUDGE: Madam Witness, counsel is asking you did
	23	you say this in the previous court case?
	24	THE WITNESS: I do not understand.
16:50:43	25	PRESIDING JUDGE: Put the question again, please, Mr Anyah.
	26	MR ANYAH:
	27	Q. Madam Witness, I just read you transcripts that suggest you
	28	told the RUF Bench that most of the members of the Red Lion
	29	Battalion were STF members. Did you hear what I read, Madam

	1	Wi tness?
	2	A. I've heard, but I did not say that.
	3	Q. Are you saying that what I have read does not accurately
	4	reflect what you told the Court in March 2006?
16:51:24	5	A. Yes, sir, I did not tell them that.
	6	Q. You said you heard about the Special Task Force in
	7	connection with did you say Makeni?
	8	A. Yes, sir, in Karina. That's where I heard, during the
	9	Karina attack.
16:51:49	10	Q. And in what context did you become familiar with that name?
	11	A. At the time that they were burning houses and killing
	12	people, that was the time that the other soldiers were saying,
	13	"SLA - NPFLA advance, advance". That was where I heard that.
	14	Q. I'm asking you about the Special Task Force, the STF. You
16:52:14	15	said you heard about them in Karina?
	16	A. Yes, sir.
	17	Q. What did you hear about the Special Task Force in Karina?
	18	A. They were just saying, "Advance, advance". That was what I
	19	heard.
16:52:31	20	Q. Was this when you were taken captive in Karina?
	21	A. Yes, sir.
	22	Q. Are you saying that some of the people who took you captive
	23	in Karina were STF members, Madam Witness?
	24	A. Well, that was what I heard them saying.
16:52:56	25	Q. When you say you heard them saying and you've repeatedly
	26	said they were calling, who was calling and saying "Special Task
	27	Force"?
	28	A. Just like you tell somebody - somebody was brandishing a
	29	gun and they say, "STF advance. Advance". That's how I heard

	1	them saying, the man, the man saying, the junta man, because he
	2	was wearing a combat.
	3	Q. So it was a fighter or junta man that was using the phrase
	4	"STF advance", yes?
16:53:37	5	A. Yes, he was wearing combat.
	6	Q. Besides that reference to STF in Karina when you were
	7	captured, did you ever hear any other reference to STF in Karina
	8	when you were captured?
	9	A. No, since then I did not hear any other thing about STF.
16:54:06	10	Q. The man you heard speak about the STF, did he have a
	11	Liberian accent?
	12	A. No, he was far away from me. He was not talking like a
	13	Liberian. He was just saying, "Advance. Advance".
	14	Q. It will be fair to say, Madam Witness, that none of the men
16:54:31	15	who captured you from Karina and took you all the way in the
	16	first instance to Colonel Eddie Town were Liberians, yes?
	17	A. They were junta.
	18	Q. Did you hear any of them speak Liberian English?
	19	A. Yes, sir.
16:54:56	20	Q. And they were part of the SLAs, right?
	21	A. They were in the SLA group. They were speaking Liberian,
	22	but that man was a real Liberian, the Killer.
	23	Q. So, Madam Witness, in all these groups you've mentioned,
	24	the SLAs and the 70 men that made up the Red Lion Battalion,
16:55:28	25	there were Liberians in these groups, right?
	26	A. Yes, sir.
	27	Q. You mentioned a number of people being sent to receive the
	28	70 men from - where did they receive the 70 men from, Madam
	29	Wi tness?

Α.

1 Α. At Gbendembu. 2 Q. Yes, and today you gave us five names that were sent you 3 said by Five-Five to go and receive these men, right? 4 Α. Yes, they were the leaders that were to go with the group. You said they were Jabbi, Olangba, Ogadiyai, Ibrahim and 16:56:15 5 0. Ahchebe, yes? 6 Yes, sir. 7 Α. When you spoke with the Prosecution four days ago, not even 8 Q. four days ago, two days ago on 5 May this year, you gave them 9 only the name of Jabbi, yes? 16:56:39 10 Yes, sir. 11 Α. 12 Q. And today you've given us five or four additional names in 13 court, yes? 14 Α. Yes, sir. 16:57:04 15 Besides the Red Lion group and besides the SLAs that you Q. were with, was there another group headed by somebody named Tito? 16 17 Α. Yes, sir. 18 When you testified in the RUF trial, the paragraph or the Q. 19 transcript I've just referred to, you mentioned three groups in 16:57:32 **20** that case, yes? 21 Α. Yes, sir. 22 You said one were SLAs, yes, headed by SAJ Musa? Q. 23 Α. Yes, sir. Yes, sir. 24 Q. Let me take that again, Madam Witness. You said one group 16:57:54 25 was headed by SAJ Musa and those were SLAs, yes? 26 Α. Yes, sir. 27 Q. You said that one group was the Red Lion group headed by 28 Med Bajehjeh, yes? 29 Yes, sir.

	1	Q. And you said there was a third group headed by Tito,
	2	correct?
	3	A. Yes, sir.
	4	Q. The group headed by Tito, were they SLAs, RUF or what,
16:58:28	5	Madam Witness?
	6	A. Tito was SLA. The group that he came with I do not know
	7	how they were mixed, but the one who led was a soldier.
	8	Q. So we have three groups now, yes?
	9	A. Yes, sir.
16:58:50	10	Q. But there's a fourth group which is the group that brought
	11	you from Karina to Colonel Eddie Town, isn't there, Madam
	12	Wi tness?
	13	A. Yes, sir.
	14	Q. That is different from the group that came with SAJ Musa,
16:59:10	15	yes?
	16	A. Yes, sir.
	17	Q. When you first spoke with the Prosecution the very first
	18	time, 18 January 2003, you told them that SAJ Musa came along
	19	with Tito. Do you remember that, Madam Witness?
16:59:35	20	A. No, sir.
	21	PRESIDING JUDGE: Mr Anyah, I'm unclear on this answer. Is
	22	the witness saying, "I don't remember", or, "No, I didn't say
	23	that".
	24	MR ANYAH: I can clarify, Madam President:
