

**PROSECUTION SUBMISSION REGARDING “ORDER ON PROSECUTION
MAP EXHIBITS” DATED 27 OCTOBER 2004**

1. In accordance with the “ORDER ON PROSECUTION MAP EXHIBITS” (“Order”) dated 27th October 2004, the Prosecution submits the attached maps highlighted to the specifications of the Order. Map 1 indicates all labeled locations referred to in the Consolidated Indictment. Maps 2-5 indicate all labeled locations referred to in the respective paragraphs of the indictment. A separate map is not submitted for Counts 6-7 as it refers to all locations in the Consolidated Indictment and would therefore be identical to map 1. An Index of the Maps is submitted at Annex A.
2. As these maps are submitted in compliance with the Order, highlighting the locations referred to in the Consolidated Indictment, it should be noted that the indictment is pleaded in an inclusive, rather than an exhaustive, fashion. Therefore, crimes occurred, and are charged, in locations within the Districts, other than those that are specifically identified in the Indictment.

3. It should further be noted that towns and other locations referred to in the Indictment often have multiple spellings and/or multiple names and are not always reflected on the map.
4. The Prosecution seeks to have these maps admitted into evidence as exhibits.
