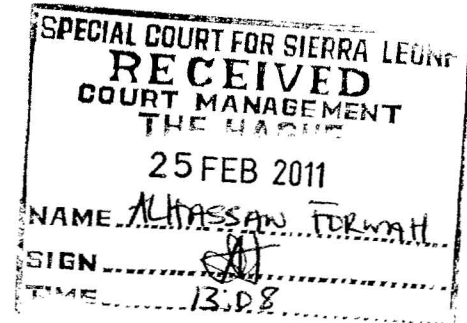

**URGENT PROSECUTION REQUEST TO SUPPLEMENT THE 'PUBLIC WITH CONFIDENTIAL ANNEXES A & B URGENT PROSECUTION MOTION FOR AN INVESTIGATION INTO CONTEMPT OF THE SPECIAL COURT FOR SIERRA LEONE'**

1. The Prosecution urgently requests leave of the Trial Chamber to supplement the “Public with Confidential Annexes A & B Urgent Prosecution Motion for an Investigation into Contempt of the Special Court for Sierra Leone.”<sup>1</sup> The information set out in **Confidential Annexes A** and **B** may be of assistance to the Chamber in assessing the 7 February Contempt Motion. Accordingly, the Prosecution requests the Trial Chamber to supplement the 7 February Contempt Motion with these signed and affirmed statements.
2. Considering the serious and on-going nature of the allegations in the 7 February Contempt Motion,<sup>2</sup> the Prosecution files this request urgently and requests an expedited filing schedule.
3. The Prosecution endeavored to bring the serious allegations contained in the 7 February Contempt Motion to the prompt attention of the Trial Chamber. Therefore, the Prosecution urgently filed the 7 February Contempt Motion based on investigative interview notes from a telephone interview with TF1-274. Only thereafter did Prosecution investigators have the opportunity to travel to TF1-274’s location and obtain signed and affirmed statements relating to the events set forth in the investigative interview notes.<sup>3</sup> Having received the signed and affirmed statements attached at **Confidential Annexes A** and **B** on 23 February, the Prosecution now promptly brings them to the attention of the Court.
4. Of note, in the statement at **Confidential Annex B**, TF1-274 explains that, on 10 February, Senesie identified Prince Taylor as the Defence team member TF1-274 spoke to on the telephone on 3 February.<sup>4</sup> This information was disclosed to TF1-274 three days after the 7 February Contempt Motion was filed and therefore, could not have been included therein.


